## Notes to Financial Statements

Years Ended December 31, 2024 and December 31, 2023

### NOTE A - DESCRIPTION OF PLAN

The following description of the Atomic Design, Inc. 401(k) Plan (the Plan) provides only general information. The Plan was originally established in 2008, and amended and restated thereafter. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility Requirements**

The Plan is a defined contribution plan covering substantially all full-time employees, excluding employees covered by a collective bargaining agreement, leased employees, non-resident aliens, and any employee paid through a third-party payroll service, of Atomic Design, Inc. (the Company) who have attained the age of 18 and completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

#### **Plan Amendment**

Effective January 1, 2024, the Plan was amended to permit in-plan Roth transfers for fully vested accounts and to not permit any in-plan Roth Rollovers.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are enrolled in the Plan unless they affirmatively elect a different deferral rate. The automatic deferral rate is set at 4% of eligible compensation for automatically enrolled participants, with subsequent increases of 1% annually, until the deferral percentage reaches 8% of eligible compensation.

Under current provisions of the Plan, the Company makes a non-elective qualified automatic contribution arrangement (QACA) safe harbor contribution of 3% of compensation. Non-elective QACA safe harbor contributions in the amount of \$341,194 and \$331,108 were made for the plan years ended December 31, 2024 and 2023, respectively. The non-elective QACA safe harbor contribution is invested as directed by the participant. The Company may make a discretionary matching and profit-sharing contribution to all qualifying participants, which the Company determines from year to year. The Company did not make any discretionary matching or profit sharing contributions to the Plan for the years ending December 31, 2024 or 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company's non-elective QACA safe harbor contributions, as well as allocations of the Company's discretionary matching or profit-sharing contribution, if applicable, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are fully vested after two years in the non-elective QACA safe harbor contributions plus actual earnings on the contributions. Vesting in the Company's discretionary matching and profit-sharing contributions portion of their accounts is based on years of continuous service following a six-year vesting schedule as follows:

<u>Years of Service</u>	
<i>Less Than Two Years</i> .....	0%
<i>Two Years</i> .....	20%
<i>Three Years</i> .....	40%
<i>Four Years</i> .....	60%
<i>Five Years</i> .....	80%
<i>Six Years</i> .....	100%

A participant becomes fully-vested upon attainment of normal retirement age, upon disability, upon death, or upon termination of the Plan.

#### Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rates are 1.5% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if their vested balance exceeded \$5,000. The portion of the participant's account to which they are not vested is a "forfeiture" and allocated to restore participants' forfeitures, if applicable, and the remaining is allocated as a reduction of future employer matching contributions or operational and administrative expenses.

In-service withdrawals of a participant's elective deferrals and vested employer contributions are permitted after the participant has obtained age 59½. Rollover contributions are available for in-service withdrawals at any time.

If the participant's vested account balance is less than \$5,000, the vested account balance is paid out in the form of a lump sum distribution upon their termination. Rollover portions of the account is excluded in determining the \$5,000 amount. In the event of a mandatory distribution greater than \$1,000, the Plan administrator will pay the distribution in the form of a direct rollover to an individual retirement arrangement account designated by the Plan administrator if the participant does not elect a direct rollover or lump sum distribution.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts are immaterial. These accounts will be used to restore participants' forfeitures, if applicable. Remaining forfeitures are then used to reduce the future employer contributions or operational and administrative expenses. Forfeitures of \$5,401 and \$5,249 were utilized to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$2,917 and \$-0- were utilized to reduce plan expenditures during the years ended December 31, 2024 and 2023, respectively.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting. Contributions from employees are recorded in the period in which the Company makes the authorized payroll deductions from Plan participants.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Use of Estimates**

The preparation of financial statements in accordance with the accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for a fully benefit-investment contract, which is reported at contract value as discussed above). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Employer Contributions**

Employer contributions to the Plan are recognized in the period for which the plan sponsor has made a formal commitment to fund such amounts for the period. Contributions receivables include legal or contractual requirements for the employer to make contributions applicable to past periods.

#### **Expenses**

Certain expenses incurred maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transactional fees and charges which are attributable to a specific participant's account are deducted directly from that account. Investment related expenses are included in net appreciation in fair value of investments.

#### Expenses (Continued)

The Plan received miscellaneous receipts, including but not limited to, payments from mutual funds, rebates of 12b-1 fees, service fees, sub-transfer agent fees, commission recaptures, and similar payments from third parties through an agreement with the trustees. Such amounts are used to offset Plan operating expenses. During 2024 and 2023, administrative maintenance charges paid from the miscellaneous receipts amounted to \$27,426 and \$22,601, respectively. These amounts are included in net appreciation in fair value investments and administrative expenses in the Statements of Changes in Net Assets Available for Benefits.

### NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets have a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### NOTE D - GROUP ANNUITY CONTRACT WITH GREAT-WEST LIFE AND ANNUITY INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life and Annuity Insurance Company (Great-West) totaling \$49,595 and \$56,268 as of December 31, 2024 and 2023, respectively. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the Plan was 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively. The actual crediting interest rates were approximately 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively.

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the Plan agreements without the consent of the issuer.

### **NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Administrative maintenance charges are paid to the trustees based on the closing market value of the investments in the Plan's trust. These fees amounted to \$52,152 and \$42,251 for the years ended December 31, 2024 and 2023, respectively. These are considered related party and party-in-interest transactions.

The Plan has issued loans to participants, which are secured by the participant's account balances. These are considered party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### NOTE G - TAX STATUS

The Plan is operating under an adoption agreement of the prototype defined contribution plan document prepared by PA Retirement Solutions, Inc. The IRS stated in an opinion letter dated June 30, 2020 that the prototype plan document was designed in accordance with the applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE I - INFORMATION CERTIFIED BY TRUSTEES

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company and Empower Trust Company, LLC, a qualified institution.

### NOTE J - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosure in these financial statements.
