Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of I.B.E.W. Local 405 Deferred Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of I.B.E.W. Local 405 Deferred Savings Plan as of December 31, 2024 and 2023 and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE 1 DESCRIPTION OF PLAN

The following brief description of I.B.E.W. Local 405 Deferred Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan was established as a result of a collective bargaining agreement between the Local Union #405, International Brotherhood of Electrical Workers, AFL-CIO, Iowa Chapter (the Local), National Electrical Contractors Association and Contributing Employers. The Plan also allows nonbargaining unit employees of contributing employers to participate. It is a defined contribution plan covering substantially all bargaining unit employees represented by the Local. The Board of Trustees is responsible for the oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees are immediately eligible to participate in the deferral and Employer contribution provisions of the Plan.

Participant Accounts

Each participant's account is credited with Employer contributions, the participant's contributions, and allocations of investment earnings and administrative expenses. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Upon becoming eligible to participate in the Plan, a participant may direct their contribution in any of the investment options offered by the Plan on a daily basis. Investment allocations may be changed at any time. Participant accounts are valued daily. Cash balances of \$1,132,509 and \$1,091,356 were unallocated at December 31, 2024 and 2023, respectively.

Contributions

Each month, participating employers contribute to the Plan, on behalf of their eligible employees, a fixed amount per hour of service, as determined under the collective bargaining agreements or participation agreements. The fixed amount per hour of service is based on various categories of participants, as defined in the collective bargaining agreements or participation agreements. Participants may make elective before-tax contributions on a per hour basis in \$0.50 increments with a maximum dollar limit of \$22,500 and \$23,000 for 2024 and 2023, respectively. Effective January 1, 2023, participants may elect to make an after-tax contributions (Roth 401k) on a per hour basis in \$0.50 increments. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions with a maximum dollar limit for 2024 and 2023 of \$7,500 and \$6,500, respectively. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Payment of Benefits

Upon retirement, termination, death, or disability, participants can make application to receive their benefits. Participants may take an in-service distribution upon attainment of age 59½. Participants may also take a distribution upon sustaining a hardship. The standard form of benefit payment under the Plan is a joint and survivor annuity. Participants can elect an alternative form of payment including a lump-sum distribution, partial distribution, or installment payments upon waiving the right to the joint and survivor annuity form of payment. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Vesting

Participants are immediately vested in employee and employer contributions plus actual earnings thereon.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions Received and Receivable

Employer contributions receivable at December 31, 2024 and 2023, are primarily amounts received in the first month of the following year from employers for work months through December. Employee 401(k) deferral contributions receivable at December 31, 2024 and 2023, are primarily amounts received in the first month of the following year from employers for employee withholdings through December. Delinquent contributions are individually analyzed for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, Employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was insignificant.

Contributions are subject to audit, and any delinquent accounts are subject to liquidated damages. At any point in time, certain accounts are receivable by the Plan due to audit results and may be subject to various disputes or legal actions. Such accounts receivable are recognized based on the ultimate collectability as determined by Plan management.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes both realized gains and losses from sales and unrealized market gains and losses.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 28, 2025, the date the financial statements were available to be issued.

NOTE 3 PLAN TERMINATION

Although they have not expressed an intent to do so, the Board of Trustees reserves the right to terminate the Plan in whole or in part. Upon termination of the Plan, participants' accounts will be 100% vested and contributions to the Plan will cease. Earnings (gains or losses) will continue to be credited and expenses charged to the participants' accounts until such time as all accounts have been paid.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash – Valued at cost, which approximates fair market value.

Pooled Separate Account – Valued based on the NAV of units, which is based on the value of the underlying assets, held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 RECIPROCITY AGREEMENTS

The Plan has entered into money follows the member reciprocity agreements with other retirement plans so that money will be transferred to a member's home plan.

For the years ended December 31, 2024 and 2023, the Plan remitted \$1,388,588 and \$707,651, respectively, of reciprocal cash payments in accordance with these agreements. For the years ended December 31, 2024 and 2023, the Plan received \$856,595 and \$822,554, respectively, of reciprocal cash payments in accordance with these agreements. Reciprocal payments received from other plans are included in the Employer contributions in the statement of changes in net assets available for benefits. No allowance for credit losses as of December 31, 2024 and 2023, was necessary for reciprocal payments due to the Plan. Payments made to other plans for reciprocal contributions collected on behalf of those plans are recorded as a reduction in the Employer contributions.

NOTE 6 INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated October 9, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the board of trustees believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of funds that are managed by Matrix Trust, who is the custodian of the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
