Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The 401(k) Plan of UCC Holdco, LLC (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of The 401(k) Plan of UCC Holdco, LLC (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible U.S. employees of UCC Holdco, LLC (the Company), United Conveyor Corporation LLC, and United Conveyor Supply Company LLC. To be eligible for all contributions, employees must complete 30 days of service and then are eligible to participate on the first of the following month and attain the age of 21. The Plan Administrator is responsible for the oversight of the Plan. The Plan's trustee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrator.

Contributions: Each year, participants may contribute up to the maximum dollar limit of pretax annual compensation, as defined in the Plan, as allowed by the Internal Revenue Service (IRS) starting on the first day of the calendar month immediately following the participant's date of hire. Participants are automatically enrolled to have a pretax deduction equal to 6% of eligible compensation unless they elect to enroll at a different deferral rate or elect not to enroll in the Plan. All automatically enrolled participants have the option to increase, decrease, or eliminate their automatic enrollment contribution prior to it becoming effective. Participants with a deferral rate greater than zero will have that deferral increased annually by 1% until a deferral rate of 15% is reached. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants may also contribute in the form of Roth contributions.

Participating employees of UCC Holdco, LLC, United Conveyor Corporation LLC, or United Conveyor Supply Company LLC, will receive matching contributions equal to 100% of the participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the next 2% of the participant's compensation (for a maximum matching contribution of 4%).

The Company may also make discretionary profit sharing contributions to the Plan as approved by the Company's Board of Directors for eligible participating employees of United Conveyor Corporation LLC, and United Conveyor Supply Company LLC, who have completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. All eligible participants receive an allocation of the profit sharing contribution based on a percentage of participants' eligible compensation during the Plan year. The Company made a discretionary profit sharing contribution equal to 7% of participants' eligible compensation for the year ended December 31, 2024, totaling \$1,919,461. This discretionary profit sharing contribution is included in Company receivables on the statement of net assets available for benefits.

Note 1. Description of the Plan (Continued)

Investment options: Upon enrollment in the Plan, participants may direct all contributions into a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Participant accounts: Under the Plan, separate accounts are maintained to reflect the interests of each participant. Each participant's account is credited with the participant's contribution and Company matching contributions, and allocations of the Company's discretionary profit sharing contributions, forfeitures and investment earnings. Each participant's account is also charged with an allocation of administrative expenses. Allocations are based on participant earnings, Plan account balances, or specific participant contributions, as defined.

Terminated or retired participants with undistributed benefits remaining as part of the Plan's assets continue to earn pro rata allocation of investment income.

Vesting: Participants are immediately vested in their contributions and the Company's matching contributions, plus actual earnings thereon. Participants become 100% vested in their discretionary profit sharing allocations after two years of service.

Notes receivable from participants: The Plan allows each participant to borrow a minimum amount of \$1,000 and a maximum amount not to exceed the lesser of one-half of the participant's vested account balance or \$50,000. The loan term may not exceed five years unless it is for the purchase of a principal residence, in which case the term will be within a reasonable amount of time, not to exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates for the Plan year as of December 31, 2024, ranged from 3.25% to 8.5%. Loans are repaid ratably through weekly or semimonthly payroll deductions.

Payment of benefits: On termination of service due to death, permanent disability, retirement or separation from service, a participant may elect to receive their vested balance in a lump-sum amount or in the form of equal installments over a period of time not exceeding the participant's life expectancy or the joint life expectancy of the participant and their beneficiary.

Administrative costs: Administrative expenses of the Plan are paid by both the Company and the Plan.

Forfeited accounts: At the Company's discretion, forfeited balances may be used to pay administrative expenses or to reduce the employer's contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$387 and \$13,127, respectively. Forfeitures of \$92,701 were used to reduce Company matching contributions during the year ended December 31, 2024.

Note 2. Summary of Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

Valuation of investments and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies using information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule of assets (held at end of year).

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Payment of benefits: Benefit payments are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through September 30, 2025, the date the financial statements were available to be issued.

Note 3. Summary of Investment Information Certified by Fidelity Management Trust Company, the Trustee

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that were prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodologies include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Shares of common/collective trust: Investments are valued using the NAV provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of a common/collective trust fund and of mutual funds managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for management services totaled \$113,519 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services to the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Note 6. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

Note 7. Tax Status

The Plan, as adopted, is a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management & Research Co. that has been adopted by the Sponsor. The pre-approved plan provider obtained its latest opinion letter on June 30, 2020, by which the IRS has determined and informed the Sponsor that the Plan, as then designed, was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset), or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
