### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Bessemer Management Company 401(k) Plan, ("Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### Bessemer Management Company 401(k) Plan

#### 1 Description of Plan

The following description of the Bessemer Management Company 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan includes the following related companies collectively known as the "Employer": The Kaplan Trucking Company, Horizon Freight System, Inc., Eastern Express, Inc., TRX, Inc., and DD&S Express, Inc. Effective January 1, 2025, Bessemer Management Company was added as a participating employer.

The Plan, which began January 1, 1988, is a defined contribution plan. The Plan covers all employees, except nonresident aliens, leased and union employees who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### ***Eligibility:***

All employees of the Employer age twenty and a half and older and who are employed for three months and work 1,000 hours in the year are eligible to participate in the Plan, except for illegal aliens, leased and union employees.

##### ***Contributions:***

Cash or Deferred Option [401(k)] - Participants may elect a portion of their compensation to be contributed to the Plan by the Employer. Newly eligible participants are automatically enrolled in the Plan with a deferral percentage of 3% unless otherwise elected. Participants may change the deferral percentage at any time.

Employer Contributions - The Employer makes contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the Plan year. Effective January 1, 2020, the Plan was amended and restated to become a Safe Harbor Plan and the Company match was set to 100% of employee contributions up to 3%, and 50% of employee contributions over 3% and up to 6%. The Company may also make additional discretionary match contributions up to 6%. No such discretionary contributions were made in 2024 or 2023.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

##### ***Participants' Accounts:***

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer contributions, earnings and losses thereon.

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

**1 Description of Plan, Continued**

***Vesting:***

All participants are 100% vested in elective deferrals, Employer safe harbor contributions, and rollover contributions made to the Plan. Participants are vested in Employer matching (prior to January 1, 2020) and discretionary contributions based on years of service. A participant is vested as follows:

<u>Years of Service</u>	<u>Vested %</u>
1	50%
2	80%
3	100%

***Forfeitures:***

Forfeited non-vested accounts totaled \$3,758 and \$3,467 as of December 31, 2024 and 2023 respectively. Forfeitures can be used to:

- Offset Plan expenses;
- Reduce Employer matching contributions;
- Reduce Employer discretionary contributions; and
- Allocated to participants as discretionary contributions.

Forfeitures of \$208 (2024) and \$537 (2023) were used to offset Plan expenses.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants are allowed to have up to 2 loans outstanding. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Other Plan Provisions:***

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

***Payment of Benefits:***

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may elect to receive a lump sum amount equal to the value of his or her account, or annual installment payments. Benefit payments to participants are recorded upon distribution.

## NOTES TO FINANCIAL STATEMENTS

### Bessemer Management Company 401(k) Plan

#### **1 Description of Plan, Continued**

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct his or her contributions in any of the investment options offered by the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Mutual funds are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Investments held in common collective trusts are valued based on their underlying investments using a variety of methodologies including pricing services, dealer quotes, and net asset per share calculated on a specific valuation date. Participants can transact with the common collective trusts daily and there are no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased, sold, and held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Plan expenses are fees for services that are provided on a regular basis, such as recordkeeping and general plan administration. Reasonable administration expenses may be paid out of the Plan, unless paid by the Plan sponsor.

## NOTES TO FINANCIAL STATEMENTS

## 2 Summary of Significant Accounting Policies, Continued

### *Plan Termination:*

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances at the time of termination.

### *Risks and Uncertainties:*

The Plan's investment options include investments in mutual funds and a common collective trust holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 27, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan. On June 30, 2020, the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### ***Mutual Funds:***

The fair values of the mutual funds are based on the daily closing price reported by the fund. These funds are required to publish their daily net asset values and to transact at that price. The mutual funds are deemed to be actively quoted and are classified in the Level 1 category of the valuation hierarchy.

##### ***Common Collective Trust:***

The fair value of the common collective trust is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on quoted market prices or commercial quotation services. The common collective trust is classified in the Level 2 category of the valuation hierarchy.

Participant transactions (purchases and sales) may occur daily. Withdrawals by participants for purposes of benefit payments or transfer to a noncompeting option are processed within 30 days of receipt of written notification.

Transactions other than those initiated by a participant for specific purposes of a sale, purchase, transfer or benefit payment require 12 months advanced written notice.
