## INDEPENDENT AUDITOR'S REPORT

To the Trustees, Administrators and Participants of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Radiology Consultants of Iowa, PLC 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of Radiology Consultants of Iowa, PLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

1. Description of the plan

The following brief description of the Radiology Consultants of Iowa, PLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

The Plan is a defined contribution 401(k) plan covering all eligible employees of Radiology Consultants of Iowa, PLC (the “Company” or “Plan Sponsor”). Employees are eligible to participate in elective salary deferrals and employer matching contributions when they have completed at least three months of service and are at least twenty-one years of age. Employees become participants on the first day of the month immediately following meeting the age and service requirements. The Plan allows participants to designate all or a portion of their elective deferrals as Roth elective deferrals. Roth elective deferrals are accounted for separately in the respective participant’s account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan is funded by contributions from participants in amounts up to 100% of eligible compensation, limited to the maximum amount deductible under the Internal Revenue Code. Participants are automatically enrolled with a 3% deferral rate on the first day of the month immediately following meeting the age and service requirements, if no election is made by the participant. The deferral rate for those automatically enrolled increases 1% each January 1<sup>st</sup> thereafter until the maximum automatic deferral rate of 6% is reached. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also provides for an employer matching contribution equal to 50% of the employee’s deferral, limited to 3% of eligible compensation. Also, participants who have completed two years of service, are twenty-one years of age or older and have worked at least 1,000 hours during the Plan year are eligible to receive profit sharing contributions. The profit sharing contributions are made at the discretion of the Company’s Board of Directors, limited to the maximum amount deductible under the Internal Revenue Code. During 2024 and 2023, the Company made discretionary profit sharing contributions to the Plan of \$1,268,797 and \$1,282,826, respectively.

Participant accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution on salary deferrals, an allocation of the Company’s discretionary profit sharing contribution, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant’s compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the plan, continued

Vesting

Participants are immediately vested in their contributions and the Company's contributions, plus actual earnings thereon.

Investment options

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan or self-directed investment options through a self-directed brokerage account. Participants may change their investment options at their discretion and changes become effective on the next business day. Additional investment options are periodically added to the Plan to provide more diversification for participants.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, unless used to purchase a personal residence. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon retirement, death, disability or termination of service, participants receive an amount equal to the value of their vested benefit. The Plan provides for lump-sum payments or installment payments over a period not to exceed the life expectancy of the participant or beneficiary. If no benefit payment election form is completed, participants receive automatic lump-sum distributions for accounts with a value of \$1,000 or less. In addition, participants automatically have balances rolled into an individual retirement account at Principal for accounts with balances between \$1,000 and \$7,000, if no election form is completed. Distributions of balances greater than \$7,000 are made at the election of the participants. Prior to December 31, 2023, the account balance that was automatically rolled into an individual retirement account was limited to \$5,000.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

## 2. Summary of significant accounting policies, continued

### Investment valuation and income recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Concentration of investment risk

As of December 31, 2024 and 2023, approximately 53% and 55% of the Plan's investments were held in one mutual fund family.

### Notes receivable from participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### Payment of benefits

Benefits are recorded when paid.

### Income tax status

The Plan is a nonstandardized prototype plan. The Internal Revenue Service ("IRS") has determined and informed Principal Life Insurance Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been restated and amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Subsequent events

Plan management has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

3. Information prepared and certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”), party-in-interest

Certain assets of the Plan were held by Principal, a party-in-interest discussed at Note 7, as of December 31, 2024 and 2023. Certain transactions during the years ended December 31, 2024 and 2023 were executed under formal custody agreements between the Plan and Principal. Certain securities bought, sold, or exchanged were executed under these agreements. Such financial information has not been audited by independent auditors.

In accordance with the provisions of Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, Principal has certified the following unaudited financial information to be complete and accurate with respect to certain Plan assets held by them as of December 31, 2024 and 2023, respectively, and certain activity for the years then ended, respectively:

#### 4. Risks and uncertainties

The Plan invests in various investment securities, which in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

## 5. Fair value measurements, continued

Collective investment trusts: Valued at the net asset value (“NAV”) of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust, up to 12 months or longer, in order to ensure that securities liquidations will be carried out in an orderly business manner. The trust does not have a finite life, the Plan has no unfunded commitments, and there are no participant redemption restrictions.

Mutual funds and exchange traded funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: These accounts include various assets self-directed by participants and include the following assets in addition to mutual funds and exchange traded funds:

Cash and money market funds: Valued at cost, which approximates fair value.

Equity securities: Valued at the closing price reported on the active market on which the individual securities are traded. When prices on the active market are not available, securities are valued utilizing the American deposit receipt (“ADR”) evaluation model which utilizes the underlying best price for the security, exchange rate for underlying security’s currency against the U.S. Dollar and ratio of the underlying security to ADR.

Debt securities: Valued based on market prices and market data available for securities with similar characteristics since active markets are not common for many debt securities.

Participant life insurance policy: Valued at cash value as determined by the insurance carrier.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s policy is to recognize transfers between Levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels.

6. Administrative expenses

Administrative expenses for the maintenance of investments, contributions and distributions records, and the processing of related transactions are paid to Principal, party-in-interest. Loan processing fees, distribution fees, and certain processing fees are charged directly to the respective participant’s account when incurred and are included in administrative expenses. Fees paid to Principal during 2024 and 2023 were \$12,323 and \$9,380, respectively. Additional administrative expenses totaling \$57,153 and \$59,411 were paid to various registered broker-dealers (Wells Fargo Clearing Services, LLC, TD Ameritrade Clearing, Inc., and Charles Schwab & Co., Inc.), parties-in-interest, related to participants’ self-directed accounts during 2024 and 2023. Other administrative expenses, including audit fees paid to BGHN Associates, P.C., a party-in-interest, are paid by the Plan Sponsor and, therefore, excluded from these financial statements.

7. Related party and party-in-interest transactions

The Company had an agreement with Principal to provide record-keeping, administrative, custodial, and transaction processing services for certain Plan investments. In addition, various registered broker-dealers provide custodial services related to participants’ self-directed accounts. Other party-in-interest transactions are described in Notes 3 and 6.
