INDEPENDENT AUDITORS' REPORT ON REQUIRED COMMUNICATIONS

To the Plan Administrator
Missouri Walnut, LLC 401(k) Plan

We have audited the financial statements of Missouri Walnut, LLC 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) for the year ended December 31, 2024, and we have issued our report thereon dated September 9, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets for investment of the plan ("investment information") held by Principal Life Insurance Company, the investment agent that holds custody of plan investment assets, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplementary information, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of generally accepted accounting principles ("GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under GAAP, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated December 30, 2024. We performed the audit according to the planned scope and timing previously communicated to you. Professional standards also require that we communicate to you the following information related to our audit.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the plan, an employee benefit plan subject to ERISA as of and for the year ended December 31, 2024, in accordance with GAAP, we considered the plan's internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any investment information held by the investment agent that prepared and certified the investment information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies, and, therefore, material weaknesses or significant deficiencies may exist that were not identified. In addition, because of the inherent limitations in internal control, including the possibility of management override of controls, misstatements due to error or fraud may occur and not be detected by such controls. However, as discussed below, we identified a deficiency in internal control that we consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiency in plan's internal control to be a significant deficiency:

- As noted in the other matters for your consideration section below, there were numerous participant testing discrepancies identified during the audit work that could require corrective actions that may not have been identified outside of the scope of the audit. Additionally, there were numerous other issues identified throughout the administration of the 401(k) plan. We believe if key monitoring functions were in place, these identified errors would be minimized and/or mitigated.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the plan are described in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. We noted no transactions entered into by the plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the plan's financial statements. After the third party administrator posted any suggested edits we had to the draft Form 5500, we identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no corrected or uncorrected misstatements identified during the audit.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated September 9, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the plan's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplementary information accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplementary information, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplementary information related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Matters for Your Consideration

- As part of our audit, we select a sample of participants to perform various testing procedures (confirm certain demographic information, verify deferral percentages, recalculate employee and employer contributions, etc.) During this work we noted the following:
 - Ryan Farris should have been automatically enrolled in December 2024 but improperly was not enrolled until 2025. Jacob Gonzales should have been automatically enrolled in August 2024 but improperly was not. We recommend working with Principal to determine if any corrective actions are necessary to make these participants whole for their missed opportunity for both employee and employer contributions. Additionally, we recommend putting controls in place to ensure participants are automatically enrolled in the plan timely. Finally, we recommend plan management complete a full analysis to determine if there are any other impacted employees that would also need corrective actions.
 - Bonnie Clevenger properly did not have 401(k) deferrals on her April 26th and May 24th paychecks as they related to severance pay, but did have 401(k) deferrals withheld on the May 10th paycheck, which was also severance pay. We recommend putting controls in place to ensure all ineligible compensation properly does not have 401(k) deferrals withheld.
 - Jonathon Hornbaker improperly had 401(k) deferrals withheld on the May 10th paycheck which related to severance pay, which is ineligible compensation for 401(k) deferrals. We recommend putting controls in place to ensure all ineligible compensation properly does not have 401(k) deferrals withheld.
 - Yun Wang had bonus compensation on his October 20th paycheck which did not have 401(k) deferrals withheld. Plan management advised us that Yun Wang opted out of 401(k) deferrals for the bonus pay, but could not provide support substantiating that. We recommend maintaining documentation for any eligible pay that does not have deferrals in alignment with the participants deferral election.

- During our work we noted that your plan defines eligible wages subject to employee elective deferrals as all W-2 compensation with the exception of reimbursements, other allowance, fringe benefits and moving expenses. During 2024, the company deferred on cell phone reimbursements. We recommend working with Paycom to correct the classification of this pay code so that it is excluded from eligible compensation going forward. Also, we would recommend putting checks and balances in place to ensure the compensation that is being deferred upon is in line with the plan document.
- Throughout 2024, it appears 401(k) withholdings were generally remitted within several days of the related payroll run, with the exception of The Bridge's May 24, 2024, and August 2, 2024, pay dates. 401(k) withholdings for these payrolls were not remitted until 14 to 17 days after the related payroll date. The DOL has emphasized that employers must remit 401(k) withholdings from employees' paychecks as soon as administratively possible. Failure to remit 401(k) contributions in what the DOL would consider a timely manner could result in penalties to you as the plan sponsor. The DOL no longer recognizes a safe harbor and instead requires depositing these withholdings as soon as practicable. The DOL could consider these remittances to be late contributions.
- We were not able to vouch Jonathon Hornbaker's current address. Applicable personnel information (such as address, date of birth, date of hire, date of termination, if applicable) should be maintained by the plan sponsor as long as employees remain a participant in the plan.
- It is our understanding that the plan did not have fidelity bond coverage for the 2024 plan year. The plan is required to have a fidelity bond that is the lesser of \$500,000 or 10% of net assets.
- Currently, Tim Mohs is listed as the trustee in the plan documents. We recommend working with Principal to get the plan documents amended to reflect who the current trustee should be.
- During our work we noted that distributions can be initiated and approved online. It is our understanding that if they are initiated and approved online, there is documentation of the approval, but it does not specify who approved the transaction. We recommend establishing procedures so that documentation is maintained in personnel files supporting participant loans and distributions were properly approved and by whom.
- The IRS continues to increase the amount of responsibility it places on fiduciaries and plan sponsors to ensure that benefit plans are operating in accordance with laws and regulations and that participants are protected. For example, plan sponsors are required to take steps to ensure that fees being charged to the plan are reasonable and not excessive (benchmarking, etc.). The plan sponsor must document the procedures performed to fulfill this fiduciary responsibility.

It is our understanding that the plan management meets at least annually to discuss the reasonableness of plan fees, soundness of investments, re-affirm/select plan providers/advisors, determine investment strategies, approve plan amendments, etc. However, minutes summarizing these meetings are currently not being maintained.

We recommend maintaining formal minutes to document the discussions and related decisions made during the plan's advisory committee minutes.

- During our work we noted that Missouri Walnut Log Trading, LLC and Pennsylvania Cherry, LLC are participating employers in the plan. It appears through review of the plan documents that these participating employers are not specifically identified in the plan documents. We recommend working with Principal to amend the plan to specifically note these.
- Payroll changes are currently reviewed by a person who also has access to make changes to employee information in the payroll system. We recommend that a member of management, who does not have access to the payroll system, review payroll changes on a regular basis to ensure all changes were authorized and made correctly.
