### Note 1 - Plan Description

The following description of Alchemer 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering employees of Alchemer LLC (the "Company"). Nonresident aliens and union employees are not eligible to participate in the Plan. An employee is eligible to become a participant in the Plan if he or she is 18 years of age or older. Employees meeting such requirements may enter the Plan on the first day of the pay period in which such requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company is the sponsor of the Plan. Certain officers serve as trustees of the Plan.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 75 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute up to 75 percent of their annual eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Catch-up contributions are allowable by the Plan.

The Plan provides for employer safe harbor matching contributions of 100 percent of the participant's contribution, not to exceed 6 percent of the employee's deferred compensation. Catch-up contributions are eligible for this match. For the year ended December 31, 2024, the Company made safe harbor matching contributions of \$1,295,830.

Alchemer LLC may make discretionary profit-sharing contributions to the Plan. If a participant is employed on the last day of the plan year, there are no service requirement conditions that must be met. In order to share in the allocation of the contribution if not employed on the last day of the year, participants must have completed 500 hours of service in the plan year. The last-day rule is waived if the participant terminates employment due to death, disability, or termination on or after attaining normal retirement age. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants' contributions, the employer match contribution, and the employer discretionary profit-sharing contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

**Note 1 - Plan Description (Continued)**

The Plan allows in-service distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. Furthermore, the Plan allows for all terminated participant vested account balances to be automatically distributed as soon as administratively feasible. All balances are to be distributed in a lump sum within a reasonable period following the date the participant terminates employment. Partial withdrawals or installments are permitted only for participants or beneficiaries who must receive required minimum distributions under Internal Revenue Code Section 401(a)(9). The Internal Revenue Service (IRS) has required minimum distributions once a participant reaches age 70½ during the previous plan year and is no longer employed by the Company.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Capital Bank and Trust Company or its affiliates. Capital Bank and Trust Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA.

***Participant Notes Receivable***

Effective February 21, 2025, the Plan allows for participant loans. Participants may have up to two loans outstanding at any time. Loans must be at least \$1,000 and may not exceed 50 percent of the participant's vested account balance. The interest rate applied to participant loans is the prime rate.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value.

All investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

Effective February 21, 2025, the Plan was amended to allow for participant loans, as further described in Note 1.

The financial statements and related disclosures include evaluation of events up through and including September 24, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Capital Bank and Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 4 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
