Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Beck Auto Sales, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Beck Auto Sales, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a profit sharing plan covering all employees of Beck Auto Sales, Inc. (the “Company” or “Employer”). The Plan was formed and adopted on January 1, 2008 and most recently amended effective January 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees become eligible to participate in the Plan immediately upon completion of one month of service, and are automatically enrolled in the Plan deferring 3% unless they make a written election to opt-out. Employees enter the Plan on the first day of the quarter coinciding with or following the date eligibility requirements are satisfied. Employees that are not eligible to participate in the Plan are non-resident aliens who do not receive any compensation from U.S. sources and union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining.

Contributions

Participants may contribute up to the maximum allowed by law imposed by the Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for December 31, 2024 and 2023 was \$23,000 and \$22,500, respectively. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified plans. Contributions received from participants are net of excess deferral contributions refunded, as required to satisfy the relevant nondiscrimination provisions of the Plan. Participants also have the option to make Roth contributions.

Each year, the Company has the option to make profit sharing contributions at their discretion. Participants must be employed on the last day of the year and have completed at least 1,000 hours of service to receive a profit sharing contribution except in the year a disability or death occurred. For the year ended December 31, 2024, the Company elected not to make a profit sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor’s contribution, (b) Plan earnings, and charged with an allocation of administrative expenses not otherwise paid by the Plan. Income allocations are made on a daily basis based on fund performance. Participant accounts are reduced by the number of withdrawals made by the participant during the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Participants may receive an amount equal to the value of their vested interest upon termination of employment, death, disability or retirement. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest as a lump sum distribution.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Vesting Percentage

Participants are immediately vested in their contributions plus actual earnings, thereon. Vesting in the Company’s matching portion of their accounts plus actual earnings thereon is based on years of continuous service, as described below:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant’s account. Loans must bear a reasonable rate of interest, not to exceed the legal limit. The interest rate is determined by the certifying entity and is reevaluated every quarter. As of December 31, 2024 the interest rate of notes receivable from participants ranged from 4.25% to 9.50%. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. The notes receivable balance at December 31, 2024 and 2023 was \$254,048 and \$206,882, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant’s account will become fully vested and non-forfeitable. If the Plan is terminated, the participant will be required to take their entire account balance from the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions into various investments and investment contracts offered by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan carries investments at their fair value. The difference between the fair value and the carrying value of investments is included as appreciation or depreciation in the statement of changes in net assets available for benefits. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses and commissions of the Plan are paid by the Employer. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Risk and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and statement of changes in net assets available for plan benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE CERTIFYING ENTITY

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the certifying entity of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related net appreciation in the value of investments reflected in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments are shares of mutual funds and investment contracts managed by John Hancock, the certifying entity of the Plan. Therefore, these transactions qualify as party-in-interest.

Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

NOTE 5 – TAX STATUS

The underlying standardized prototype plan has received an opinion letter from the IRS dated March 31, 2014 stating that the written form of the underlying prototype document is qualified under Section 401(a) of IRC, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan's Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

NOTE 6 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management's own assumptions in determining the fair value of investments).

Pooled separate accounts: Valued at the net asset value ("NAV") provided by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

Self-directed brokerage accounts: Privately-held common stock valued based on marketable minority interest basis as determined by independent appraiser (Level 3 inputs). The fair market value analysis is developed primarily on the basis of the market approach. The market approach utilizes a comparison of the Company with comparable publicly traded companies or acquisitions of comparable companies. The value has been discounted for marketability and control.
