## INDEPENDENT AUDITOR'S REPORT

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Abbott-Action, Inc. 401(K) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan established effective April 1, 1987. The Plan covers all employees of Abbott-Action, Inc. (the Company) who have completed 6 months and are age 21 or older. Full-time employees of the Company who have completed 1,000 hours during the Plan year and are age 21 or older are eligible to receive employer contributions, as defined. The Plan requires a participant to be employed as of year-end to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan’s investment advisor determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Plan Administrator.

*Contributions* - Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100 percent of the first \$2,000 of base compensation that a participant contributes to the Plan. For the year ended December 31, 2024, there were no profit-sharing contributions to the Plan. Additional discretionary amounts may be contributed by the Company at the option of the Plan Administrator. For the year ended December 31, 2024, the Company approved a \$182,741 discretionary contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at five percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

*Participant Accounts* - Each participant’s account is credited with the participant’s contributions, allocations of the Company’s discretionary contributions and an allocation of the Plan’s earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service.

A participant is 0 percent vested after 1 year of credited service and continues to vest in increments of 20 percent until 100 percent vested after 6 years of credited service.

*Payment of Benefits* - On termination of service due to death, disability, or retirement, a participant may elect to receive either lump sum amounts equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

*Forfeited Accounts* - On December 31, 2024, and 2023, Plan forfeited nonvested accounts totaled \$52,097 and \$54,327, respectively, remaining in forfeited non-vested balance. During 2024 and 2023, employer contributions were reduced by \$23,092 and \$33,324, respectively from forfeited non-vested accounts, in accordance with plan provisions.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The methods used to value investments are as follows:

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. These prices represent the net asset value (NAV) of shares held by the Plan at year-end. Mutual funds are classified as Level 1 in the fair value hierarchy.
- **Collective Investment Trusts (CITs)** – Valued at the NAV per unit as determined by the trustee of the trust. NAV is based on the fair value of the underlying assets of the trust, less its liabilities, divided by the outstanding units at year-end. NAV is used as a practical expedient to estimate fair value, and accordingly, these investments are not classified within the fair value hierarchy.
- **Guaranteed Investment Contracts (GICs) / Stable Value Fund** – The Plan invests in the Key Guaranteed Portfolio Fund (KGPF), a fully benefit-responsive general account investment contract. The KGPF is reported at contract value, which represents contributions plus credited earnings, less participant withdrawals and administrative expenses. The fair value of the

contract is determined by using discounted cash flow models with observable market inputs (such as yield curves and credit spreads) and is disclosed in the notes as a Level 2 investment. Contract value is the relevant measurement attribute for the Statement of Net Assets Available for Benefits, as it represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Investment Income Recognition* - Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date, and interest income is recorded on the accrual basis. Realized gains and losses on security transactions are recorded as the difference between the proceeds received and the cost of the investments, using the specific identification method.

*Excess Contributions Payable* - Amounts payable to participants for contributions more than amounts allowed by the IRS are recorded as a liability with a corresponding increase to benefit payments. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

*Revenue Recognition* - On January 1, 2021, the Plan adopted the accounting guidance under Accounting Standards Codification Topic 606 (ASC 606), *Revenue from Contracts with Customers*. ASC 606 outlines a single comprehensive model for entities to utilize for revenues. The guidance is based on the principle that an entity should recognize revenue to depict the transfer of goods or services to customers in amounts that reflect the consideration to which the entity expects to be entitled in exchange for such goods or services. The Plan elected to adopt this guidance using the modified retrospective transition method. No adjustments to net assets were required as of January 1, 2019, as there was no impact to previously reported revenue or expenses associated with adopting ASC 606.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

*Subsequent events* - The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

*Reclassifications* - Certain amounts have been reclassified in the 2023 financial statements to conform to the 2024 presentation with no impact to net assets available for benefits.

**NOTE C – FAIR VALUE MEASUREMENT**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the custodians as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodian to the information included in the Plan's financial statements and supplemental schedule. Investments held and certified by the custodian in the accompanying statements of net assets available for benefits totaling \$13,445,527 and \$12,081,663 as of December 31, 2024, and 2023, respectively.

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in the active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair values measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used on December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the SEC. These funds are

required to publish their daily net asset value and are required to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

*Guaranteed investment contract:* Valued at fair value by the Company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see Note D). Since the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contracts terms (for example, minimum crediting rate, duration or payout date) while others are substantiated utilizing available market data (for example, discount rate).

*Common Collective Trust (CCT):* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D – GROUP ANNUITY CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company (Empower) totaling \$529,115 for 2024 and \$503,600 for 2023. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The traditional investment contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The guaranteed investment contract cannot be terminated prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.

3. A material misrepresentation; or,
4. A material amendment to the agreement without the consent of the issuer.

**NOTE E – EXCESS CONTRIBUTIONS**

Excess participant contributions totaling \$20,821 were returned to certain active participants prior to March 15, 2025, for the 2024 plan year. Accordingly, benefit payments increased by \$20,821. In addition, the Statement of Net Assets Available for Benefits as of December 31, 2024, includes an accrued liability of \$20,821.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE G – TAX STATUS**

The Plan adopted a pre-approved plan offered by Abbott-Action, Inc. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to informational return examinations for years prior to 2021.

**NOTE H – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan utilizes a third-party custodian and record keeper, Empower Trust Company, LLC and Empower Annuity Insurance Company. Certain plan investments are shares of mutual funds and a guaranteed investment contract (GIC) managed by Empower; therefore, these transactions qualify as party-in-interest transactions. The Plan Sponsor also provides

administrative services to the Plan at no cost while also paying certain Plan expenses in the amount of \$16,440 and \$18,780 during the 2024 and 2023 plan year, respectively. All these party-in-interest transactions are exempt from the prohibited transaction rules.

**NOTE I – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

*Concentration of Credit Risk*

The Plan's investments are exposed to various risks, including interest rate, market, and credit risk. Investment securities, in general, are exposed to credit risk due to possible default of the issuer. Securities of a single issuer that represents 10 percent or more of the Plan's net assets available for benefits are required to be disclosed.

**NOTE K – INVESTMENT EXPENSES**

The Plan’s investment expenses are calculated for each fund based on the Asset Management Charge (AMC). The charges to each fund are not shown separately in the financial statements but rather are netted against the net appreciation of each individual fund and are disclosed to the participants on their individual statements.

**NOTE L – REVENUE SHARING**

Certain funds within the investment line-up, whose expense fee ratios provide for revenue sharing arrangements, provide for those participants that selected those investments, to be credited for their proportional share thereby lowering plan fees/expenses. During 2024 and 2023, the revenue sharing amounts were \$29,436 and \$26,830, respectively.

**NOTE M – COVID RESPONSE**

In December 2019, an outbreak of a novel strain of coronavirus (COVID-19) originated in Wuhan, China and has since spread to other countries, including the United States of America. On March 11, 2020, the World Health Organization characterized COVID-19 as a pandemic. The COVID-19 outbreak in the United States of America has caused significant business disruption through mandated and voluntary closings of businesses and organizations across the country for non-essential services. While the disruption is expected to be temporary, there is considerable uncertainty about the duration of the disruption and business closings at the time of publication of these financial statements.

On May 11, 2023, the United Nations World Health Organization declared an end to COVID-19 as a public health emergency, stressing that it does not mean that the disease is no longer a global threat.

Any future financial impact on the Plan cannot be reasonably estimated at this time.

**NOTE N – SUBSEQUENT EVENTS**

Delinquent Participant Contributions

Subsequent to the Plan year ending December 31, 2024, the Plan Sponsor remitted certain participant contributions withheld from employee payrolls in April 2025 later than the time frame required by Department of Labor (DOL) regulations. The Plan Sponsor corrected the late remittance, including the calculation and deposit of lost earnings, if any, in accordance with the DOL's Voluntary Fiduciary Correction Program.

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued and determined that no other events or transactions occurred that would require adjustment to or disclosure in the financial statements.
