Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, as listed in the table of contents as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE A - DESCRIPTION OF PLAN

The following description of the Elyria/Hodge Foundry Company 401(k) Savings & Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Elyria Foundry Company, LLC (the Company, Plan Sponsor, and Plan Administrator) and all employees of Hodge Foundry, Inc. who have completed six months of service and are not covered by a collective bargaining agreement, part time, temporary, or seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Change in Service Provider

On June 28, 2024, the Plan changed the trustee from Reliance Trust Company to Transamerica Trust Company.

Contributions

Participants may elect to defer not less than 1% and not more than 75% of their eligible compensation as defined by the Plan on either a pre-tax basis or after-tax basis. Employees who have not declined participation in the Plan or completed a salary deferral agreement as of the date of their eligibility to participate in the Plan will be automatically enrolled in the Plan with a pre-tax deferral of 3% invested in a designated fund until changed by the participant. The Plan provides for a safe harbor matching contribution for each participant, which was 100% of the first 3% of annual compensation (as defined by the Plan) that a participant contributed to the Plan and 50% of the next 2% of annual compensation that a participant contributed to the Plan for the year ended December 31, 2024.

The Plan also provides for a discretionary employer matching contribution as well as a discretionary employer profit sharing contribution. There were no discretionary employer matching or profit sharing contributions during the year ended December 31, 2024. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code). The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the Plan year. Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, compensation, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in the discretionary employer contributions plus actual earnings thereon is based on the completion of two years of continuous service. A participant is fully vested after two years of credited service.

Payment of Benefits

Upon attainment of age 59½ or upon termination of service, a participant may elect to receive installment payments as permitted by the Plan or a lump-sum amount equal to the vested value of the participant's account. If the value of vested benefits credited to a participant's account is \$5,000 or less at the time of termination, the entire amount will be distributed without the participant's consent. If an election is not made, vested accounts between \$1,000 and \$5,000 at the time of distribution are automatically rolled to an individual retirement account, subject to Plan provisions.

Active participants may make hardship withdrawals of their account balances, subject to Plan provisions.

Forfeited Accounts

Forfeitures may be used to reduce future employer contributions. The unallocated forfeiture balance was \$4,672 and \$-0- at December 31, 2024 and 2023, respectively. Forfeitures of \$4,939 were used to reduce employer contributions for the year ended December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation

Investments are recorded at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurement.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the related Company safe harbor matching, discretionary matching, and discretionary profit sharing contributions are recorded in the year in which the employee's participant contributions are withheld from compensation. Any contributions attributable to the Plan year but not received by the trust by the last day of the Plan year are recorded as a receivable.

The carrying amount of the contributions receivable (if any) are assessed for the need to record a valuation allowance. The valuation allowance is an estimate derived from the Plan's historical losses of contributions receivable, adjusted for the Plan Administrator's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Based on the Plan Administrator's assessment as of December 31, 2024 and 2023, no allowances for contributions receivable were recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees for benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in investment income on the accompanying statement of changes in net assets available for benefits.

Income Taxes

The Company adopted a non-standardized pre-approved profit sharing/money purchase plan, which received an opinion letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with applicable sections of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through September 22, 2025, the date which the financial statements were available to be issued.

NOTE C - CERTIFICATION

Investment information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest, and dividends for the year ended December 31, 2024 were obtained by management and agreed to or derived from information certified as complete and accurate by the trustees.

NOTE D - FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds are valued at the net asset value of the shares held by the Plan at year end, as reported on the active markets in which the investments are traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair values of certain financial instruments could result in different fair value measurements as of the reporting date.

NOTE E - INVESTMENTS IN STABLE VALUE INVESTMENT CONTRACT

The Plan has a traditional fully benefit-responsive stable value investment contract with Transamerica Life Insurance Company (Transamerica) with a balance of \$1,857,328 and \$1,859,188 at December 31, 2024 and 2023, respectively. Contributions from the Plan and credited interest are maintained in Transamerica's general account. On a semi-annual basis, Transamerica declares a guaranteed rate of interest at least 45 days before the rate becomes effective. There is no stated minimum or maximum interest rate under the contract and therefore the investment is not considered a guaranteed investment contract.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value to non-competing funds at contract value within 30 days of the request.

The repayment of principal and interest credited to participants in the Plan is a financial obligation of Transamerica. The Plan's ability to receive amounts due is dependent on Transamerica's ability to meet its financial obligations. Transamerica's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of Transamerica or otherwise.

Transamerica may terminate the contract with 30 days advanced written notice due to significant Plan changes that impact Transamerica's obligations under the contract, if the contract can no longer be treated as a pension plan contract under the Code, if the Plan is terminated, if the Plan fails to comply with the requirements under the contract, if the Plan fails to give Transamerica information needed under the contract, if the Plan fails to furnish Transamerica with copies of any amendments to the Plan or annual report records, or if the sum of the contract account values at any time equals \$20,000 or less. Transamerica may delay withdrawals or transfers in unusual conditions, including receipt of requests totaling \$20,000,000 or more or that exceed 20% of the market value of the separate account. If either of these conditions are met, the delay will be no more than 30 business days following the date on which the withdrawal or transfer would have otherwise been made.

Certain events might limit the ability of the Plan to transact at contract value, such as partial or complete contract termination by the Plan. Upon termination, the payment may be delayed up to 270 days. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE G - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include the investment in an investment contract of the insurance company and the related dividend income, interest income, and the payment of expenses by the Plan. Such transactions are exempt from being prohibited transactions.

Transamerica Trust Company provides certain administrative services to the Plan. Transamerica Trust Company receives revenue from these services at crediting rates per investment at 0.35% of the funds' balances as of December 31, 2024. These fees reduce the rate of return credited to the Plan for these investments and are netted within net appreciation in fair value of investments on the statement of changes in net assets available for benefit.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
