Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to



prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedules agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of The Hain Celestial Group 401(k) Plan (the Plan) is provided for general information purposes only. The Hain Celestial Group, Inc. (the Company or Employer) is the Plan sponsor. Participants should refer to the comprehensive Plan Document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established as of July 1, 1990, for the benefit of all eligible employees of The Hain Celestial Group, Inc. and its subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2024, the Plan implemented certain provisions under the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (SECURE Act 2.0). Effective August 1, 2024, the Plan implemented new benefit payment options, including emergency personal expense, qualified disaster recovery, and victims of domestic abuse distributions.

The 401(k) Investment Committee (the Committee), comprised of members of management of the Company, is responsible for the general administration of the Plan. State Street Bank and Trust Company (State Street) is the Trustee of the Plan. Transamerica Retirement Solutions, LLC (Transamerica) is the recordkeeper for the Plan.

Participation

The Plan initially covered all employees who are at least 21 years of age, have completed one month of defined service, and elected to participate in the Plan. Effective June 1, 2018, the Plan implemented auto-enrollment for new employees who are hired June 1, 2018 or later, with a 3% pretax deferral into the appropriate target date fund, which the employee can opt out of within 30 days. Effective September 1, 2020, the Plan was amended such that employees may participate in the Plan with no age restriction and no service requirement. Effective January 1, 2021, the Plan was amended to implement an annual 1% auto-escalation on employee deferrals, up to a maximum of a 10% deferral.

Contributions

The Plan allows participants to contribute up to the maximum annual dollar limit for 401(k) salary deferrals pursuant to Internal Revenue Service (IRS) guidelines. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions of amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contributions, which are solely determined by management of the Company, and are allocated in accordance with the provisions of the Plan. The Company made a discretionary matching contribution to the Plan of \$2,440,914 for 2024.

The Company may make a qualified non-elective contribution (QNEC) in an amount required to pass annual compliance testing. The QNEC will be made to the accounts of only non-highly compensated participants and will be fully vested when made. For the year ended December 31, 2024, the Company did not record a QNEC.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. For the year ended December 31, 2024, expenses paid out of the Plan totaled \$251,258, which is comprised of recordkeeping and custodial fees, as well as participant distribution and loan fees. See Note 5 for further discussion regarding revenue sharing.

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus, not separately identifiable as an expense.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary matching contributions and (b) Plan earnings (losses) and is charged with an allocation of administrative expenses. Plan earnings (losses) are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested immediately in their contributions, the Company's discretionary matching and QNEC contributions and earnings thereon.

Payment of Benefits

The value of a participant's account is payable in full to the participant upon retirement, termination, disability, or to the participant's beneficiary if death occurs during employment. Additionally, the Plan provides that minimum required distributions commence upon a participant's attainment of age 73, unless the participant is still employed by the Company. Participants may also withdraw an amount at age 59½ if certain criteria are met. Payment may be made as a lump sum or partial payments.

Immediate lump sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an Individual Retirement Account unless otherwise elected. Effective January 1, 2024, the \$5,000 threshold was revised to \$7,000.

In cases of serious financial hardship, as defined by the Plan, participants may be eligible to receive a withdrawal distribution of a certain portion of their current account balance.

Forfeitures

All contributions into the Plan vest immediately. Forfeitures of Company discretionary matching contributions arise from the refunding of excess contributions to participants. The overfunded discretionary matching contributions are placed in an unallocated account. Unallocated forfeited balances as of December 31, 2024 and 2023 were \$191 and \$5, respectively. Forfeitures of \$3,491 were used in the year ended December 31, 2024 to offset the 2023 employer contribution receivable, which was paid in the year ended December 31, 2024.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Generally, participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may range up to five years or may extend beyond five years if the loan proceeds are used to purchase the principal residence of the participant. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, which is set at the time of the loan issuance. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document. Participants are allowed one loan outstanding at a time.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements were prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Contributions Receivable

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary matching

contributions are recorded in the relevant period in accordance with the terms in the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments, cash, and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

Mutual Funds - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

Collective Trust Fund - The collective trust fund is a stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the NAV of units of the collective trust less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily with no advance notice. The collective trust fund is a direct filing entity. There were no unfunded commitments as of December 31, 2024.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by State Street, the Trustee of the Plan. Transamerica provides certain administrative services to the Plan, pursuant to a Pension Services Agreement (PSA) between the Company and Transamerica. Transamerica receives revenue from mutual fund service

providers for services Transamerica provides to the funds. This revenue is used to offset certain amounts owed to Transamerica for its administrative services to the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

If the revenue received by Transamerica from such mutual fund service providers exceeds the amount owed under the PSA, Transamerica remits the excess to the Plan's trust on a quarterly basis. Such amounts may be allocated to the accounts of the participants on a pro-rata basis or credited to an expense budget account. If there is a revenue shortfall, the Company may direct Transamerica to either deduct the shortfall from participant accounts on a pro-rata basis, deduct the shortfall from an expense budget account, or bill the shortfall to the Company. During 2024, \$133,915 was remitted to the Plan's trust, and \$71,355 was used to offset administrative expenses of the Plan.

Notes receivable from participants also qualify as party-in-interest transactions.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts would remain fully vested and shall be distributed in accordance with the provisions of the Plan.

8. Tax Status

The Plan uses a pre-approved profit-sharing plan document sponsored by Transamerica. Accordingly, the Plan is permitted to rely on the opinion letter, dated June 30, 2020 from the IRS, which states the pre-approved profit-sharing plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Subsequent Events

Effective January 1, 2025, the Plan complied with the benefit provisions under SECURE Act 2.0 increasing the catch-up contribution limit for individuals aged 60-63 to the greater of \$10,000 (indexed for inflation) or 150% of the regular catch-up amount.

Effective July 1, 2025, the Plan was amended to change from discretionary matching contributions to a percentage of deferral match equal to 50% of the first 6% of compensation that a participant contributes to the Plan.

The Plan's management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued. There were no other subsequent events requiring adjustment to the financial statements or disclosures.

10. Delinquent Participant Contributions

During the Plan year ended December 31, 2024, participant contributions totaling \$515 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Company is in the process of taking the appropriate corrective measures. The delinquent contributions and the related lost earnings are expected to be remitted to the Plan during 2025.
