### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the accompanying financial statements of Drake University Voluntary Tax-Deferred Annuity Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Disclaimer of Opinion***

We do not express an opinion on the financial statements referred to above of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

***Basis for Disclaimer of Opinion***

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements referred to above may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the financial statements referred to above.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

***Other Matter***

***Supplemental Schedule Required by ERISA***

The supplemental schedule of schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule.

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Drake University Voluntary Tax-Deferred Annuity Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a 403(b) defined contribution and tax deferred annuity plan covering substantially all employees of Drake University (the University) upon hire or another institution of higher education, except for student workers, whose employment is incidental to their educational program. The Audit Committee on behalf of the Board of Trustees of the University is responsible for the oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 100% of their pre-tax annual compensation subject to certain (IRS) limitations. Employer contributions are not allowed under this Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

**Participant Accounts**

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, a pooled separate account, and annuity contracts as investment options for participants. Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of Plan earnings, and charged with withdrawals and an allocation of losses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in 100% of their contributions, plus actual earnings (losses) thereon.

**Plan Loans**

Prior to April 26, 2020, participants with a balance in the TIAA Traditional fixed annuity contract could borrow directly from TIAA using a portion of their Voluntary Plan account as security for the loan. Effective April 26, 2020, no such new Plan loans will be issued (see Notes Receivable from Participants section below related to participant loans issued after that date). Loans were limited to a minimum of \$1,000 and a maximum of \$50,000 or 45% of their TIAA Traditional fixed annuity contract balance, further limited by the amount accumulated attributable to the participant's deferral contributions.

At December 31, 2024 and 2023, participants had outstanding Plan loan balances due to TIAA-CREF of \$17,946 and \$26,852, respectively. During 2024 and 2023, no account balances were used to satisfy Plan loan defaults.

**Notes Receivable from Participants**

Effective April 26, 2020, participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their Voluntary Plan account balance subject to annuity contract and plan provisions. Loan terms range from one year to five years in one-year increments (10 years or longer for the purchase of the participant's primary residence). The loans are secured by the balance in the participant's account and bear interest at rates commensurate with prevailing rates at the time funds are borrowed as put forth by TIAA. The notes receivable from participants are Plan assets. Principal and interest are paid, directly by participants through automated clearing hours (ACH).

**Payment of Benefits**

Upon termination of service, retirement, death, or total permanent disability, a participant may elect to receive a distribution of their entire vested Plan balance, subject to the terms of the funding vehicles. Distribution options include lump-sum payments, partial payments or installments. In addition, participants may elect in-service withdrawals of their elective deferral account after reaching age 59½ or for hardship purposes. Required minimum distributions generally must begin by age 72 in accordance with IRS guidelines.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Plan Servicing Credits**

Plan servicing credits are funded with excess revenues generated by the Plan and can be utilized to offset certain expenses associated with administering and maintaining the Plan or allocated and distributed to participants. During 2024 and 2023, plan servicing credits of \$40,692 and \$40,177 were received. As of December 31, 2024 and 2023, the Plan holds servicing credits of \$23,068 and \$12,606, respectively, and the assets are maintained in the TIAA Traditional annuity. During 2024 and 2023, plan servicing credits of \$-0- and \$4,300, respectively, were used to pay administrative expenses of the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Historical Plan Administration**

Prior to 2009, the Plan's third-party administrators tracked contributions, investment earnings, distributions and other activity on a contract basis. Each participant was setup as having a separate contract and Plan level activity was not captured. This method of administration was utilized prior to January 1, 2009 as the regulations governing 403(b) plans did not require Plan level reporting. The Plan administrator believes a good faith effort was made to obtain all relevant information prior to January 1, 2009. However, as a result of the method of administration and lack of historical Plan level financial reporting, the Plan administrator is unable to obtain Plan level information prior to January 1, 2009.

Additionally, the Plan's financial statements do not present information regarding certain investments in annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. The Plan has excluded those contracts and accounts and related activity from the Plan's financial statements for purposes of the annual reporting requirements of ERISA as permitted by Department of Labor Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. Presentation of this information is required by GAAP. The effects of this departure from GAAP on the Plan's financial statements are not reasonably determinable.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for fully benefit-responsive contracts which are reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Oversight Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and TIAA and CREF (the insurance companies). See Note 5 for a description of valuation methodologies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the University, as provided by the Plan document. Expenses paid directly by the University are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

TIAA and CREF, the qualified institutions of the Plan, and TIAA on behalf of TIAA Trust, N.A., (collectively the qualified institutions) have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 INVESTMENT CONTRACTS**

**TIAA Traditional Fixed Annuity**

Each participant maintains an individual annuity contract with TIAA. TIAA may maintain a portion of the contributions in a “guaranteed account,” which is called the TIAA Traditional Fixed Account. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some recent contracts between 1% and 3%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchase a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA Traditional is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and does not represent an obligation of the Plan.

Six different contracts are available to participants. Three of these contracts are considered benefit-responsive and other three are non benefit-responsive. With respect to the fully benefit-responsive portion, there are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable. At December 31, 2024 and 2023 fully benefit-responsive traditional fixed annuity contracts reported at contract value totaled \$13,483,601 and \$13,029,667, respectively. At December 31, 2024 and 2023 non benefit-responsive traditional fixed annuity contracts reported at fair value totaled \$3,311,330 and \$3,183,872, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include, 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the net asset value (NAV) of shares held by the Plan at year-end as quoted in active markets. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

*Interest in Sub-Accounts of Variable Annuity Contracts* – Net asset value (NAV) of shares, which are valued by CREF at accumulation unit value based on the estimated value of the underlying investments held by the Plan at year-end.

*TIAA Traditional Annuity (Non Benefit-Responsive)* – Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations, considering the credit worthiness of the issuer.

*Pooled Separate Account* – Valued based upon the redemption price of units held by the Plan, which is based on the current fair value of the underlying assets of the real estate pooled separate account. Unit values are determined daily by TIAA, who is the sponsor and administrator of such funds, by dividing the fund’s net assets at fair value by its units outstanding at the valuation dates.

Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

Fair value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Fixed Annuity Funds' historical crediting rates.

**NOTE 6 EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, annuity contracts, and a real estate pooled separate account managed by the insurance company. Therefore, transactions in these funds qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on those funds.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intention to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**NOTE 8 FEDERAL INCOME TAX STATUS**

The Plan is placing reliance on an opinion letter dated August 7, 2017 received from the IRS on the volume submitter plan indicating that the Plan is qualified under Section 403(b) of the IRC and is therefore not subject to tax under current income tax law. The 403(b) Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments including mutual funds, annuity contracts, and a pooled separate account. Investment instruments, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

**NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The variable annuities are reported as mutual funds on the Form 5500, Schedule H.
