INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Endeavor Health 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Endeavor Health 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As further discussed in Note 2 to the financial statements, effective 11:59:59 p.m. Central Time on December 31, 2023 (the Merger Date), the Northwest Community Healthcare Employees' Retirement Plan (NCH 401(k) Plan), NorthShore University HealthSystem 401(k) Plan (NS 401(k) Plan), and NorthShore University HealthSystem Retirement Contribution Plan (RCP) were merged with and into the Plan, with the Plan being the surviving plan following the merger. The assets of the NCH 401(k) Plan, NS 401(k) Plan, and RCP were transferred to the Plan's Trust as soon as administratively practicable on or after the Merger Date. Effective January 1, 2024, the Plan was renamed the Endeavor Health 401(k) Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.



Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Endeavor Health 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan document and amendments thereto for a complete description of the Plan's provisions.

General

The Plan is a defined contribution Plan for eligible employees of Endeavor Health and its affiliated entities (collectively referred to as the Company). Endeavor Health is formerly known as NS-EE Holdings. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Prior to January 1, 2024, the Plan was formerly known as the Edward-Elmhurst Healthcare Retirement Savings Plan and Edward-Elmhurst Healthcare was the Plan Sponsor. Effective January 1, 2024, the Plan was renamed as the Endeavor Health 401(k) Plan and Endeavor Health replaced Edward-Elmhurst Healthcare as the Plan Sponsor.

Eligibility

For the 2023 Plan year, substantially all employees of the Company were eligible to participate in the pre-tax and Roth contribution provisions of the Plan, receive Company matching contributions, and receive an allocation of the Company discretionary contribution, if any, in the first pay period following completion of 30 days of service. Seasonal and temporary employees, independent contractors, and leased employees were not eligible to participate in the Plan. All employees of Endeavor Health and its affiliates are immediately eligible to participate in the Plan on and after January 1, 2024.

Contributions

The Plan allows for both participant and Company contributions, subject to certain Internal Revenue Service (IRS) limitations. For the 2023 Plan year, eligible employees were allowed to elect to contribute between 1% and 75% of their compensation, as defined by the Plan, as pre-tax contributions, Roth elective contributions, and after-tax contributions. For the 2023 Plan year, eligible employees who either did not elect to contribute or did not elect to decline to contribute within 60 days of hire are automatically enrolled in the Plan at a 3% pre-tax contribution rate. On a pay date occurring in October of each year before January 1, 2024 following their year of hire, participants whose pre-tax and Roth after-tax contribution rates combined were less than 10% would have their contribution rate automatically increased by 1% up to a maximum of 10%, unless the participant opted out.

Contributions *(continued)*

Effective January 1, 2024, participants can contribute from 1% to 100% of eligible pay as pretax, after-tax or Roth 401(k) contributions, or a combination, up to the annual Plan and IRS limits.

Additionally, participants can change their contribution percentage at any time and as many times as they prefer during the year. The Plan no longer has automatic enrollment and automatic increases effective January 1, 2024. Participants direct the investment of their account balance into various investment options offered by the Plan.

In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and individual retirement accounts or annuities (rollover).

For the 2023 Plan year, the Plan provided for matching contributions to be contributed each pay period to eligible employees who had made pre-tax or Roth after-tax salary contributions, including catch-up contributions, in an amount equal to the sum of 100% of the first 1% of compensation, and 50% of the next 5% of compensation. Effective January 1, 2024, each payroll period, the Company matches 100% of the first 6% of pretax and/or Roth 401(k) contributions participants make to the Plan, including any catch-up contributions. The Company made matching contributions of \$108,214 for the year ended December 31, 2024.

All company matching contributions go through a year-end true-up calculation to ensure that the match is based on the participant's total contributions made to the Plan during the year while they are eligible for a match, rather than only the pay periods in which the participant contributed.

Participant Accounts

Each participant's account is credited with the participant's pre-tax and Roth after-tax salary deferral contributions, catch-up contributions, employee after-tax contributions, rollover contributions, and allocations of Company contributions, and charged with withdrawals, allocations of administrative expenses, and allocations of Plan earnings (losses).

Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employees are immediately 100% vested in their pre-tax and Roth after-tax salary deferral contributions, employee after-tax contributions, catch-up contributions, rollover contributions, and any earnings thereon. Employees are 100% vested in Company contributions made before January 1, 2024 and any earnings thereon after the earlier of the completion of two years of service, as defined by the Plan, or the participant's disability or death. Notwithstanding the foregoing, a participant is automatically 100% vested in his or her entire account balance if (i) the participant was employed by the Company on December 31, 2006, or (ii) the participant was not employed by the Company on December 31, 2006 but his or her original hire date precedes January 1, 2007 and the participant is rehired by the Company or an affiliate on or after January 1, 2007.

Participants are always 100% vested in their own contributions to their account as well as any earnings on them. Participants will become 100% vested in the company matching contributions made under the Plan on and after January 1, 2024 upon completing 3 years of service. Participants' prior years of service with the Company will count toward the new vesting schedule.

Forfeitures and Unallocated Assets

Non-vested forfeited amounts, if any, are used to reduce Company contributions or pay Plan expenses. During 2024, \$2,220 of forfeitures were used to reduce contributions. Amounts remaining in forfeited non-vested accounts as of December 31, 2024 and 2023, were \$549 and \$788, respectively.

The Plan charges a quarterly administrative fee to participants. At December 31, 2023, \$472 of unallocated assets were available to offset future Plan expenses. Beginning January 1, 2024, a per-participant fee (which is charged quarterly) is deducted from participant accounts and paid directly to Fidelity.

Participant In-Service Withdrawals

The Plan allows for in-service withdrawals not more than once per year by participants who have attained the age of 59½ or by any participant from their rollover contributions. In addition, the Plan allows for hardship withdrawals if certain criteria are met for specific situations as defined by the Plan.

Notes Receivable from Participants

The Plan administrator may grant loans to qualified participants, as defined, of an amount not less than \$1,000 or in excess of the lesser of \$50,000 less the participant's highest outstanding loan balance in the last 12 months, or 50% of the participant's vested account balance. Loans are evidenced by written promissory notes, secured by the participant's account balance, bear interest at a rate determined by the Plan administrator based on current rates set by commercial lending institutions for similar type loans and are to be repaid over a period not to exceed five years or 20 years for the purchase of a primary residence. Principal and interest payments are made ratably through periodic electronic debits from the participant's checking or savings account. For the 2023 Plan year, a participant may could have no more than two loans outstanding at any given time. For new loans issued on and after January 1, 2024, a participant may have no more than one loan outstanding at any time. Interest rates on loans outstanding as of December 31, 2024, ranged from 4.25% to 9.50%.

Payment of Benefits

On termination of service due to death, disability, retirement, or for termination of service due to other reasons, a participant may elect to receive either a lump sum of his or her vested account balance, or choose from among several annuities or installment payments as described in the Plan.

If a participant had a money purchase pension account balance in the Plan before January 1, 1994, the normal form of payment is an annuity with a value equal to the participant's account balance. If the participant is single, the annuity is paid over the participant's life expectancy. If the participant is married, the annuity is paid over the participant's life expectancy with a 50% survivor annuity paid to his or her spouse. Instead of the normal form, the participant can elect one of several optional distribution forms with spousal consent.

If a participant is on active military duty for more than 30 days, as defined in the Heroes Earnings Assistance and Relief Tax Act of 2008, the participant may withdraw all or a portion of their account attributable to employee elective deferrals, provided; however, the participant may not make any employee elective deferrals or other employee contributions for six months following such a withdrawal.

If a participant is a member of a reserve component (as defined in 37 USC 101) and is called into active military duty for a period in excess of 179 days or an indefinite period, the participant may request to receive a distribution of all or a portion of their vested account without incurring an early withdrawal penalty.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

The Plan provides for various investment options, including a fully benefit-responsive investment contract, mutual funds, a collective trust, and other investment securities elected by participants through their self-directed brokerage account.

Use of Estimates in Preparation of Financial Statements

The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of the uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Plan's statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments, other than the investment in the fully benefit-responsive investment contract, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The fully benefit-responsive investment contract held by the Plan is stated at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Determination as to when participant loans are considered in default and reclassified as distributions is based on the terms of the Plan document.

Administrative Expenses

Management fees for investments in mutual funds and collective trust funds are deducted from income earned on a daily basis and, therefore, are reflected as a reduction of investment return for those funds. Revenue sharing received by the third-party record keeper from certain investment options are allocated as a revenue credit to participants based on their account balance in the investment option. Participants are charged a flat dollar quarterly administrative fee which is used to pay Plan expenses. Any expenses not paid by the Plan are paid by the Company and excluded from these financial statements.

Benefit Payments

Benefits are recorded when paid.

Plan merger

Effective 11:59:59 p.m. Central Time on December 31, 2023 (the Merger Date), the following plans were merged with and into the Plan:

- Northwest Community Healthcare Employees' Retirement Plan (NCH 401(k) Plan)
- NorthShore University HealthSystem 401(k) Plan (NS 401(k) Plan)
- NorthShore University HealthSystem Retirement Contribution Plan (RCP)

The Plan was the surviving plan following the merger. The plan assets of the NCH 401(k) Plan, NS 401(k) Plan, and RCP were transferred to the Plan's Trust as soon as administratively practicable on or after the Merger Date. Also, effective on the Merger Date, eligible participants, beneficiaries and alternate payees covered by the NCH 401(k) Plan, NS 401(k) Plan, and RCP became participants in the Plan. Effective January 1, 2024, the Plan was renamed the Endeavor Health 401(k) Plan.

NOTE 3 SUMMARY OF INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, accrued income and other liability at December 31, 2024 and 2023, and total investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

In measuring the fair value of the Plan's investments, Plan management utilizes a framework that provides for a fair value hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds, including those held in self-directed brokerage accounts - Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common stocks held in self-directed brokerage accounts - Valued at the closing or bid price reported on the active market in which the individual securities are traded.

Collective trust fund - Fair value is estimated using NAV as provided by the administrator of the fund as a practical expedient. NAV is determined by using the estimated fair values of the underlying assets held in the fund at year-end. The use of NAV as fair value is deemed appropriate since the collective trust fund allows for daily redemption and does not have a finite life, unfunded commitments relating to this type of investment, or significant restrictions on redemptions.

The methods described above may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

At December 31, 2024 and 2023, the Plan held guaranteed investment contracts (GICs) that met the fully benefit-responsive investment criteria and, therefore, are reported at contract value. These contracts included the Voya Fixed Plus Account III and Voya Stabilizer. In connection with the change in record-keepers from Voya to Fidelity, participation in the Voya Fixed Plus Account III investment fund under the Plan was discontinued effective January 1, 2024. As required by the Voya Fixed Plus Account III, that fund will be liquidated over a five-year period. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting interest rate is based on a formula agreed upon with the issuer; such interest rates are reviewed and may be reset on a quarterly basis. The minimum guaranteed interest rate is 1% annually.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (c) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The GIC issuer may discontinue the contract with the Plan under any of the following circumstances:

- The Plan fails to meet any of its obligations under the contracts or under any related agreements.
- All amounts under the contracts are withdrawn.
- The Plan is no longer a qualified plan under the Code.
- The Plan is terminated.
- The Plan, without the issuers' written agreement, attempts to assign the Plan's interest in the contracts.
- The Plan rejects an amendment to the contracts proposed by the issuer under the Amendments section.
- The issuers elect to discontinue accepting deposits for all contracts of this class.
- Employees of the Company are no longer eligible to participate in the Plan (any such discontinuance affects only those ineligible employees).
- A change in applicable laws and regulations (including tax laws and regulations) materially affects the taxation of the contracts or separate accounts, or otherwise materially affects the issuers' obligations hereunder.

Additionally, prior to December 20, 2023, the Plan also held a fully benefit-responsive guaranteed investment contract with Metropolitan Life Insurance Company (MetLife), which was maintained in a general account of the insurance company. Effective December 20, 2023, Endeavor Health exited this fund by making the required payment to MetLife to terminate the contract. As such, this fund was no longer available as of December 31, 2023.

NOTE 6 PLAN TERMINATION

Although it has not expressed any such intent, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE 7 TAX STATUS

The IRS has determined and informed the Company by letter dated October 26, 2015, that the Plan and the related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt. The Plan administrator submitted an IRS determination letter request on July 24, 2024, which is still pending. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Investments and its affiliated entities. Fidelity Management Trust Company, the trustee of the Plan, is an affiliated entity of Fidelity Investments and, therefore, these transactions qualify as party-in interest transactions. Notes receivable from participants also qualify as party-in- interest transactions, which are exempt from the prohibited transaction rules of ERISA. In addition, the Plan pays various service providers for certain expenses incurred in connection with investment management or operation of the Plan. Transactions with respect to these service providers also qualify as party-in-interest transactions.

NOTE 10 SUBSEQUENT EVENTS

Effective January 1, 2025, with respect to participants who will attain age 60 but will not attain age 64 before the close of a given plan year, catch-up contributions will not exceed the adjusted dollar amount under Internal Revenue Code Section 414(v)(2)(E) (as adjusted for increases in the cost-of-living). These catch-up contributions shall be administered in accordance with Section 109 of the SECURE Act 2.0 and any related guidance and regulations issued thereunder.

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.
