December 31, 2024

1. Description of Plan

The following description of the Berwind Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Company.

General

The Plan is a defined contribution plan covering all eligible employees of Berwind Corporation and affiliated companies (collectively referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Vanguard Fiduciary Trust Company is the trustee and The Vanguard Group, Inc. is the record-keeper for the Plan (collectively, Vanguard). The Administrative Committee is responsible for the general administration of the Plan.

Contributions

Participants may contribute pretax contributions of 1% to 60% of their compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants aged 50 and older may make catch-up contributions. Participants may contribute Roth contributions of 1% to 60% of their compensation, as defined in the Plan.

Participants that do not accrue benefits under a separate defined benefit pension plan sponsored by the Company (Non-grandfathered participants) are automatically enrolled in deferral contributions with an initial contribution rate of 3%. Each year after the first year of participation, this contribution rate is increased by 1% up to 6% of compensation. Additionally, a safe harbor contribution is matched at 100% of the first 1% of compensation plus 50% of the next 5% of compensation (Safe Harbor Match).

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participants that accrue benefits under a separate defined benefit pension plan sponsored by the Company (Grandfathered participants) receive matching contributions in one of two ways:

- If participant's compensation in the prior year, including bonus, was less than the Internal Revenue Service (IRS) threshold to be considered a highly compensated employee (HCE), the participant receives the Safe Harbor Match.
- If the participant does not qualify for the Safe Harbor Match, the participant receives a matching contribution in an amount equal to 50% of deferral contributions (including catch-up contributions) up to 4% of compensation with a maximum matching contribution of \$1,000, determined on an annual basis.

In addition, Non-grandfathered participants with 1,000 hours of service during the Plan year also receive an annual non-elective Company contribution in an amount equal to 3% of compensation.

All contributions are subject to certain Internal Revenue Code (the Code) limitations.

All investments are participant-directed. Participants may direct contributions in any of the Plan's available fund options. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and non-elective contributions and allocations of Plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants that were hired prior to January 1, 2017, including Grandfathered participants, were immediately fully vested in their account balances. Participants that are hired on or after January 1, 2017, including Non-grandfathered participants, are 100% vested in the Company's matching contributions after two years of credited service and non-elective contributions after five years;

1. Description of Plan (continued)

however, they are immediately vested in their contributions plus actual earnings thereon. Forfeited balances of terminated participants' non-vested accounts are used to reduce Company contributions or pay for administrative expenses. There were forfeited balances of \$6 and \$3,700 as of December 31, 2024 and 2023, respectively.

Participant Loans

Participants may borrow from their participant accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed five years unless the loan is for the purchase or construction of a primary residence. A participant may only have one loan outstanding at a time; however, effective July 7, 2023, the maximum number of outstanding loans was increased from one to two loans. The loans are secured by the balance in the participant's account and bear interest at a fixed rate based on the Prime Rate plus 1%. The Prime Rate is established at April 30 or October 31 for loans issued during the following six months. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant whose account balance is \$1,000 or less and has not commenced receiving payments will automatically receive an immediate lump-sum distribution equal to his or her account balance. A participant whose account balance exceeds \$5,000 may elect to receive a distribution in the form of: a lump-sum, installments, partial lump-sum, or a rollover equal to the participant's interest in his or her account; and a participant whose account balance is more than \$1,000, but \$5,000 or less, and has not commenced receiving payments will automatically be paid a direct rollover to an individual retirement account selected by the Administrative Committee, unless the participant affirmatively elects distribution in a single sum payment or through a direct rollover to an eligible retirement plan specified by the Administrative Committee.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Due to the COVID-19 pandemic, management opted in for the distribution, relief for loan repayments and required minimum distribution provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, which were effective immediately in 2020 with no formal amendments required until December 31, 2026.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. The Company pays the majority of the administrative expenses incident to the management of the Plan; however, certain costs may be paid from the assets of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, account balances shall be held for distribution by Vanguard, subject to outstanding loans and administrative costs.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (U.S. GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard.

4. Fair Value Measurements

Fair value is defined under Accounting Standards Codification 820, *Fair Value Measurement*, as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy

gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - quoted prices for similar assets and liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in markets that are not active
 - observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the valuation techniques and inputs used at December 31, 2024 and 2023.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

6. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan invests in shares of registered investment companies managed by an affiliate of Vanguard. The Plan also holds units of common/collective trusts managed by Vanguard. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 4, 2025, the date the financial statements were available to be issued. Based on this evaluation, no additional disclosures or adjustments were required to be made to the financial statements as of December 31, 2024.
