NOTE 1 - PLAN DESCRIPTION

The following description of the Refinery Terminal Fire Company Money Purchase Pension Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined noncontributory plan covering the employees of Refinery Terminal Fire Company (the Company) who have completed one year with at least 1,000 hours of service can enter as of the first day of plan year or the first day of the seventh month of the plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee oversees governance of the Plan by determining the appropriateness of the Plan's investment offerings and monitoring performance.

Contributions

Each year that the participant is eligible to share in contributions, the plan sponsor will contribute an amount equal to 15% of the employee's compensation. Minimum funding requirements have been met. Compensation is generally defined as the employee's total compensation paid to the employee by the plan sponsor during the plan year. Compensation is recognized only for the period in which the employee is actually a participant in the Plan. Adjustments to compensation include the exclusion of overtime, bonuses, and commissions. Salary deferral to any other plan or arrangement, such as a cafeteria plan, will be included in compensation. For the 2024 and 2023 Plan years, Participants were able to direct the investment of Company contributions to their accounts into various investment options offered by the Plan, including several mutual fund accounts. Contributions are subject to certain limitations. The Company's contribution for the years ending December 31, 2024 and 2023 were \$1,482,168 and \$1,284,561, respectively.

Participant Accounts

Each participant's account is credited with the Company's contribution and Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, such as hardship, a participant may receive the value of the vested interest in his or her account as a lump-sum or rollover distribution. Normal retirement age under the Plan is sixty-five.

Forfeited Accounts

Forfeited nonvested accounts totaled \$0 for the years ending December 31, 2024 and 2023, respectively. These amounts may be used to reduce future employer contributions.

Vesting

Participants are 100% vested in employer contributions after they complete three years of credited service.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis in accordance with principles generally accepted in the United States of America as of December 31, 2024 and 2023. Employer discretionary contributions are recognized as revenues in the period in which they are determined. Benefits payable are recognized when due and payable in accordance with terms of the Plan.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported on contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Expenses

All operating expenses of the Plan are paid by the Company and are therefore excluded from these financial statements.

Investment Valuation and Income Recognition

The Plan entered into an investment contract with John Hancock Life Insurance Company (U.S.A.) who maintains the contributions in various mutual funds. Investments in mutual funds are maintained at fair value.

Investment Valuation and Income Recognition (continued)

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for the discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation and appreciation include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits payable are recognized when due and payable in accordance with terms of the Plan.

Date of Management's Review

Subsequent events were evaluated through September 5, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 is not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were unavailable. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by John Hancock Life Insurance Company (John Hancock), which included total investments as of December 31, 2024 and 2023, the total investment income for the year ended December 31, 2024, and all information included in the supplemental schedule H, Line 4i-Schedule of Assets (Held at End of Year).

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination or complete discontinuance of contributions, participants would become 100% vested in the employer contributions.

NOTE 6 - TERMINATED EMPLOYEES

The Plan has a "cash out" provision whereby the Plan can distribute the vested account balance for terminated participants with account balances not exceeding \$5,000. The Plan did not have terminated participants with vested account balances less than \$5,000 on December 31, 2024 and 2023.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - INCOME TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan is qualified under Section 401 of the Code and, therefore, the related trust is exempt from taxation.

Generally accepted accounting principles require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan investments in the self-directed brokerage fund are managed by John Hancock Life Insurance Company. Therefore, these transactions qualify as party-in-interest transactions. The party-in-interest transactions also include fees paid during the year for trustee, accounting, and other services, as well as contributions paid to the Plan by the Company. However, no fees were paid by the Plan for the investment management services for the year ended December 31, 2024. All these transactions are exempted from prohibited transaction rules under ERISA.

NOTE 10 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual fund accounts managed by John Hancock Life Insurance Company (U.S.A). John Hancock Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. However, no fees were paid by the Plan for the investment management services for the years ended December 31, 2024 and 2023. All the party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 11 - CONTINGENCIES
