Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Rocky Flats Welfare Benefits Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. Formation of the Plan

Effective January 1, 2002, the Rocky Flats Employee Welfare Trust (the "Trust") established the Rocky Flats Welfare Benefits Plan. Under the Plan, welfare benefits were provided to eligible employees of the contractors, former contractors, subcontractors, and former subcontractors to the Department of Energy (DOE) at the Rocky Flats Environmental Technology Site (the Site). Welfare benefits were also provided to eligible retirees of such contractors and subcontractors and dependents of employees, former employees, and retirees.

Effective December 31, 2005, remediation work at the Site was completed and all active employees were laid off. Kaiser-Hill Company LLC (Kaiser) and two subcontractors continued to provide welfare benefits to participants under the Plan through April 30, 2006. Effective May 1, 2006, the two subcontractors withdrew as sponsors of the Trust, leaving Kaiser as the sole remaining sponsor. Effective October 1, 2006, pursuant to instructions of the DOE, Kaiser assigned all of its rights, authority, and responsibilities as Plan Sponsor to CH2M Hill Hanford Group, Inc. (CHG), as successor Sponsor. Contemporaneously, trustees of the Trust appointed by Kaiser were removed and replaced by trustees appointed by CHG.

Effective October 1, 2008, Washington River Protection Solutions, Inc. (WRPS or Sponsor) pursuant to instructions from the DOE, assumed all of the rights, authority, and responsibilities for providing the health and welfare benefits to former Rocky Flats employees. Contemporaneously, trustees of the Trust appointed by CHG were removed and replaced by trustees appointed by WRPS.

On January 25, 2021, the Plan's daily operational and plan administrative activities were transitioned from WRPS to Hanford Mission Integration Solutions LLC.

The Plan shall continue to be maintained for the exclusive benefit of, and to provide certain health and welfare benefits, for eligible former employees of the employers and their eligible dependents.

B. Benefits

The Plan provides health and pharmacy benefits, life insurance, and long-term disability coverage to eligible former employees and eligible dependents, as defined by the Plan. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

C. Insured Benefits

The Plan fully insures the life insurance and long-term disability benefits and some health benefits. Premiums for the benefits are paid from Trust assets.

D. Self-Insured Benefits

Some health benefits are self-insured. The claims for self-insured benefits are processed by third-party claims processors under administrative services-only arrangements. Claims are paid from the Plan's zero balance account by UMR (insurance company) claims processors.

D. Self-Insured Benefits (Continued)

The Plan utilizes a pharmacy benefit manager which periodically sends rebates to the Plan based on the Plan's actual utilization pattern of specific drugs and their contractual formularies.

E. Retiree Reimbursement Arrangement

Effective January 1, 2015, the Plan established the Retiree Reimbursement Arrangement (RRA). The RRA removes all retirees and dependents age 65 and older from the traditional group plan and, instead, provides each eligible individual with a stipend. Participants use this stipend to purchase individual coverage through UnitedHealthcare's exchange and cover any other costs allowed in IRS publication 502. OptumHealth is the facilitator of the stipend. The stipend amount will roll over to the next year with no maximum amount allowed to have in their RRA account. Once a participant deceases or becomes ineligible for RRA funding, any monies still in the RRA account will be forfeited back to the Trust to be used to reimburse remaining participants for high-cost pharmaceuticals. During 2024 and 2023, forfeited RRA balances of \$1,943,082 and \$1,779,064 were available to fund participant high-cost pharmaceuticals in the subsequent year. The Sponsor makes contributions to the Plan to fund RRA, as needed, to pay claims.

F. Contributions

Sponsor contributions are the amount necessary to cover administrative costs and remaining benefits provided under the Plan after contributions. Participant contributions are funded to the Trust monthly, and the Sponsor funds the Trust through funds received from the DOE as benefit claims are processed and premiums are paid. Participants contribute a fixed amount of premiums and anticipated claims depending on their retirement date and years of service. Based on this, the percentage of contributions paid by participants in relation to total Plan benefits paid was approximately 2% for the years ended December 31, 2024 and 2023.

G. Medicare Subsidy

Beginning in 2015, participants eligible for the RRA account may use their RRA reimbursement for prescription drugs. Therefore, the Plan no longer expects to receive Medicare subsidies.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Payment of Benefits

Premiums paid by the Trust are recorded as health care premiums in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processors.

D. Rebates

Rebates due from the pharmacy benefit manager are recorded when received. For the years ended December 31, 2024 and 2023, pharmacy rebates are netted against health care claims on the statements of changes in net assets for available benefits totaling \$77,570 and \$121,919, respectively.

E. Cash

Pursuant to its agreement with the DOE, the Plan does not maintain interest-bearing cash accounts. The Plan maintains its cash in bank accounts in amounts that, at times, may exceed the federally insured limit of \$250,000 per bank. The Plan has not experienced any losses in such accounts.

F. Deposit with Insurance Company

The deposit with insurance company is a required balance to be maintained at UnitedHealthcare for the purpose of reimbursing claims and/or fees for the RRA.

G. Administrative Expenses

Some administrative and professional fees relating to the direct management of the Plan's assets and benefit payments are funded by the Plan on behalf of the sponsoring company.

H. Tax Status

The Trust established under the Plan holds Plan assets and pays benefits in accordance with the Trust Agreement. Although the Plan is a taxable entity under the Internal Revenue Code, the Plan administrator understands that the Plan had no taxable income during the years ended December 31, 2024 and 2023. Accordingly, no provision or liability for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right to terminate the Plan and discontinue its contributions at any time. If the Plan or any portion of the Plan is terminated, the Plan Sponsor shall apply Trust assets to reasonable and necessary expenses incurred in such termination and for payment of benefits to the participants until trust assets are exhausted.

J. Risks and Uncertainties

The actuarial present value of Plan benefit obligations is based on certain assumptions pertaining to interest rates, employee demographics, and medical cost trend rates, all of which are subject to change. Due to the uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the financial statements.

NOTE 3 - BENEFIT OBLIGATIONS

Benefit obligations at December 31 for claims incurred by participants but not yet reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. Such estimated amounts are reported in Plan benefit obligations as all obligations are considered payable within one year. Any differences between estimated amounts and actual claims incurred are reflected in subsequent periods.

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future health and life insurance benefits expected to be paid to or for currently retired or terminated employees and their beneficiaries and dependents who qualified for postretirement benefits as of December 31, 2024. The postretirement benefit obligation represents the expected future funding requirements from the DOE.

The actuarial present value of the expected postretirement benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participants and to adjust such estimates for the time value of money (through discounts and interest) and the probability of payment between the valuation date and the expected date of payment.

The following are the significant assumptions used in the valuations as of December 31, 2024 and 2023:

Discount Rate – 4.80% and 5.60% (for December 31, 2024 and 2023, respectively).

Mortality – Pri.H-2012 head count weighted sex distinct generational mortality tables for annuitants and non-annuitants with contingent survivors (for current survivors) and no collar adjustment projected with Scale MP-2021 mortality improvements.

The Plan utilizes the standardized medical trend rates prescribed by the DOE, which have been adjusted slightly to reflect the Plan's use of a net claims valuation method (versus the gross claims method requested by the DOE). The adjustment reflects the leveraging and dampening effects which deductibles, co-payments, and maximum benefit provisions exert on the trend in gross claims. The leveraging factor assumed increases in the trend rates and is reflected as follows:

The foregoing assumptions are based on the fact that the Site closed in October 2005 and that there will be no new participants after that date. In the event of Plan termination, different actuarial assumptions and other factors might be applicable in determining actuarial present value of the post-retirement benefit obligation.

Changes to assumptions – Since the prior valuation, the mortality table was changed as prescribed by the DOE, the discount rate was changed, and updates to the trend and claims assumptions were made.

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by one percentage point in each year, that would increase the obligation as of December 31, 2024 and 2023, by \$6,334,868 and \$5,920,718, respectively.
