Enclosed is a Form 5500 Annual Report for the above referenced Plan. Please note that the plan sponsor is the Redding Rancheria, a federally recognized Indian tribal government (the "Tribe"). The Tribe is filing the enclosed Form 5500 in connection with the Tribe's operational good faith compliance with Section 906 of the Pension Protection Act of 2006 (the "PPA"), as required pursuant to Internal Revenue Service ("IRS") Notice 2006-89.

The only federal guidance on essential government functions or commercial activities under the PPA as of the date of this filing is set forth in IRS Notice 2006-89. That Notice lists five activities presumed to be "commercial" in nature for purposes of the IRS good faith transition relief pending further guidance, and requests comments prior to the issuance of formal guidance under the PPA. The Tribe, along with other tribes and tribal organizations across the country, submitted timely comments in opposition to the approach taken in Notice 2006-89. In April 2024, the Tribe submitted comments in support of the Treasury Tribal Advisory Committee ("TTAC") Subcommittee on Parity and Reform's Project Plan and Report with regard to the governmental plan issues presented by the Pension Protection Act of 2006 (the "PPA") and comments in opposition to the approach taken on governmental plan issues in the Advance Notice of Proposed Rulemaking published in IRS Notice 2007-67.

The Enterprise Plan includes employees engaged in activities identified as "commercial" in Notice 2006-89 and therefore the Tribe is making the enclosed Form 5500 filing. However, the Tribe reserves its right to assert government status under the PPA for all of its employee welfare benefit plans and has requested consultation and participation in the pending regulatory efforts to define commercial activities under the PPA. The enclosed filing is not to be construed as a waiver of sovereignty or government status by the Tribe or any of its enterprises or employee benefit plans. It is the Tribe's intent to preserve its right to treat the above-referenced plan as a governmental plan under Internal Revenue Code Section (the "Code") 414(d) and Section 3(32) of the Employee Retirement Income Security Act of 1974 ("ERISA") in accordance with final PPA guidance and/or any future changes in the Code and ERISA. The Tribe reserves its right to consultation under Executive Order 13175 with regard to all matters arising under or out of the PPA.
