We have performed an audit of the financial statements of Teal Jones Lumber Services, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Teal Jones Lumber Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following employers (collectively the “Company” or Sponsor”) participate in this Plan:

- Teal Jones Lumber Services, Inc.
- Teal Jones Lumber, LLC
- GreenTree Lumber Company, LLC
- Pine Products, LLC
- Potomac Supply, LLC
- Plain Dealing, LLC

Empower Trust Company and Empower Annuity Insurance Company of America (“Empower”) are the custodians of the Plan, and Empower Retirement LLC is the recordkeeper. Pension Plan Specialists, P.C. serves as the Third-Party Administrator. Employees of the Company serve as trustees.

Plan Amendment – The Plan was amended effective May 31, 2024, to include Plain Dealing, LLC as a participating employer in the Plan.

Partial Plan Termination – During the year ended December 31, 2024, the Company experienced a significant reduction in workforce resulting in the involuntary termination of more than 20% of Plan participants. This event constitutes a partial plan termination. As a result, all affected participants will become 100% vested in their Company contributions, regardless of the Plan’s regular vesting schedule.

Eligibility – An individual is eligible to participate in the Plan after reaching the age of 18 and completing two months of service. Once the requirements have been met, the employee may enroll in the Plan on the first day of the following month. The Plan is not open to leased employees or non-resident aliens.

Contributions – Participants may elect to contribute any percentage of their annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. In addition, participants over age 50 are permitted to make catch-up contributions, as defined in the Plan.

The Plan includes a Qualified Automatic Contribution Arrangement (“QACA”) whereby eligible participants will have an automatic deferral amount of 3% of eligible compensation withheld, unless the participant elected to have another amount or 0%. Each successive year the deferral will increase by 1%, to a maximum amount of 10%.

The Company has elected to make QACA safe-harbor matching contributions to all employees who have deferred to the Plan at a rate of 100% of the first 3% of gross compensation contributed, and 50% of the next 2% of gross compensation contributed. The Company may also make discretionary employer matching contributions not to exceed 4% of eligible compensation, or profit sharing contributions using an integrated allocation method. Participants must be employed on the last day of the Plan year to receive profit sharing contributions. No discretionary matching or profit sharing contributions were made in 2024.

Participant Accounts – Each participant's account is credited with the participant's and Company's contributions, an allocation of the Plan's investment earnings (losses), and is charged with the participant's withdrawals and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – The Plan offers mutual funds and a fixed account as investment options for participants.

Vesting – Participants' contributions are fully vested at all times. The Company's QACA safe harbor contributions, and the earnings or losses thereon, vest in 0% after year 1, and 100% after year 2. The vesting schedule for the Company's discretionary matching and profit sharing contribution is as follows:

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to reduce future employer contributions and pay plan expenses. During 2024, \$39,780 in forfeitures were used to pay Plan expenses. Forfeitures in the amount of \$58,409 were used to reduce employer contributions during the year ended December 31, 2024. As of December 31, 2024 and 2023, there is \$48,506 and \$34,502 in forfeitures available, respectively.

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum amount equal to their vested account balance, or monthly, quarterly, or annual installments over a fixed, reasonable period of time, as defined by the Plan document. If the account balance does not exceed \$7,000, the Plan allows for automatic distribution. For distributions greater than \$1,000 but not exceeding \$7,000, the account balance will be rolled over into an individual retirement account, unless otherwise directed by the participant.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferral contributions.

Participants who have attained the age of 59 ½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, unless the loan is to acquire the participant's principal residence, then the term will be established by the Plan Administrator at the time of the loan. Interest rates are established as the Prime rate plus 1 percentage point. A participant's loan shall immediately become due and payable upon termination from employment for any reason, or upon failure to make a principal and/or interest payment, as provided in the loan agreement. The balance in the participant's account secures the loan. Participants may only have one loan outstanding at any time.

Administrative Expenses – Plan fees and expenses, including fees and expenses connected with providing administrative services by external service providers are paid from Plan assets. Expenses totaled \$102,215 for 2024. The Company may pay other professional fees associated with the Plan.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for the fully benefit-responsive fixed account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management's Review – Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes used in the methodologies used at December 31, 2024 and 2023:

Mutual funds – Valued at the published net asset value (“NAV”) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants, including related interest income
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. FIXED ACCOUNT

The Plan provides a Fixed Account, a group annuity contract by Empower, as an investment option for participants which is considered fully benefit-responsive. The objective of this investment option is to guarantee the return of principal plus compound interest earned over a defined term backed by Empower. There are no specific securities in the general account that back the liabilities of this group annuity contract. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Empower is obligated to pay interest at crediting rates, which are announced in advance and guaranteed per the terms of the contract. The crediting rate at December 31, 2024 and 2023 was and 1.45% and 1.35%, respectively. The average yield for the contract was 1.41% and 1.23% for 2024 and 2023, respectively. Certain events might limit the ability of the Plan to transact at contract value, as prescribed in the contract. Plan management believes that the occurrence of such events is not probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

7. TAX STATUS

The Company adopted a Prototype Non-Standardized Pre-Approved Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments include a fixed account managed by Empower. Empower is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest.

The Plan has a number of service providers, and such providers are parties-in-interest under ERISA. Notes receivable from participants are party-in-interest transactions.

9. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, employee deferrals of \$1,213 were withheld from one payroll and not remitted on a timely basis (as defined by the Department of Labor "DOL") by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust, will file and pay the appropriate excise tax, and contribute lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.

During the year ended December 31, 2023, employee deferrals of \$85,789 and loan payments of \$11,084 were withheld from various payrolls and not remitted on a timely basis (as defined by the Department of Labor "DOL") by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust, filed and paid the appropriate excise tax, and contributed lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.
