1. Description of the Plan

The following description of the Dr. Martens 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document or summary plan description for a more complete description of the Plan’s provisions. The Plan’s date of inception was January 1, 1996.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of Dr. Martens AirWair USA LLC (the “Company”) who have at least three months of service and are age 18 or older. The Company is the plan administrator; accordingly, certain members of its management have been appointed to be responsible for overseeing the Plan’s operations including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year participants may contribute up to 90 percent of their annual compensation, subject to certain limitations, as defined by the plan document. The Company matches 100 percent of the first 4 percent of compensation a participant contributes to the Plan. Participants may change their deferred contribution percentage as of the beginning of each payroll period. Participants may direct contributions into any of the investment options offered under the Plan. Participants may transfer contributions among investments or change their future investment options at any time. Eligible employees are automatically enrolled into the Plan at an initial automatic salary deferral rate of 4 percent for the first year. Employees who do not wish to participate in the Plan are required to file an affirmative election to terminate their respective participant contributions. Unless an alternative election is made by the participant, the automatic salary deferral rate increases by 1 percent each year up to a maximum of 10 percent of the participant’s annual compensation as defined by the plan document. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Employer contributions which may be required to be designated as top-heavy contributions, if any, vest at a rate of 20 percent per year and become fully after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are collateralized by the balance in the participant's account. The loan interest rate, determined quarterly, is set based upon the prime rate, as defined by the plan document. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service or other eligible circumstances described in the plan document, a participant may elect to receive distributions in any combination of installment, lump-sum or rollover distributions equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$25,125 and \$22,631, respectively. These accounts may be used to pay certain administrative expenses of the Plan or to reduce future employer contributions.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar

assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the investment trustee for all of the Plan's assets as follows:

- Common/collective trust investments are valued by the respective fund's manager as of the close of trading each business day. The net asset value ("NAV") per unit is computed by dividing the total value of the assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the portfolio and included in the determination of unit values. Unit purchases and redemptions initiated by participants are transacted at the NAV per fee class of the fund and are valued at the transaction date.
- Registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fidelity Advisor Stable Value Portfolio

Investments in common/collective trusts include investments in the Fidelity Advisor Stable Value Portfolio: Class I ("FA Stable Value Portfolio") fund. The FA Stable Value Portfolio invests in stable value instruments, and in certain other fixed income or money market obligations or in a variety of collective investment vehicles which invest in such obligations. A stable value instrument is a fixed income obligation, the rate of return of which is guaranteed by the issuing insurance company, bank, savings and loan or other financial institution; or a debt instrument or portfolio of debt instruments owned by the FA Stable Value Portfolio combined with a fully benefit responsive contract wrapper issued by an insurance company, bank, savings and loan or other financial institution. The FA Stable Value Portfolio achieved a market value yield of 3.92 percent with a contract value yield credited to participants of 2.15 percent for the year ended December 31, 2024.

Withdrawals for benefit payments are executed as requested on any business day. Withdrawals for participant transfers to competing investment options are generally executed within 90 days after such transactions are requested. Were the Plan to initiate a full redemption of the FA Stable Value Portfolio, the investment adviser reserves the right to temporarily delay withdrawal from the trust for up to twelve months.

6. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are shares of mutual funds managed by affiliates of Fidelity. Fidelity is the trustee as defined by the plan document; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment management services are included in net appreciation in fair value of the investment, as they are paid at the investment level, rather than through direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments for investment advisory and management services totaling \$60,333. The Company pays directly certain other fees related to the Plan's operations.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the provisions of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

8. Tax Status

The Plan has adopted a Fidelity volume submitter profit sharing plan agreement. The Internal Revenue Service has determined by a letter dated June 30, 2020 that the prototype plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
