Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Burton Flower and Garden, Inc. 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Burton Flower and Garden, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Plan participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established effective September 30, 1974, is a defined contribution profit sharing plan which covers employees of BFG Supply Co., LLC and its affiliates (collectively, the "Company"), who have completed 1,000 hours of service during the plan year and have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Plan participants may authorize the Company to make salary deferral contributions to the Plan up to 100% of eligible compensation not to exceed the annual limits prescribed under the Internal Revenue Code ("IRC"). Additionally, participants may make after-tax ("Roth") contributions, subject to the provisions of the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Plan participants may also make rollover contributions of amounts distributed to them from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contributions for participants with at least 1,000 hours of service during the Plan year. During 2024, the Company matched 50% of the first 6% of participant deferrals. A matching contribution will also be made for any participant who dies, retires or becomes disabled during the year. Additional profit sharing amounts may be contributed at the option of the Company. There were no profit sharing contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is vested 25% after one year of service and 25% each year thereafter until they are 100% vested after four years of service.

Notes Receivable from Participants

Participants have the right, subject to certain restrictions, to borrow from their accounts. Generally, the maximum amount a participant may borrow is the lesser of \$50,000 or 50% of their vested account balance. Loans bear a fixed rate of interest based on prime rates at the time the loan is made, and are collateralized by the balance in the participant's account. Repayment of loans must be made, generally, over a period not to exceed five years, unless the loan is made for the purchase of a primary residence. The loans bear interest at rates ranging from 4.5% to 9.5% as of December 31, 2024 and 2023.

Payment of Benefits

Payment of benefits may be made upon retirement, attainment of retirement age (65), death, termination of service, or total and permanent disability. A participant or the designated beneficiary receives a lump-sum amount equal to the value of his or her account. A participant over the age of 59-1/2 may also withdraw fully vested amounts. Benefits are typically paid in a lump sum, however, the participant may elect to receive in periodic installments, as single life annuity or a qualified joint and survivor annuity. If the total value of the participant's vested account balance is \$1,000 or less, the participant's balance will be distributed in a lump sum. If the vested account balance is over \$1,000, but \$5,000 or less, and if the participant does not elect for either a direct rollover or lump sum payment, the Plan Administrator deposits the distribution into a designated individual retirement account.

Forfeited Accounts

If a participant terminates employment prior to being fully vested, the non-vested portion is forfeited. The balance of forfeited accounts was \$34,637 and \$15,167 as of December 31, 2024 and 2023, respectively. Forfeited amounts, if any, are first used to pay administrative expenses of the Plan, and remaining forfeitures are used to reduce Company contributions. Forfeitures utilized during 2024 totaled \$12,424.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value other than the Plan's investment in the guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The Plan pays all administrative fees to the extent not paid by the Company.

Subsequent Events

Management has evaluated subsequent events through September 23, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability assumptions regarding risk.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The valuation of investments has been provided by Reliance Trust Company, the Trustee, and represents fair value. Mutual funds are valued at published market prices of shares held by the Plan at year end. Investments in common trust funds are valued at the net asset value (NAV) of the underlying investments held by the funds, less their liabilities. Net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive investment contract with Standard Insurance Company ("The Standard"). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The crediting rate was 3.04% and 2.78% at December 31, 2024 and 2023, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, transfers to and from other investment accounts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 5 - SUMMARY OF FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on investments and cash, and related investment income that is certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan, except to compare such information to the information included in the accompanying financial statements. Information certified by the Trustee includes investment amounts included in the statements of net assets available for benefits and investment income included in the statement of changes in net assets available for benefits.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become vested in their accounts.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments include units in common trust funds managed by Reliance Trust Company. Fees are paid by the Plan for investment management services. Reliance Trust Company is the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in fair value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 9 - TAX STATUS OF THE PLAN

The Plan has adopted a volume submitter plan document sponsored by Standard Retirement Services, Inc. which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the volume submitter plan document was designed in accordance with applicable provisions of the IRC. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and being operated in accordance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 and for the year ended December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS.
