### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of USCA Management LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### 1. DESCRIPTION OF THE PLAN

The following description of USCA Management LLC 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a qualified retirement plan generally covering substantially all employees of USCA Management LLC (“Company”). The purpose of the Plan is to enable eligible employees to save for retirement. The Plan has been amended as of May 1, 2023, to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Plan Administration**

Fidelity Management Trust Company is the trustee of the Plan and responsible for trusteeing the Plan’s assets in its possession. Fidelity Investments is the recordkeeper of the Plan.

##### **Eligibility and Contributions**

The Plan has no age requirements or service requirements to participate in the Plan.

Participants may elect to defer a percentage of their eligible compensation into the Plan. The contributions are not to exceed the annual limits set by the Internal Revenue Service (“IRS”). Participants age 50 or older by the end of the taxable year may also make catch-up contributions to the Plan. Participants can increase, decrease, suspend, or resume their deferral contributions.

The Company may make discretionary matching and/or nonelective contributions to the Plan. For the year ended December 31, 2024, no employer contributions were made.

A participant can also roll over part of or all of an eligible distribution they receive from an eligible retirement plan into this Plan as a rollover contribution.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their account balances in any of several investment securities. Participants can change their investments among the various investment securities either through direct transfers from one fund to another or by changing the percentage allocation of future contributions. The Plan also has a self-directed brokerage program with allows a wide variety of investments with a diverse fee structure.

##### **Vesting**

Participants are immediately vested in their contributions, rollovers, and earnings thereon. Participants vest in employer contributions after three years of service.

**Notes Receivable from Participants**

The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. All loans bear a reasonable rate of interest. All loans must be repaid in level payment through after-tax payroll deductions over no more than a five-year period unless the loan was for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years. A participant may only have one loan outstanding at any given time.

**Payment of Benefits**

Participants are eligible to request a distribution from their vested account balance upon the event of death, disability, retirement, required minimum distributions, or termination of employment. In service withdrawals are permitted for hardship withdrawals and withdrawals after age 59½.

A participant's vested account balance will be paid in a lump sum distribution. The participant may elect a distribution paid directly to themselves, a rollover distribution to an IRA or another employer's qualified plan, or a combination of a direct payment and rollover.

**Forfeiture Accounts**

If a participant terminates employment with the Company and is less than 100% vested in their employer account, the participant forfeits the non-vested portion of their employer account. Forfeitures are retained in the Plan and may be used to pay administrative expenses or reduce future employer contributions. As of December 31, 2024 and 2023, forfeiture accounts totaled \$849 and \$1,499, respectively. In 2024, the Plan used \$736 from forfeitures accounts to pay for administrative expenses.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred.

**Benefits Paid to Participants**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds are deemed to be actively traded.

*Money Market Fund:* Valued at the daily closing price as reported by the fund. The money market fund is an open-end fund that is registered with the SEC. This fund is required to publish its daily NAV and to transact at that price. The money market fund is deemed to be actively traded.

*Self-Directed Brokerage Accounts:* The self-directed brokerage accounts consist of mutual funds, a money market fund, and common stocks. Mutual funds and the money market fund are valued at the daily closing price as reported by the funds. These funds are open-end funds that are registered with the SEC. These funds are required to publish their NAV and to transact at that price. The funds held in the brokerage accounts are deemed to be actively traded. Common stocks held in the brokerage accounts are valued at the closing price reported on the active market on which the individual securities are traded.

**4. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

**5. TAX STATUS**

The Company adopted a pre-approved plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the pre-approved plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and related trust is tax-exempt.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

**7. PLAN TERMINATION**

The Company has no legal or contractual obligations to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024, Fidelity 500 Index Fund and Fidelity Contrafund Fund represent 12% and 15%, respectively, of the total net assets available for benefits under the Plan. These investment concentrations may subject the Plan to greater risk due to lack of diversification. Participants are encouraged to review the investment objectives, risks, and expenses associated with each option.
