**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Great Lakes Community Action Partnership 403(b) Tax Sheltered Annuity Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

The Plan is a participant-directed defined contribution plan, covering all full-time employees, established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Great Lakes Community Action Partnership (the "Employer") is the Plan Sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan’s investment alternatives.

**Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Catch-up contributions are available to be made by participants over age 50. Participants may contribute rollovers from other qualified plans. Participants may change their contribution deferral election at the beginning of each quarter. Participants’ contributions are 100 percent matched by the Employer, up to 4 percent of compensation. In addition, the Employer may elect to make discretionary nonelective contributions to the Plan. During 2024, the Employer elected to make discretionary nonelective contributions equal to 100 percent of the first 3 percent of compensation for each eligible participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, Employer matching contributions, as well as allocations of the Employer’s discretionary nonelective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in all contributions to their account balance plus actual earnings thereon.

**Notes from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant’s account and bear interest at 1 percent above the prime rate, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

**Payments of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. In the case of death, lump-sum or installment payments can be made to the participant's beneficiary (over a period not to exceed the life expectancy of the beneficiary). For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Benefits are recorded when paid.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Basis of Accounting**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts [FBRICs]). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

**Notes from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the Plan Administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to benefit payments and to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level I inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level II inputs consist of observable inputs other than quoted prices for identical assets (Level I); Level III inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level I inputs because they generally provide the most reliable evidence of fair value. Level II inputs are used for investments for which Level I inputs were not available. Level III inputs would only be used if Level I or Level II inputs were not available. There are no plan assets requiring the use of Level III inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Mutual funds held in pooled separate accounts:* Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

*Non-benefit-responsive guaranteed interest account:* Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

**NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, fully benefit-responsive investment controls, and notes receivable from participants and related accrued interests, held at December 31, 2024 and 2023, as well as net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Trust Company of Toledo for \$24,120,322, Empower Annuity Insurance Company of America and Empower Trust Company, LLC., for \$2,534,070, the Custodians of the Plan.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (FBRICS)**

The Plan maintains investment options in two guaranteed interest contracts with Empower Annuity Insurance Company of America ("Empower"). The Empower Guarantee Certificate Fund is considered to be non benefit-responsive and therefore is reported at fair value (see Note 3).

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (FBRICS) (Continued)**

The Empower Daily Interest Guarantee Fund is considered to be a fully benefit-responsive investment contract (FBRIC) that invests in a traditional investment contract. Empower maintains the contributions in general accounts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan (4.00 percent in 2023 and 2024). The FBRIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower including plan termination and other events as specified in the FBRIC. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The FBRIC does not permit Empower to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Trust Company of Toledo, Empower Annuity Insurance Company of America, and Empower Trust Company, LLC., the Custodians, or their affiliates. These transactions qualify as party-in-interest transactions. Fees for investment management services during the plan year ended December 31, 2024, were included in administrative expenses. The Plan made direct payments to the Custodians of \$65,680. The Employer pays directly any other fees related to the Plan's operations. The Company also paid audit expenses for the Plan, which totaled \$9,200.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**NOTE 8 – TAX STATUS**

The IRS has previously determined and informed EPIC Advisors Inc. (the third-party administrator) that the prototype plan is designed in accordance with the applicable sections of the IRC.

Management of the Plan is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
