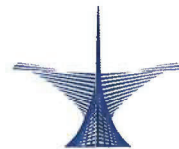

## Independent Auditor's Report

To the Plan Administrator

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Milwaukee Art Museum, Inc. Employees' Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Milwaukee Art Museum, Inc. Employees' Retirement Income Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a participant-directed contribution plan sponsored by a not-for-profit organization, commonly known as an Internal Revenue Code (IRC) Section 403(b) savings plan. Milwaukee Art Museum, Inc. is the sponsor (the Sponsor). Reliance Trust Company (Reliance) and TIAA-CREF are the Custodians of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, as well as allowing long-term, part-time workers who work between 500 and 1,000 hours in a year to participate in the Plan effective January 1, 2024. Management is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Eligibility

Substantially all employees of the Sponsor are eligible to participate in the Plan. To be eligible to receive matching Sponsor contributions, participants must complete one year of service, have completed 1,000 hours of service, and not be a security guard employee of the Sponsor.

#### Contributions

Each year, participants may contribute between 1% and 100% of compensation of annual compensation through pre-tax and after-tax roth contributions, as defined in the Plan, not to exceed the annual maximum allowed by the Internal Revenue Service. Participants may also contribute amounts from other qualified plans (rollovers).

The Sponsor may make a discretionary matching contribution, not to exceed 7% of participant's eligible compensation. In 2024 and 2023, the Sponsor's discretionary contribution was 3% of participant's eligible compensation. The Sponsor may make a nonelective discretionary contribution to the Plan. No Sponsor nonelective contributions were made in 2024 and 2023.

## Note 1: Description of Plan (Continued)

### Funding

The Sponsor remits participant elective contributions as soon as practical after the participant contributions have been withheld from the participant wages. Sponsor matching and nonelective contributions, if any, are remitted annually.

### Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contributions, and earnings (losses) thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Sponsor discretionary matching and nonelective discretionary contribution portion of participant's account is based on the number of years of service as shown by the following schedule:

A participant's accrued benefit is 100% vested upon a participant's death, total disability, or attainment of normal retirement age of 65.

### Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested in the Sponsor contributions. Forfeited nonvested accounts are used to offset Plan expenses or reduce future discretionary Sponsor contributions. The Plan used forfeitures to pay plan expenses of \$4,242 in 2024 and \$1,858 in 2023. Unallocated forfeitures as of December 31, 2024 and 2023 were \$0 for both years.

## **Note 1: Description of Plan (Continued)**

### **Investment Options**

Participants direct how their individual account is invested into one or a combination of investment choices which cover a wide range of fund objectives and risks. For a more complete description of the Plan's investments, participants should refer to the investment prospectuses.

### **Notes Receivable from Participants**

Participants may borrow from their Reliance participant accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. The maximum term of any note is ten years. The notes are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions. Interest rates on notes receivable outstanding at December 31, 2024 range from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator.

### **Payment of Benefits**

Benefits are paid to the participant or beneficiary upon death, disability, hardship, retirement, or termination of employment, up to the amount of the participant's vested interest in their account. Benefits may be paid in a lump sum distribution or installment distribution. Preretirement distributions may be made to participants who have not terminated employment and have attained age 59 1/2.

## **Note 2: Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and the benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Administrative fees of Reliance and fees for the administration of notes receivable from participants are charged directly to the participant's account and are classified as administrative expenses. Investment expenses are included in net appreciation in fair value of investments. Other expenses are paid by the Sponsor and are not included in these financial statements.

### **Subsequent Events**

The Sponsor has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Annuity Contract:* The annuity contract is not available for sale or transfer. Accordingly, fair value is not observable and the issuer of the annuity contract, Teachers Insurance and Annuity Association of America (TIAA), values the investments based on accumulated cash contributions, interest credited to the contract, transfers, and withdrawals.

*Mutual funds held in pooled separate accounts:* Fair value is estimated using the NAV per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)**

The Plan invests in a FBRIC with TIAA in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. Additional amounts, when declared, remain in effect through the end of the declaration year which begins each March 1 for accumulating annuities and January 1 for payout annuities.

Certain events limit the Plan's ability to transact at contract value with TIAA including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

The Plan also invests in a FBRIC with Standard Insurance Company. The FBRIC provides a guarantee of principal and interest which is guaranteed by the general account assets of Standard Insurance Company. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate is set using a process determined by the issuer, but it may not be less than 1%. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The issuer may terminate the contract with 30 days advance notice for reasonable cause which could result in a market value adjustment.

### **Note 5: Information Prepared and Certified by the Custodians**

The Plan Administrator has elected the method of compliance permitted by 29 CFE 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including cash, investments, notes receivable from participants, and the FBRICs held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained and derived from information certified as complete and accurate by the Custodians of the Plan.

## Note 6: Party-In-Interest

Certain investments are managed by affiliates of the Custodians. These transactions, notes receivable from participants, and administrative expenses qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations.

## Note 7: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

## Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## Note 9: Tax Status

The Sponsor adopted a volume submitter plan which is based on a pre-approved plan document to be in compliance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, no provision for income tax has been included in the Plan's financial statements.
