We have performed audits of the accompanying financial statements (modified cash basis) of Knight Piesold and Co. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. Description of Plan

The following description of Knight Piesold and Co. 401(k) Retirement Plan (the “Plan”), provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 1989. An employee becomes eligible to make elective contributions upon completion of two months of service with the exception of non-resident aliens. An employee becomes eligible to receive Employer matching contributions upon enrollment in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The management team of Knight Piesold and Co. (the “Company”) is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the management team of the Company.

The Company administers the Plan. Standard Insurance Company (“Standard”) serves as custodian of the Plan. Standard offers Plan participants a variety of investment options through various pooled separate accounts and a deposit administration contract. Individual accounts are invested in the various investment options at the direction of the participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan should be terminated or partially terminated, or should Company contributions be permanently discontinued for any reason, all amounts allocated to the account of a Plan participant, or their beneficiary, shall become fully vested and be payable to the Plan participant, or their beneficiary, and shall be distributed in a lump sum.

Contributions

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they elect not to participate, with a default rate set at 6% of eligible compensation. Participants can make pre-tax or after-tax (Roth) contributions from their annual compensation, subject to statutory dollar limitations. The maximum contribution allowed in 2024 was \$23,000 (\$30,500 for participants whose age was 50 or over by the end of 2024). Employees may also elect to contribute amounts representing distributions from other qualified plans. Employee contributions to the Plan are made through regular payroll deductions. The Company may make discretionary matching contributions and has elected to contribute a percentage equal to 50% of elective deferrals up to 6% of compensation for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's matching contribution and Plan earnings. Participants who are subject to limitations on individual contributions, due to their level of pay in relation to that of the other participants, share in Company contributions to the extent of their contribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their voluntary contributions and allocated earnings or losses thereon.

Any employer contributions (including forfeitures) and the earnings or losses thereon will vest as follows:

A participant's account becomes 100% vested upon death, attaining normal retirement age, disability, or if the Plan is terminated, partially or in full, or if Company contributions cease.

Participant Loans

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.50% to 8.50% at December 31, 2024 and 2023, which are commensurate with local prevailing rates at loan initiation, as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payments of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, or annual installments over a period not to exceed the assumed life expectancy of the participant or the beneficiary. For termination of service for other reasons, a participant may receive the value of the vested account balance as a lump-sum distribution.

A participant may apply for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant or their dependents, medical expenses to the extent not otherwise reimbursed under the Company's medical programs, expenses for the purchase of a principal residence or major alteration thereto, to prevent eviction from or foreclosure on a principal residence and to pay for funeral or burial expenses or immediate and heavy financial need as determined based on Internal Revenue Service Regulations.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are first used to reduce Plan expenses with any remaining balances used to reduce future employer contributions. The balance in the forfeiture account at December 31, 2023 was \$9,483. For the year ended December 31, 2024, participant forfeitures were \$24,214. Of the total forfeitures, \$32,294 was used to reduce employer contributions. The balance in the forfeiture account at December 31, 2024 was \$1,403.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). Contributions and investment income are recognized when received and expenses are recognized when paid, except for certain investments and their related gains or losses, which are reflected at fair value. Management has determined that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with US GAAP.

Use of Estimates

The preparation of financial statements requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

The fair value of the Plan's pooled separate accounts is reported in the accompanying statements of net assets available for benefits based on level 2 inputs.

Following is a description of the valuation methodologies used for the Plan's investments:

Pooled separate accounts: Valued at the closing price reported on the active market on which the individual securities of the pool are traded. Securities in the active market are adjusted for internal fees and pooled into an adjusted market price.

Deposit administration contract: Valued at contract value by utilizing crediting rates using a process similar to that used by banks and other insurance companies for similar products. The crediting rate takes into account yield forecasts and required margins. The crediting rate is declared in advance and reset quarterly.

Contract value is the relevant measurement attribute for that portion of the net assets of an investment company attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined contribution plans.

Income Recognition

Purchases and sales of securities are recorded on the trade date basis, with realized and unrealized gains and losses calculated on a moving average basis. Interest and dividend income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are measured at their outstanding principal amounts plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is July 18, 2025.

3. Information Certified by the Custodian (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends on investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard, the custodian of the Plan and, a qualified institution.

4. Deposit Administration Contract

The Plan maintains a deposit administration contract (“DA”) with the Standard Insurance Company. The DA provides a guarantee of both principal and accrued interest from the Standard Insurance Company. Standard guarantees that the account’s credited rate will never be less than 1% regardless of market conditions. The crediting rate as of December 31, 2024 and 2023 was 2.18% and 1.87%, respectively. The deposit administration contract balance represents 7.9% and 8.2% of net assets available for benefits at December 31, 2024 and 2023, respectively.

The principal and previously credited interest rate is guaranteed by Standard Insurance Company. The credit risk of the issuer was evaluated by nationally recognized statistical rating agency of Standard and Poor’s (A+ as of September 2024).

Certain events may limit the ability of the plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The custodian believes that the occurrence of each of these events is not probable of occurring at this time.

5. Party-in-Interest Transactions

All investments of the Plan are managed by Standard, the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA and are reflected in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Tax Status

The prototype plan document preparer has received a favorable opinion letter dated June 30, 2020, from the IRS regarding the Plan's compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code ("IRC"). Management believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC.

The Plan recognizes the effect of income tax positions only if those positions are more likely-than-not to be sustained upon examination by the taxing authorities.

As of December 31, 2024, the Plan has determined that it has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. As of December 31, 2024, tax years for all years since December 31, 2021 remain open to examination by the Internal Revenue Service.
