## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator and Participants of the  
American Fuji Seal, Inc. Union 401(K) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of American Fuji Seal, Inc. Union 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American Fuji Seal, Inc. ### 1. DESCRIPTION OF THE PLAN

The following description of the American Fuji Seal, Inc. Union 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

**General** - The Plan covers all employees of the Company which are in the union. The Plan is a defined contribution plan under which employees contribute and American Fuji Seal, Inc. (the “Company” or “Plan Sponsor”) contributes a matching amount, pursuant to the Plan. The Standard Insurance Company (the “Custodian” or “Standard”) is the custodian of the Plan’s assets. An employee of the Company serves as the trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** - Each year, employees who are eligible and elect to participate in the Plan may contribute through payroll deductions up to 100% of their pre-tax income within the limit of the statutory maximum percentage of eligible compensation allowable under the Internal Revenue Code (“IRC”). In accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible employees may make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Reconciliation Relief Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024.

The Company matches the Plan’s employee participants’ contributions up to 5% of gross wages.

**Participant Accounts** - A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution; any Company contributions, an allocation of Plan earnings or losses and charged with an allocation of any administrative expenses paid by the Plan. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Allocations of expenses are based upon account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Rollovers** - Rollover contributions are permitted into the Plan in accordance with the applicable income tax regulations and Plan provisions.

**Investment Options** - Upon enrollment in the Plan, a participant may direct employee contributions in increments among several investment options. Participants may change their investment options on any normal business day.

**Notes Receivable from Participants** - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance from their accounts. Loan terms range from 1-5 years unless used for the purchase of the participant’s principal residence (for which the administrator may permit a longer repayment term). The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Notes receivable outstanding have interest rates ranging from 3.25% to 8.50% and have maturity dates ranging through September 2029. Principal and interest are paid ratably through monthly payroll deductions. Each participant loan, which is subject to committee review, complies with terms and conditions prescribed by federal legislation.

### 1. DESCRIPTION OF THE PLAN (continued)

**Payment of Benefits** - On termination of services due to resignation, a participant receives the value of the vested account balance as of the most recent valuation date. For termination of services due to retirement, total and permanent disability, or death, the participant receives the value of the account balance as of the valuation date.

**Vesting** - Participants are 100% vested immediately in their contributions, including employer matching contributions and rollover contributions.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Estimates** - The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Valuation of Investment and Income Recognition** - Investments are reported at fair value, except fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for the descriptions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date and interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan agreement.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net depreciation of fair value of investments.

**Payment of Benefits** - Benefit payments to participants are recorded when paid.

### 3. INFORMATION CERTIFIED BY THE STANDARD INSURANCE COMPANY (UNAUDITED)

The Plan Administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Standard, except for comparing such information certified by the custodian with information included in the Plan's financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Item 4i – Schedule of Assets (Held At End of Year).

### 4. GUARANTEED INVESTMENT CONTRACT

The Standard Stable Asset Fund II ("Fund") is a group annuity contract that offers a full guarantee on principal and interest by the Standard Insurance Company ("Issuer"). The contracts are fully benefit responsive.

The fund qualifies as a fully benefit-responsive investment contract because it meets all of the following criteria:

1. The investment contract is effected directly between the Fund and the Issuer and prohibits the Fund from assigning or selling the contract of proceeds to another party without the consent of the Issuer.
2. The contract Issuer is obligated to (i) repay principal and interest, or (ii) apply prospective crediting rate adjustments with an assurance the crediting rate will not be less than zero.
3. The term of the investment contract require all permitted participant-initiated transactions with the Fund to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those transactions allowed by the underlying defined-contribution plan, such as withdrawals for benefits, loans or transfers to other funds within the Plan.
4. An event that limits the ability of the Fund to transact at contract value with the Issuer (for example, premature termination of the contracts by the Fund, plant closings, plan terminations, bankruptcy, mergers and early retirement incentives) and that also limits the ability of the Fund to transact at contract value with the participants in the Fund must be probable of not occurring.
5. The Fund itself must allow participants reasonable access to their funds.

### 4. GUARANTEED INVESTMENT CONTRACT (continued)

Investment contracts held in the Fund are recorded at contract value. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Contract value represents deposits made to the contract, plus earnings guaranteed crediting rates, less withdrawals and fees.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of contract, spin-offs, divestitures, layoffs, corporate relocations, partial or total termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The Issuer may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, including the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, layoffs, Plan disqualification or failure to adopt the Plan in a reasonable period of time. Upon termination by the Issuer, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The Plan Sponsor was not aware of any events that would have limited the Plan to transact at contract value at December 31, 2024 and through the date of the auditors' report.

The contract crediting rate is established at the end of each quarter and is guaranteed for five years. The effective annual crediting rate and yield for the Contract was approximately 2.06% and 1.86% for the years ended December 31, 2024 and 2023, respectively.

### 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled Separate Accounts:** The Plan has investments in participation units held in pooled separate accounts through sub-accounts of an insurance company. The net asset value ("NAV") is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The underlying securities in other pooled separate accounts are listed on national securities exchanges and valued on the basis of year end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. There are notices on redemption.

### 6. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Plan investments are managed by The Standard Insurance Company. Standard is the custodian of the Plan. Loans to the participants are secured by balances in the respective participant accounts. These transactions qualify as party-in-interest transactions and are exempt from prohibited transaction rules. Administrative fees paid by the Plan totaled \$41,625 for the year ended December 31, 2024.

### 7. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the right to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

### 8. PROHIBITED TRANSACTIONS

During the Plan year ended December 31, 2023, the Company was delinquent in remitting to the Plan certain employee contributions totaling \$283,373, within the time period prescribed by the DOL's regulations. Delays in remitting contributions to the Plan were due to administrative errors. The Company computed lost earnings on the December 31, 2023 deposits and made a contribution for the lost earnings to the Plan. The Plan sponsor takes full responsibility for any penalties and other potential issues associated with such untimely remittances.

### 9. FEDERAL INCOME TAX STATUS

The Plan's Administrator adopted a prototype non-standardized 401(k) profit sharing plan with cash or deferral arrangement, which received a favorable advisory letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan Administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities including pooled separate accounts and a guaranteed investment contract. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 11. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan Administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact to the Plan's 2024 financial statement.

### 12. SUBSEQUENT EVENTS

The Plan’s management evaluated subsequent events through September 23, 2025, the date on which the financial statements were available to be issued. Based upon that evaluation, the Plan’s management has determined that no subsequent events have occurred which would require disclosure in or adjustment to the financial statement.

### 13. RECONCILIATION TO FORM 5500

No material differences exist between the financial statements and Form 5500.
