## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and Participants of the  
Weissman PC 401(k) and Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the financial statements of the Weissman PC 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

### 1. Description of Plan

The following description of the Weissman PC 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Weissman PC (the Company or Plan Sponsor). Employees are eligible to participate in the Plan on the first day of each quarter coinciding with or following the date after attaining the age of 18 and completing six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Eligible employees are automatically enrolled into the Plan, and pre-tax participant contributions are withheld at 5% of eligible compensation unless the employee elects differently. The Plan allows for an annual 1% automatic increase of participant pre-tax contributions up to a maximum of 8%. Each participant may elect to make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of \$7,500 for those participants who are at least 50 years of age before the close of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may also make discretionary matching and non-elective contributions to the Plan. For the discretionary matching contributions, participants must attain age 18 and complete six months of service. During 2024, the Company provided discretionary matching contributions equal to 100% of participant contributions up to 1% of eligible compensation. For the discretionary non-elective contributions, participants must attain age 21 and be employed as of the last day of the Plan year with at least 1,000 hours of service. The Company did not make any discretionary non-elective contributions in 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any Company contributions, investment earnings and losses, and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. The Plan also offers a self-directed brokerage account as an additional investment option for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus earnings thereon. Vesting in Company contributions is based on years of continuous service. Participants vest 20% per year in Company discretionary matching and non-elective contributions and are fully vested after five years of service. All amounts become fully vested upon the participant's attainment of normal retirement age, disability, or death.

### **Forfeited Accounts**

Forfeited non-vested accounts totaled \$660 and \$440 at December 31, 2024 and 2023, respectively. Forfeitures may be used to reduce Company discretionary matching contributions. During 2024, forfeitures of \$1,808 were used to reduce Company discretionary matching contributions.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. The notes are secured by the balance in the participant's account and bear interest at a rate of Prime + 1%. During 2024, notes had rates ranging from 4.25% to 9.50%. Notes must be repaid in 5 years unless used for the purchase of a primary residence, in which case the term may be up to 10 years. Participants may have two notes outstanding at any time. Principal and interest are paid through payroll deductions.

### **Payment of Benefits**

On termination of service due to death, disability, termination of employment or retirement, a participant or their beneficiary may receive payment of the vested interest in their account in the form of a lump-sum or installment distribution. In-service withdrawals are also permitted for participants who have attained age 59½. If a participant terminates employment and has an account balance between \$1,000 and \$5,000 for which no distribution request has been made, the balance will be rolled into an individual retirement account in the participant's name. If a participant terminates employment and has an account balance less than \$1,000, the participant will automatically receive a lump-sum distribution. Participants are eligible to receive hardship withdrawals when certain conditions are met.

### **Administrative Expenses**

Certain transaction fees for distributions and loans are charged directly to the participants. Administrative expenses also include recordkeeping fees, investment management fees, and advisory fees, which are deducted from participant accounts as defined by the Plan document. value or contract value of the investments. The Company pays all other administrative expenses of the Plan and provides certain accounting and administrative services to the Plan. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company's discretionary matching contributions are considered payable to the Plan when approved by the Company and when the related participant's contributions are payable to the Plan. The Company discretionary non-elective contribution is considered payable to the Plan when approved to be paid by the Company.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed interest account which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value and contract value of investments includes realized and unrealized gains and losses on investments, interest, and dividends. Interest income is recorded when received.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced

and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by the Qualified Institutions**

All investment information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, net change in fair value and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower), the Plan's qualified institutions.

### **4. Investments**

Plan investments include a guaranteed interest account (GIA), which is managed by Empower. Empower is a service provider to the Plan; therefore, transactions in this investment qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value or contract value of investments, as they are paid through revenue sharing rather than a direct payment.

Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to

unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other significant observable inputs, including quoted prices in active markets for similar securities

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in the self-directed brokerage accounts include common stock, exchange-traded funds, money market funds, and mutual funds and are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a GIA which is a general obligation of Empower. The GIA is valued at contract value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The investment contract is backed by the general account of the issuer. The Plan makes deposits with the issuer and receives a guaranteed interest rate for the specified time. Interest is accrued on a fully compounded basis and paid either periodically or at the end of the contract term. The issuer guarantees that all qualified participant withdrawals will occur at contract value (principal plus accrued interest). The methodology for calculating the interest crediting rate is based on earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The weighted average crediting interest earned by the contract for the years ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively. Empower considers the contract to be fully benefit responsive for participant-initiated transactions and is stated at contract value. Investment income of this contract is presented on a contract basis. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any.

### 5. Income Tax Status

The Plan uses a non-standardized prototype plan document sponsored by Empower Retirement LLC (Empower Retirement), an affiliate of Empower. Empower Retirement received an opinion letter from the Internal Revenue Service, dated November 14, 2022, which states that the prototype document designed satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not received an individual determination letter and has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
