Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental Schedule H, Line 4i – Schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A -- Description of plan and significant accounting policies**

The following brief description of Smart Motors, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Smart Motors, Inc. (the "company" or "employer") has adopted the National Administration, Inc. Pre-Approved Defined Contribution Plan effective January 1, 2022. The Plan was originally effective on January 1, 1993.

**General**

The Plan was established to provide retirement benefits to eligible employees of the employer. The Plan is a defined contribution profit sharing plan with elective deferral 401(k) features covering all non-union and non-leased employees of the employer who have completed 60 days of service. Participants may enter the Plan the first day of month immediately following the date the participant completes the eligibility conditions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Representatives of the Plan Administrator determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Plan's federal identification number is 39-0977617, and the Plan's number is 002.

**Contributions**

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. The Plan includes an automatic enrollment provision which will automatically defer 3% of the participant's eligible compensation. Participants may opt out of the automatic enrollment provision or select an alternative deferral amount at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The employer may make a discretionary matching contribution. Discretionary matching contributions are calculated at 50% of the participant's deferral up to \$1,000. The employer may also make a discretionary non-elective contribution which is allocated pro-rata based on compensation. There were no discretionary matching or non-elective contributions made during 2024. To be eligible for the matching contributions, the participant must be employed on the last day of the Plan year and have completed 60 days of service or more. To be eligible for the non-elective contributions, the participant must in addition work 1,000 hours in a Plan year and be employed on the last day of the Plan year. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

**Contributions receivable**

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the company.

#### Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s discretionary contributions, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of employer contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the rollover of funds from other qualified plans to a participant’s account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested ratably over 4 years of credited service, which is defined as completing at least 1,000 hours of service during a Plan year.

#### Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$4,639, respectively. These accounts will be used to pay Plan expenses, reduce employer contributions, or reallocated to participants in the same manner as company contributions. A total of \$5,175 was used to reduce 2024 plan expenses.

#### Benefits

On termination of service due to death, disability, retirement (age 65) or termination of service due to other reasons, a participant may elect a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In-service distributions are permitted for participants over age 59 ½ that are 100% vested with a minimum of \$1,000. If a participant’s vested account balance is less than \$5,000, a participant will receive a mandatory distribution of the value of the vested interest in his or her account as a lump-sum payment immediately following severance from employment. For account balances greater than \$5,000, a participant may elect a lump-sum distribution or elect to roll over the distribution to another qualified plan. In addition, hardship distributions are permitted if certain criteria are met.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at the prime rate at the date of issuance (7.50% at December 31, 2024) plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

A summary of significant accounting policies follows:

#### Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits or a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

**Cash**

The Plan maintains its cash in bank deposit accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Management believes it is not exposed to any significant credit risk on cash.

**Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Representatives of the Plan Administrator determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

The employer pays some of the administrative expenses of the Plan which are excluded from these financial statements. The major administrative expenses are trustee and withdrawal fees.

**Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

**Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and adjustment to net appreciation in fair value of investments. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

**Subsequent events**

These financial statements have not been updated for subsequent events occurring after September 23, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

**NOTE B -- Information certified by the asset custodians**

Certain information related to cash, investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including cash, investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company, FSB (Nationwide), and Nationwide Life Insurance Company (NLIC), an affiliate of Nationwide, the asset custodians of the Plan.

**NOTE C -- Party-in-interest transactions**

Certain Plan investments were managed by Nationwide and NLIC (the providers) during the year ended December 31, 2024. The providers were the asset custodians and recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Fees were also paid by the plan during the year for advisory and administrative services rendered by ProAccount and Definiti LLC, respectively. Definiti LLC has a basis point charge on the Plan's contract. The basis point charge is charged to the participant accounts and is paid to Definiti LLC. In turn, Definiti LLC offsets the quarterly invoices sent to the plan sponsor by the amount they received from Nationwide as a result of the basis point charge. The total amount charged and paid to Definiti LLC during 2024 was \$7,573. This amount reduced the fees paid directly by the plan sponsor outside of the Plan. These transactions also qualify as party in interest transactions.

**NOTE D -- Guaranteed investment contracts with insurance companies**

The Plan entered into a traditional fully benefit-responsive investment contract with NLIC. NLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by NLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, was \$281,295 and \$797,527, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

There are no events that allow the issuer to terminate the NLIC contract and which require the plan sponsor to settle at an amount different than contract value. There are also no events that could limit the ability of the Plan to transact at contract value for the NLIC contract. The NLIC contract does not have a maturity date.

### NOTE E -- Fair value measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- Collective investment trust funds. A fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits (in liquidation) for the year ended December 31, 2024, are reported in net appreciation in fair value of investments. Unrealized gains (losses) from the guaranteed investment contracts are not reported in the statement of changes in net assets available for benefits as the contract is recorded at contract value for presentation in the net assets available for benefits.

### NOTE F -- Tax status

The National Administration, Inc. Pre-Approved Defined Contribution Plan, referred to in Note A, that the Plan has adopted effective January 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for us by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### NOTE G -- Plan termination

The Board of Directors of the Plan sponsor approved a plan of liquidation during 2023, and management determined liquidation is imminent. The effective date of Plan termination was December 31, 2023, and no further contributions to the Plan were made after this date. Final distributions will be determined based on all participants being 100% vested and will be made as soon as possible after the termination date. As a result, the 2024 and 2023 financial statements are presented under the liquidation basis of accounting.

### NOTE H -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that those changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits (in liquidation and ongoing, respectively).

### **NOTE J -- Excess contributions payable**

The Plan failed the discrimination test for the year ended December 31, 2023. Excess contributions amounting to \$335 are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits. The Plan has reimbursed these excess contributions to its participants prior to March 15, 2024. For purposes of the Form 5500, these excess contributions are not recorded until the year paid.

### **NOTE K -- Plan amendments**

On May 18, 2023, the Plan was retroactively amended to remove the minimum age requirement to participate in the Plan effective January 1, 2022.

Effective December 31, 2023, a termination amendment was entered into to formally terminate the Plan, as well as adopt provisions to bring the Plan in compliance with the qualification requirements applicable to the Plan (see Note G).
