## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of the Columbia Grain Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established for the benefit of eligible employees of Columbia Grain International, LLC (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). T. Rowe Price Trust Company (the Trustee) is the appointed trustee and custodian of the Plan's assets. The Plan is administered by the Administrative Committee, whose members are employees of the Employer. Participants may direct their contributions and account balances into various investment options offered by the Plan.

#### **Eligibility**

Employees – other than those who are union employees, non-resident aliens, residents of Puerto Rico, leased employees, or on-call employees – are eligible to participate in the Plan on the first day of the month following the date of hire.

#### **Contributions**

The Plan includes a salary deferral provision which provides for both pretax contributions and after-tax Roth 401(k) contributions. Participants may elect to defer between 1% and 100% of their eligible compensation, subject to current Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 6% of their eligible compensation, and such contributions are invested in a designated balanced fund until changed by the participant. As of July 1 of each subsequent year, the deferral rate for each automatically enrolled participant automatically increases by 2%. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e., rollover contributions).

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

The Employer may elect to make matching contributions to the Plan. During the years ended December 31, 2024 and 2023, the Employer matched 50% of each participant's contributions. In addition, the Employer may make a discretionary Qualified Non-Elective Contribution (QNEC). A discretionary QNEC, if any, would be allocated to each participant's account on a proportionate basis of eligible compensation for the plan year. Discretionary QNECs made by the Employer were insignificant for the year ended December 31, 2024. The Employer did not make a discretionary QNEC during the year ended December 31, 2023.

### Participant Accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of (a) the Employer's contributions, (b) plan earnings (losses), and (c) administrative expenses. Earnings (losses) for each investment fund are allocated to participants' accounts based on the individual participant's account balance as compared with the total balance of the related investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in their voluntary salary contributions, rollover contributions, discretionary QNEC, and the actual earnings (losses) thereon. Vesting in employer matching contributions is based on years of service as follows:

In addition, upon death, disability, or retirement at age 65 or older, participants will immediately become 100% vested in their share of the Employer's matching contributions and the actual earnings (losses) thereon.

### 1. Description of the Plan (continued)

#### Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts were approximately \$171,000 and \$59,000, respectively. At the Employer's discretion, forfeited accounts may be used to reduce future employer contributions and/or to pay plan expenses. During the years ended December 31, 2024 and 2023, employer contributions were reduced by forfeitures of approximately \$38,000 and \$23,000, respectively.

#### Notes Receivable From Participants

Participants may elect to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding participant note receivable balance in the preceding one-year period, and may only have one outstanding loan. Notes receivable from participants are secured by the balances in the respective participants' accounts. Terms of notes receivable from participants range from one to five years, unless used to acquire the participant's principal residence, in which case the term may be extended up to 10 years. Loan repayments are generally paid through payroll deductions. The notes receivable from participants bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Interest rates on notes receivable from participants outstanding as of December 31, 2024, ranged from 4.25% to 9.50%.

#### Benefits

On termination of service due to death, disability, or retirement, a participant (or his or her beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time. For termination of service for other reasons, distributions of vested balances less than or equal to \$1,000 are made in a lump sum. If the terminated participant's vested balance exceeds \$1,000 but is less than \$5,000, and the participant does not elect to receive a distribution, the Plan permits the plan administrator to make a distribution directly to an individual retirement account set up on the participant's behalf. For vested balances greater than or equal to \$5,000, the Plan permits a participant to elect distribution by lump-sum or substantially equal installments over a specified period of time. Upon reaching age 59½, participants may make in-service withdrawals of part or all of their vested balances, including the related earnings (losses).

### **1. Description of the Plan (continued)**

#### **Hardship Withdrawals**

Participants who are still employed by the Employer are permitted to take withdrawals from their accounts under certain financial hardship conditions, as described in the plan document.

#### **Administrative Expenses**

At the Employer's discretion, administrative expenses of the Plan may be paid directly by the Employer; certain other administrative expenses may be paid by the Plan. Expenses that are paid by the Employer are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the related participants' accounts and are included in administrative expenses on the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are offset against net appreciation (or included in net depreciation) in fair value of investments on the accompanying statements of changes in net assets available for benefits.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management of the Plan (Management) to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's Trustee. See Note 4 for discussion of fair value measurements.

#### **Investment Income Recognition**

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through September 26, 2025, which is the date that the accompanying financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the years then ended, was obtained by Management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

### 4. Fair Value Measurements

GAAP defines fair value, establishes a framework for measuring fair value, and requires certain disclosures about fair value measurements. The hierarchy of fair value valuation techniques under GAAP provides for three levels: Level 1 provides the most reliable measure of fair value, whereas Level 3, if applicable, generally would require significant management judgment. The three levels for categorizing assets and liabilities under GAAP's fair value measurement requirements are as follows:

- Level 1: Fair value of the asset or liability is determined using unadjusted quoted prices in active markets (that the Plan has the ability to access) for identical assets or liabilities.
- Level 2: Fair value of the asset or liability is determined using inputs other than quoted prices that are observable for the applicable asset or liability, either directly or indirectly, such as quoted prices for similar (as opposed to identical) assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active.
- Level 3: Fair value of the asset or liability is determined using unobservable inputs that are significant to the fair value measurement and reflect the Plan's own assumptions regarding the applicable asset or liability.

An asset's or a liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

*Mutual funds* – The fair value of mutual funds is based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 4. Fair Value Measurements (continued)

*Common collective trusts (CCTs)* – The fair value of the CCTs is determined using the NAV as a practical expedient to estimate fair value. The CCTs consist of investments in the T. Rowe Price Stable Value Common Trust Fund and the T. Rowe Price Equity Index Trust Fund. The T. Rowe Price Stable Value Common Trust Fund is primarily invested in investment contracts and is valued based on information reported by the investment advisor using the audited financial statements of the T. Rowe Stable Value Common Trust Fund at year-end. The T. Rowe Price Equity Index Trust Fund is valued based on the NAV of shares held by the Plan at year-end, which are determined based on the quoted pricing units of the underlying investments.

The methods above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes that the valuation methods used by the Plan are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements as of the reporting date.

### **5. Related-Party Transactions**

Certain of the Plan's investments are invested in funds offered by the Trustee. Therefore, transactions involving these investments qualify as party in interest.

The Employer is the sponsor of the Plan and paid certain administrative expenses of the Plan during the years ended December 31, 2024 and 2023. In addition, the plan administrator is a participant in the Plan.

The Trustee provides certain administrative services to the Plan pursuant to a record-keeping agreement between the Employer and the Trustee. The Trustee receives revenue from mutual fund and collective trust fund service providers for services that the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

### **7. Tax Status**

The Plan has adopted a volume submitter defined contribution retirement plan (the Volume Submitter Plan) developed by T. Rowe Price Retirement Plan Services, Inc. The Internal Revenue Service (IRS) has determined and informed T. Rowe Price Retirement Plan Services, Inc. by a letter dated August 19, 2020, that the Volume Submitter Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended and then restated since T. Rowe Price Retirement Plan Services, Inc. received the determination letter, the plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken

that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment instruments that are exposed to certain risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements and supplemental schedule.
