The following description of the BCS Financial Corporation Tax-Favored Savings Program (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**(a) General**

The Plan is sponsored by BCS Financial Corporation (the “Company”). The Plan was established under the master trust agreement between National Employee Benefits Committee of Blue Cross Blue Shield Association (“Plan Administrator”) and Fidelity Management Trust Company (“Fidelity” or “Trustee”) (“Related Trust”). The Plan is a defined-contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Participation in the Plan is limited to employees of the Company on the later of the date of hire or age 21. The Board of Directors is responsible for the oversight of the Plan. Fidelity serves as the Plan’s trustee and custodian. The Plan was restated effective June 30, 2021. There were no material changes as a result of this restatement.

**(b) Contributions**

Participant contributions are made by means of regular payroll deductions. Participants may elect to make contributions from 1% to 30% of their compensation, as defined by the Plan document. Participant contributions are limited to the maximum amount allowed by the Internal Revenue Code (“IRC”) (the “Code”). Participants age 50 or older could make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into the various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in the age appropriate qualified default investment alternative, until changes are made by the participant. Beginning on February 21, 2023 participants will be enrolled in an annual increase program and their contribution rate will automatically increase by 1% up to a maximum of 15% each April, unless a participant elects otherwise.

The Company contributes an amount equal to 100% of the participant’s contribution, excluding catch-up contributions, up to the first 6% of eligible compensation for the year. Each year, the Company will announce whether a discretionary contribution will be made for the year and, if a contribution will be made for the year, the Company will indicate the amount it intends to contribute (as a percentage of each participant’s eligible earnings). During 2024, the Company made a discretionary contribution of 3% of each participant’s eligible 2024 earnings up to the IRS limit allowed for employer contributions.

**(c) Participant Accounts**

Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as an allocation of the Plan’s earnings and losses. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specified participants transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s

vested account.

**(d) Vesting**

Participants are immediately fully vested in their contributions and any employer matching contributions plus actual earnings thereon.

**(e) Notes Receivable from Participants**

Participants may borrow from their accounts. The loans are secured by the balance in the participant's account. Loan payments (principal and interest) are made by payroll deductions or directly to the Plan's Trustee, who records the repayment of outstanding loans.

Loan terms cannot exceed five years except for residential loans, which cannot exceed 30 years. The loan shall not exceed the lesser of \$50,000, reduced by the participant's highest outstanding loan balance in the last twelve months, or 50% of the sum of the participant's total vested balances at the time the loan is made less any outstanding loan balance.

Interest rates on participant loans are determined based on the prime rate published by Reuters on the last business day of the month plus 1% and applied to new loans beginning in the following month.

If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

**(f) Payment of Benefits**

No distributions from the Plan will be made until a participant retires, dies (in which case payment shall be made to his or her beneficiary or legal representatives), or otherwise terminates employment with the Company except for financial hardship, total and permanent disability or if a participant reaches the age of 59 ½. A special rule applies to active employees who attain age 73 (72 if that age is reached on or before December 31, 2022 or 70 ½ if that age is reached on or before December 31, 2029) and are in a certain classification of employees designated by the IRS as a "5%" owner and reach 73 (or 72 if you reached that age on or before December 31, 2022, or 70 ½ if you reached that age on or before December 31, 2019), those employees are required to receive a distribution of their entire account balance or minimum distributions while they are employed. Distributions are made only in cash and take the form of a lump-sum cash payment, unless the participant elects to receive payments in a series of semi-monthly, monthly, quarterly, semi-annual or annual installments.

**(g) Expenses**

The cost of administering the Plan may be paid from participant accounts or by the Company (Note 8).

**(2) Summary of Accounting Policies**

**(a) *Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**(b) *Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction with market participants at the measurement date.

Purchases and sales of investments are reflected on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) *Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(d) *Payment of Benefits***

Benefits are recorded when paid.

**(e) *Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance and any accrued but unpaid interest. Interest income is accrued. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**(3) Information Certified by the Plan Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following information in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024.

**(4) Fair Value Measurements**

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification Topic 820, *Fair Value Measurement*, established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

- Mutual funds – Valued at the net asset value (NAV) of shares held by the Plan at year-end. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common collective trusts and collective investment funds – Valued at the NAV of shares held by the Plan at year-end. These trusts and funds are required to publish their daily NAV and to transact at that price. The trusts and funds held by the Plan are deemed to be actively traded. The fund provides for daily redemptions of participant units at the end of each day. There are no redemption restrictions, provided that the Plan complies with the required one-year notice provision for Plan redemption, or the Plan may elect to withdraw units upon 10 days’ notice but may be subject to a redemption charge. Additionally, there are no underfunded commitments.
- Money market funds – Valued at NAV, which is targeted to \$1 and are actively traded.
- Self-directed brokerage accounts – registered investment companies are valued in the open market on a daily basis and interest-bearing cash is valued at the closing price reported on the active market in which the individual securities are traded.

**(5) Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants remain fully vested in their accounts, including employer contributions.

**(7) Tax Status**

The Plan has received a determination letter from the IRS dated January 15, 2015, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code, and therefore, the Related Trust is tax exempt. Subsequent to the effective date of the determination letter, the Plan was amended. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the Related Trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Related-Party Transactions and Party in Interest Transactions**

Certain of the Plan's investments are shares of mutual funds managed by Fidelity. Fidelity is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. There were no fees paid by the Plan for the investment management services for the year ended December 31, 2024. The agreement with Fidelity provides for a fixed cost model with a per-participant recordkeeping fee, offset by revenue credits.

Revenue credits are generated based on participants' investment choices and the underlying investments and whether the particular investments have a revenue sharing arrangement. The Plan may generate more recordkeeping revenue than their fixed pricing tier for a quarter. The excess amount will be deposited into a suspense account, from which the excess revenue can either be credited to the participants or used to pay ERISA eligible expenses.

The agreement resulted in fees of \$17,856, which is included within administrative and recordkeeping expenses on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
