We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Plan Description

The following description of Estwing Manufacturing Company Employees 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Estwing Manufacturing Company, Inc. (the Company), who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company's Fiduciary Committee. The Fiduciary Committee is responsible for operation and administration of the Plan. The Fiduciary Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions:** Participants may contribute a percentage of annual compensation, subject to certain limitations, as defined by the Plan, provided this will not cause the Plan to violate the provision of the 401(k) discrimination limits. A participant must elect to be enrolled on a pre-tax basis to defer and contribute to the Plan. Participants may contribute 1% to 60% of their eligible pre-tax annual compensation. Participants who have attained the age of 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes a non-discretionary match that is limited to 50% of the first 6% of base compensation that the participant contributes to the Plan. The Company may also make discretionary non-elective profit-sharing contributions for participants who either (1) provide 501 hours of service during the plan year or (2) are employed on the last day of the Plan year. The Company made \$1,259,527 and none in qualified discretionary contributions for the years ended December 31, 2024 and 2023, respectively.

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Company matching contributions and allocations of the Company's discretionary profit-sharing contributions, if any, and plan earnings/losses, and charged with certain administrative expenses. Allocations are based on participant account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their own contributions, including rollover contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant is 100% vested following six completed years of service. A participant is fully vested upon reaching early retirement age, death, or permanent disability. The interest of an employee shall vest and become non-forfeitable with the following vesting schedule:

**Investment options:** Upon enrollment in the Plan, a participant may direct employee and employer contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may transfer monies between funds and change their investment options daily.

**Payment of benefits:** Upon termination of service, death, total and permanent disability, or retirement, a participant or his or her beneficiary with \$1,000 or less in vested benefits will receive the value of the vested interest in their account as a lump-sum distribution. A participant with more than \$1,000 may elect to receive an amount equal to the value of the participant's account in the form of a lump-sum distribution or installment payments under various options, as described in the plan document. Under certain conditions of financial hardship, as defined in the plan document, participants may withdraw their vested account balances. Terminated participants with balances greater than \$1,000 and less than \$5,000 who make no distribution election will have their balances automatically rolled into a Fidelity IRA.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5 and \$4,600, respectively. Forfeitures may be used to pay administrative expenses or reduce the Company contributions. Forfeitures of approximately \$21,300 and \$43,500 were used by the Company to reduce Company matching contributions for the years ended December 31, 2024 and 2023, respectively.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the participant's highest outstanding loan balance during the prior 12 months. Participants may only have one note outstanding at a time. The notes are secured by the vested balance in the participant's account, and bear interest commensurate with prevailing interest rates charged by local lending institutions, as determined by the Plan Administrator. The period of repayment for the note shall not exceed five years except for loans to purchase a principal residence, for which the term shall not exceed 10 years. Principal and interest are paid ratably through payroll deductions.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements are presented on a cash basis of accounting modified to carry investments at fair value, whereas revenues are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded when received. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Use of estimates:** The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Administrative expenses are paid by the Plan. Certain other expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account.

**Subsequent events:** Plan management has evaluated subsequent events through September 26, 2025, the date on which the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Units of collective investment trust:** Units of collective investment trusts are valued based on the net asset value (NAV) per unit of the collective investment trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

**Shares of registered investment companies:** Shares of investment companies are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

For the years ended December 31, 2024 and 2023 there were no transfers in or out of Level 3.

There are no participant redemption restrictions for these investments. The redemption notice period is applicable only to the Plan.

#### **Note 5. Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

#### **Note 6. Related-Party and Party-In-Interest Transactions**

Certain plan investments are units of a collective investment trust managed by Fidelity Management Trust Company (Fidelity) and shares of registered investment companies managed by an affiliate company of Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fidelity and its affiliates also performed administrative and recordkeeping services for the Plan. Fees paid by the Plan for these services amounted to approximately \$200 and \$6,000 for the years ended December 31, 2024 and 2023, respectively.

Certain employees of the Company provided services to the Plan. These employees are not paid from the Plan for their services. In addition, certain administrative expenses of the Plan are paid by the Company on behalf of the Plan and are excluded from these financial statements.

#### **Note 7. Income Tax Status**

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, FMR LLC, has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
