Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lancaster-Burns Construction, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1: **Description of Plan**

The following description of the Lancaster-Burns Construction, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 2012, to provide eligible employees of Lancaster-Burns Construction, Inc. (the Company) with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (the IRC). Employees are eligible to participate in the Plan after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate on the enrollment date, which is defined as the date of hire.

Contributions

Employees become eligible to participate in the Plan immediately upon being hired by the Plan sponsor. Employees may elect to make tax deferred contributions to the Plan up to a limit of \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan sponsor will make qualified non-elective contributions pursuant to the Davis-Bacon Act and the California Labor Code. Qualified non-elective contributions, or prevailing wage contributions, are allocated to participants according to the applicable prevailing wage schedule determined by the Department of Industrial Relations. The Plan sponsor made qualified non-elective contributions of \$692,834 during the Plan year ended December 31, 2024.

The Plan sponsor may make matching and non-elective contributions based on a discretionary percentage allocated to participants as determined by the Plan sponsor. Participants must complete at least one (1) hour of service during the Plan year in order to receive an allocation of non-elective contributions. The Plan sponsor elected not to make any matching or non-elective contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant and employer contributions and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account.

Note 1: **Description of Plan (Continued)**

Vesting

Participants are always fully vested in the elective salary deferral contributions, qualified rollovers or transfers from other retirement plans, and qualified non-elective contributions. Participants vest in the employer matching and non-elective contributions as follows: 20% after two years of credited service, increasing by 20% for each year of service thereafter. After 6 years of service, participants are fully vested in the employer matching and non-elective contributions.

Forfeitures

Any forfeitures are first used to reduce administrative expenses and then to reduce employer matching and non-elective contributions. During the Plan year ended December 31, 2024, \$598 of the forfeiture balance was used to reduce administrative expenses. At December 31, 2024 and 2023, there were remaining forfeiture balances of \$148 and \$597, respectively.

Payment of Benefits

Upon termination of employment due to retirement, death, disability or separation of service, the balance in the participant's account will be distributed to the participant or to their beneficiaries in a lump sum, at the election of the participant or beneficiary.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or half of the vested interest in their account in the form of a loan with a minimum of \$1,000. Loans bear interest at Prime plus 1% and generally must be repaid within five years. The loans are secured by the balance in the participant's account. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan as provided in the Plan document. The Company, as Plan Sponsor, pays certain administrative expenses on behalf of the Plan. Participant accounts are adjusted for fees pertaining to termination processing and loans and are charged for expenses incurred by the custodian in the performance of their duties.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value and contract value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2024, through September 25, 2025, the date these financial statements were available for issuance. Except as disclosed in Note 9, as of such date, management was not aware of any subsequent events requiring additional disclosure.

Note 3: **Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the custodian of the Plan).

Note 4: **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Fair Value Measurements (Continued)

Common/collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments or redemption restrictions as of December 31, 2024 and 2023.

Note 5: **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would first be used to pay any expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

Note 6: **Tax Status**

The Plan Sponsor adopted a Non-Standardized Pre-Approved Profit Sharing Plan (Pre-Approved Plan) with CODA sponsored by CCH Incorporated. The Internal Revenue Service (IRS) has determined and informed the Pre-Approved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Pre-Approved Plan is designed in accordance with the applicable sections of the IRC. The Pre-Approved Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: **Party-in-Interest Transactions**

Certain Plan investments are currently managed by Charles Schwab Trust Bank, the custodian of the Plan. These transactions qualify as party-in-interest transactions.

Note 8: **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9: **Excess Contributions Payable**

The Plan failed non-discrimination testing for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, liabilities of \$7,602 and \$38,898, respectively, are recorded as excess contributions payable in the accompanying statements of net assets available for benefits and as a reduction of participant contributions for each year, respectively. The Plan distributed the excess contributions for the Plan year ended December 31, 2024, subsequent to December 31, 2024. The payable as of December 31, 2023, was distributed during the year ended December 31, 2024.
