NOTE A - DESCRIPTION OF THE PLAN

The following brief description of the Elkay Interior Systems International, Inc. 401(k) Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General

The Plan is a defined contribution plan covering non-union employees of Elkay Interior Systems International, Inc. (the Company). Effective March 9, 2022, the Plan was created from a spin-off from the Elkay Manufacturing Company Retirement and Savings Plan.

Employees are eligible to participate in the Plan after attainment of age 18 and completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the Company. Record-keeping services are provided by Empower Retirement, LLC and trustee services are provided by Empower Trust Company, LLC.

Contributions

Participants may make pre-tax and post-tax contributions based on an elected dollar amount or percentage of eligible compensation, as defined in the Plan document, subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing eligible distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan allows participants to make Roth deferrals and direct rollovers from another qualified Roth contribution program into the Plan.

The Company will make a safe harbor matching contribution equal to 100% of elective deferrals that do not exceed 4% of compensation. This safe harbor matching contribution is 100% vested.

The Company may make a discretionary nonelective contribution to the Plan (profit-sharing contribution). The profit-sharing contribution is limited by the Internal Revenue Code (IRC) and is determined by the board of directors of the Company. Profit-sharing contributions are allocated to participants who complete 1,000 hours of service during the year and are employed on the last day of the Plan year. There were no profit-sharing contributions in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, safe harbor matching contributions, and allocations of the Plan's earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the safe harbor matching contribution, plus actual earnings thereon. Vesting in any additional Company contributions is based on years of continuous service. A participant is fully vested after six years of credited service. Participant "vested percentage" in account attributable to nonelective contributions is determined under the following schedule.

<u>Years of Service</u>	<u>Vesting Requirement</u>
Less than 2 years of service	0%
After 2 years of service	20%
After 3 years of service	40%
After 4 years or service	60%
After 5 years or service	80%
After 6 years or service	100%

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of their account. Forfeitures are used to reduce future employer contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$45,559 and \$27,444, respectively. For the period ended December 31, 2024, forfeitures from non-vested accounts were not used to reduce employer contributions or pay plan expenses.

Payment of Benefits

Payments of benefits are made to participants or their beneficiaries upon death, retirement, disability or termination of employment. The Plan allows for certain withdrawals, subject to limitations and eligibility requirements as defined by the Plan. Benefits are payable in a lump-sum or by other methods as described in the Plan.

Notes Receivable From Participants

Participants may borrow from their Plan account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance relating to their contributions. Loan terms range from one to five years for a general-purpose loan and one to 15 years for the purchase of a primary residence. The minimum amount of any loan is \$1,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. A participant may only have one loan outstanding from the Plan at any time.

Administrative Expenses

Certain general and administrative expenses have been paid directly by the Company. Costs and expenses incurred with regard to the purchase, sale or transfer of investments and other assets, and for investment managers' fees in connection with the operation of the Plan are borne by the Plan. As well, specific accounting and other professional fees are paid by the Plan.

Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note C for further discussion of fair value measurements.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Distribution of Benefits

Upon termination of service, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Participants may also elect in-service withdrawals after reaching age 59½. Rollover account balances may be withdrawn at any time. Minimum required distributions for participants who have reached age 73 also apply per IRS regulations.

NOTE C - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e. an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan.

Mutual Funds

The shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of the shares held by the Plan at December 31, 2024 and 2023.

Pooled Separate Account

The pooled separate accounts are valued based on the fair value of the underlying investments held by the fund adjusted for the expense factor in the annuity contract. NAV is used as a practical expedient to estimate the fair value, calculated daily by the annuity provider according to the methods determined in the annuity contract.

Collective Trust

Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used to determine when it is determined to be

probable that the fund will sell the investment for an amount different than the reported NAV. Redemptions are permitted by participants on any business day. Redemptions at the Plan level are permitted with 12 months' written notice for the fixed income fund and on any business day for the equity fund. The collective trust has no unfunded commitments.

NOTE E - INCOME TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated November 14, 2022, stating that the form of the Plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. In accordance with Revenue Procedure 2019-04, the Plan sponsor has determined that it is eligible, and has chosen, to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - SUBSEQUENT EVENTS

Plan management evaluated the Plan's December 31, 2024 financial statements for subsequent events through September 30, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or disclosure in the financial statements, other than as noted below.

Effective July 1, 2025, the Plan Sponsor has amended the Plan to suspend the safe harbor matching contribution.
