- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Their report dated October 7, 2024, indicated that in their opinion: (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). ### Note 1—Description of the Plan

The following description of the Relatient 401(k) Plan (the "Plan") provides only general information. Participants or other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan which was established on January 1, 2015 to provide retirement benefits for the employees of Relatient, Inc. (the "Plan Sponsor"). The Plan covers substantially all employees of the Plan Sponsor who are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

*Administration* – The Plan is administered by the Company, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Eligibility* – Employees are eligible to participate in the Plan upon reaching the age of 21. The Plan excludes nonresident aliens and certain union employees under collective bargaining agreements.

*Contributions* – Participants may voluntarily make qualified retirement contributions to the Plan which are deductible for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. Participant contributions are permitted up to 100% of compensation, as defined in the Plan document, subject to certain IRC limits. Participants direct the investment of their contributions into various investment options offered by the Plan.

In 2024 and 2023, the Plan Sponsor makes a safe-harbor matching contribution equal to 100% of elective deferrals not exceeding 1% and 50% between 1% and 6%.

*Investment Options* – Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan. Participants may change their investment options at any time during the Plan year.

*Participant Accounts* – Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings (losses) and charged with withdrawals and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor contributions is based on years of continuous service. Participants become fully vested in Plan Sponsor safe-harbor contributions after two years of service.

*Notes Receivable* – Notes receivable from participants are not permitted under the Plan.

### Note 1—Description of the Plan (continued)

*Payment of Benefits* – Vested amounts contributed through salary/wage reductions may be withdrawn by or distributed to a participant only upon: (1) termination of service, (2) death, (3) disability, (4) retirement, or (5) a hardship distribution. In-service distributions are allowed for participants over the age of 59½, but only if the participant is fully vested in their account. Certain income tax penalties may apply to withdrawals or distributions prior to retirement. The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

*Forfeited Accounts* – Forfeitures are retained in the Plan and will be used to reduce administrative expenses under the Plan or reduce future employer contributions to the Plan. As of December 31, 2024 and 2023, there was a forfeited nonvested account balance of \$71,311 and \$-0-, respectively. During the years ended December 31, 2024 and 2023, \$37,920 and \$-0- were used, respectively, to reduce future employer contributions to the Plan.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Payment of Benefits* – Benefit payments are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

*Contributions Receivable* – Any participant-related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of year are reflected as participant contributions receivable in the accompanying financial statements. In addition, any contributions due and payable by the Company are reflected as employer contributions receivable in the accompanying financial statements.

### **Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by John Hancock Life Insurance Company, the qualified institution of the Plan.

- Investments, at fair value, in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental Schedule of Assets (Held at End of Year).

### **Note 4—Fair value of financial investments**

The Plan follows the Fair Value Measurements topic of the Financial Accounting Standards Board Accounting Standards Codification 820, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in the situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

**Note 4—Fair value of financial investments (continued)**

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Interest-Bearing Cash* – Valued at cost which approximates fair value based on the variability of the crediting interest rate on these funds.

*Pooled Separate Accounts* – Valued at the net asset value (“NAV”) of the units of the pooled separate account. The NAV, as provided by the Trustee is, used as a practical expedient to estimate the fair value. NAV is based on the fair value of the underlying investments held by the account less liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investments for an amount different than reported NAV/participant transactions (purchase and sales) may occur daily.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

**Note 6—Tax status**

The Plan Sponsor adopted a non-standardized defined contribution pre-approved plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated the Plan was in compliance with the applicable sections of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is designed, as amended, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken.

**Note 7—Related party and party-in-interest transactions**

Certain administrative expenses are paid to investment advisor and recordkeeper of the Plan. These transactions qualify as party-in-interest transactions. These administrative expenses amounted to approximately \$94,000 for the year ended December 31, 2024.

**Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participants' account balances and the amounts reported in the financial statements and supplemental schedule.
