### **Basis for Opinion**

### 1. Description of the Plan

The following brief description of Five Acres 401(k) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan of Five Acres – The Boys’ and Girls’ Aid Society of Los Angeles County (“Five Acres”). The Plan was amended in its entirety and restated effective January 1, 2011 and again, effective January 1, 2016. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent laws.

#### Plan Benefits

The Plan covers all eligible employees of Five Acres upon hire, however, employees can choose not to participate. Each year, participants may defer either a specific percentage or dollar amount of their pre-tax annual compensation, as defined by the Plan, up to the dollar limit set by law. In addition, participants qualifying for age-based provisions may make additional catch-up deferrals. For an employee to be eligible for the safe harbor contribution and employer match, they must have been employed on or after December 31, 2024. Matching contributions are based on a uniform percentage of each tier of salary deferrals determined by Five Acres.

Participants are immediately vested in their contributions plus actual earning thereon. Vesting in the Plan’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

#### Notes Receivable from Participants

A participant may apply for a plan loan to be made from his or her vested account balance in the Plan not to exceed the lesser of 50% of the participant’s vested account balance or \$50,000 and must be for at least \$1,000. All loans are to be paid back over a period not to exceed five years, excluding loans to acquire participant’s principal residence, which may be paid back over a reasonable period of time not to exceed 15 years. The loans bear interest at 2.00% for the years ending December 31, 2024. Principal and interest are paid by the participants through payroll deductions.

The plan administrator has concluded that these loans are not plan assets, and that such arrangements are party in-interest transactions for which a statutory exemption exists. The balance of outstanding loans at December 31, 2024 and 2023 were \$393,650 and \$342,147, respectively.

#### Termination

If employees are terminated prior to six years of service, except for reasons of death or attaining normal retirement age (as defined by the Plan), they forfeit the right to receive the unvested portion of their accumulated plan benefits.

### 1. Description of the Plan, continued

#### Death Benefits

If an active employee dies, the employee's benefit becomes 100% vested and the beneficiary will receive the balance of the employee's account.

#### Forfeitures

At December 31, 2024 and 2023, there were \$552, and \$8,672, respectively, in forfeited non-vested accounts. These amounts may be applied to reduce employer contributions.

### 2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

#### Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

### 2. Summary of Significant Accounting Policies, continued

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

#### Administrative Expenses

Employees of Five Acres perform certain administrative functions. Neither Five Acres nor its employees receive compensation from the Plan. Annual audit fees are paid by Five Acres.

#### Reclassifications

Certain amounts from the December 31, 2023 financial statements have been reclassified to conform to the December 31, 2024 presentation.

#### Subsequent Events

Management has evaluated subsequent events through September 12, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

### 3. Information Prepared and Certified by the Custodian

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 5. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$63,946.

The Plan's investment options include funds managed by Transamerica Corporation or its affiliates. As custodian and recordkeeper, Transamerica Corporation's transactions qualify as exempt parties-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intent to do so, Five Acres has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### 7. Tax Status

The Plan obtained a favorable determination letter dated October 22, 2004, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan was amended in its entirety and restated effective January 1, 2011 and again, effective January 1, 2016, with no modifications to the approved volume submitter specimen plan which is the subject of a favorable advisory opinion from the IRS. Therefore, the Plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the trust established under the Plan to hold the Plan’s assets is qualified and, accordingly, the trust’s net investment income is exempt from income taxes.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan’s investments include concentrations of credit risk. As of December 31, 2024, investments in American Funds American Balanced R6 represented 51% of the Plan’s total investments. The Plan’s exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

### **Basis for Opinion**

## NOTES TO FINANCIAL STATEMENTS

---

### 1. Description of the Plan

The following brief description of Five Acres 401(k) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan of Five Acres – The Boys’ and Girls’ Aid Society of Los Angeles County (“Five Acres”). The Plan was amended in its entirety and restated effective January 1, 2011 and again, effective January 1, 2016. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent laws.

#### Plan Benefits

The Plan covers all eligible employees of Five Acres upon hire, however, employees can choose not to participate. Each year, participants may defer either a specific percentage or dollar amount of their pre-tax annual compensation, as defined by the Plan, up to the dollar limit set by law. In addition, participants qualifying for age-based provisions may make additional catch-up deferrals. For an employee to be eligible for the safe harbor contribution and employer match, they must have been employed on or after December 31, 2024. Matching contributions are based on a uniform percentage of each tier of salary deferrals determined by Five Acres.

Participants are immediately vested in their contributions plus actual earning thereon. Vesting in the Plan’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

#### Notes Receivable from Participants

A participant may apply for a plan loan to be made from his or her vested account balance in the Plan not to exceed the lesser of 50% of the participant’s vested account balance or \$50,000 and must be for at least \$1,000. All loans are to be paid back over a period not to exceed five years, excluding loans to acquire participant’s principal residence, which may be paid back over a reasonable period of time not to exceed 15 years. The loans bear interest at 2.00% for the years ending December 31, 2024. Principal and interest are paid by the participants through payroll deductions.

The plan administrator has concluded that these loans are not plan assets, and that such arrangements are party in-interest transactions for which a statutory exemption exists. The balance of outstanding loans at December 31, 2024 and 2023 were \$393,650 and \$342,147, respectively.

#### Termination

If employees are terminated prior to six years of service, except for reasons of death or attaining normal retirement age (as defined by the Plan), they forfeit the right to receive the unvested portion of their accumulated plan benefits.

### 1. Description of the Plan, continued

#### Death Benefits

If an active employee dies, the employee's benefit becomes 100% vested and the beneficiary will receive the balance of the employee's account.

#### Forfeitures

At December 31, 2024 and 2023, there were \$552, and \$8,672, respectively, in forfeited non-vested accounts. These amounts may be applied to reduce employer contributions.

### 2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

#### Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

#### Administrative Expenses

Employees of Five Acres perform certain administrative functions. Neither Five Acres nor its employees receive compensation from the Plan. Annual audit fees are paid by Five Acres.

#### Reclassifications

Certain amounts from the December 31, 2023 financial statements have been reclassified to conform to the December 31, 2024 presentation.

#### Subsequent Events

Management has evaluated subsequent events through September 12, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

### 3. Information Prepared and Certified by the Custodian

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 5. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$63,946.

The Plan's investment options include funds managed by Transamerica Corporation or its affiliates. As custodian and recordkeeper, Transamerica Corporation's transactions qualify as exempt parties-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intent to do so, Five Acres has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### 7. Tax Status

The Plan obtained a favorable determination letter dated October 22, 2004, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan was amended in its entirety and restated effective January 1, 2011 and again, effective January 1, 2016, with no modifications to the approved volume submitter specimen plan which is the subject of a favorable advisory opinion from the IRS. Therefore, the Plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the trust established under the Plan to hold the Plan’s assets is qualified and, accordingly, the trust’s net investment income is exempt from income taxes.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan’s investments include concentrations of credit risk. As of December 31, 2024, investments in American Funds American Balanced R6 represented 51% of the Plan’s total investments. The Plan’s exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.
