Note A-DESCRIPTION OF PLAN

The following description of the SAC, INC. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and employees of the Company are generally eligible to participate in the Plan who are age twenty-one or older and after completing one year of eligibility service. A year of eligibility service is completed providing the employee worked at least 1,000 hours of service during a 12 consecutive month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of SAC, INC. oversees governance of the Plan. The Plan Administrator determines the appropriateness of the Plan's Investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Contributions

Each pay period participants may elect to defer and contribute a percentage of eligible compensation on a pre-tax basis, as defined in the Plan. This contribution is known as elective deferrals. The minimum percentage of eligible compensation a Participant may elect to defer is 1% and the maximum percentage is 75%. Participants have the option to elect to make Roth 401(k) employee contributions to the Plan. The minimum percentage of eligible compensation a Participant may elect to contribute is 1% and the maximum percentage is 75%. Eligible compensation is as defined in the Plan. Participants who have attained age 50 before year end are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers six common and collective trust funds and fourteen mutual funds as investment options for participants. Eligible employees may elect to defer a percentage of their eligible pay every pay period. The Plan provides for an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Contributions are automatically invested in a default investment fund selected by the Company, which will be identified to the participant prior to the first automatic contribution. At any time participants may select an alternative deferral amount or elect not to defer under the Plan.

The Company contributes 50% of the first 4% of the Participant's compensation which is deferred as an elective deferral. Both elective deferrals and Company matching contributions are allocated to the Participant's account and invested in accordance with the Participant's direction. The Company may decide to make nonelective contributions to the Plan at the option of the Company's board of directors, although the Company is not required to do so. Contributions are subject to certain limitations.

NOTE A-DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution, and (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan accepts Rollovers from qualified retirement plans and Individual Retirement Accounts (IRAs).

The Plan provides for cash-out distributions of small account balances (\$5,000 or less) of employees who have terminated employment with the company for at least 30 days. Such terminated participants with small account balances, who do not request a cash lump-sum termination distribution within 60 days of a cash-out notice, their vested account balance will be automatically rolled over to an individual retirement account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

Payment Of Benefits

Upon leaving the Company, due to termination of service, retirement, disability or death, a participant or participant's beneficiary may elect to receive vested benefits in either a single lump-sum payment or have the payment paid as a "direct rollover" to an individual retirement account (IRA) to the extent permitted under guidance issued by the Internal Revenue Service or to another employer's tax qualified plan equal to the value of the participant's vested interest in his or her account. If a participant's account balance (determined excluding any rollover contribution account but including any outstanding loan balance account) is greater than \$5,000, in addition to either a lump sum or a direct rollover, the participant may elect to receive installments, request a partial withdrawal, or defer receiving payments until age 70 ½.

NOTE A-DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate for the loan will be the rate in effect in the month the participant's loan is effective. The interest rate is calculated using the prime rate as published in The Wall Street Journal on the 14th of each month plus two percentage points. The interest rate is effective for any loan processed as of the 16th day of the month. Principal repayment and interest is paid ratably through bi-weekly payroll deductions.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce future employer contributions. During the year 2024 employer contributions were reduced by \$5,137 from these forfeited nonvested accounts. In 2023 employer contributions were reduced by \$2,066 from these forfeited nonvested accounts.

NOTE B-SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive stable value asset investment funds because contract (book) value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Investments in fully benefit-responsive stable value asset funds are presented in the Statement of Net Assets Available for Benefits at contract value. Accordingly, the Statement of Changes in Net Assets Available for Benefits is prepared using contract value for fully benefit-responsive stable value asset funds.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note-C for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Comparative Data

Certain prior year amounts have been reclassified to conform with the current year presentation. Such reclassifications had no effect on reported net assets available for benefits or change in net assets available for benefits.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

NOTE C-FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Benefits, except for fully benefit-responsive investment contracts which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE C-FAIR VALUE MEASUREMENTS (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U. S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

The fair value of index and blend growth funds for which quoted market price are not available are determined by using other significant observable inputs. Observable inputs are inputs that other market participants would use in valuing a portfolio instrument. These may include quoted prices for similar investments in active markets, quoted prices for identical investments in inactive markets, interest rates, foreign exchange rates, credit risk and others. Inputs are derived primarily from or corroborated by observable market data by correlation or other means.

The preceding methods may produce a fair calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D-FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Invesco Stable Asset Fund is one of the investment options offered by the Plan. This stable value asset investment fund is a common collective investment trust fund that is fully benefit-responsive. The Fund's primary investment objectives seek to achieve stability by the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The fund may invest in bank, insurance company, and other financial institution investment contracts.

Because the investments held by the Invesco Stable Asset Fund meet the criteria to be considered fully benefit-responsive, contract value is the relevant measurable attribute for that portion of the net assets available for benefits attributable to investment contracts. Contract value is the amount unit holders would receive if they were to initiate permitted transactions under the terms of the underlying defined contribution plans. The investments in the Invesco Stable Asset Fund are presented on the face of the Statement of Net Assets Available for Benefits at contract value. Contract value, as provided by Invesco Stable Asset Trust, and reported to the Plan by the Trustee, represents amounts equal to principal balance plus accrued interest plus deposits less withdrawals. Participants of the Plan may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE H-TAX STATUS

SAC, INC. 401(K) PLAN has adopted a prototype plan for which the Internal Revenue Service has issued a favorable opinion letter for the prototype document adopted. Per a determination letter dated October 6, 2020 the Internal Revenue Service determined the form of the Plan adopted by SAC, INC. 401(K) PLAN and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE I-RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
