## **Notes to Financial Statements**

### **December 31, 2024 and 2023**

---

#### **1. Description of Plan**

The following description of the Dimmitt Automotive Group 401(k) Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan became effective November 1, 2004 and was amended and restated on January 1, 2018 when the Employer adopted the Automatic Data Processing Defined Contribution Prototype Plan. Effective January 1, 2022, the Plan was restated to comply with various Internal Revenue Service (IRS) requirements. The Plan covers substantially all eligible employees of Northstar Family Enterprises (the Sponsor) and its participating employers. The Plan's management is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's management.

Effective September 1, 2023, Cycle Springs Powersports, LLC became a participating employer and the Plan was amended to provide for recognition of prior service with the employer for purposes of determining eligibility and vesting for the Plan.

Effective March 1, 2024, the Plan was amended to increase the auto enrollment deferral to 3% of compensation with 1% increases annually on the anniversary of the participant's eligibility date until reaching a maximum of 10%.

##### **Eligibility**

Employees of the Sponsor and its participating employers who have attained age twenty-one and completed two months of service are eligible to participate in the Plan.

##### **Contributions**

Participants may contribute up to 90% of their compensation, as defined by the Plan, as pre-tax or after-tax Roth contributions. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions among various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had a deferral rate of 2% of eligible compensation. Effective March 1, 2024, this rate increased to 3% of eligible compensation for all newly eligible employees. Contributions for these participants are invested in a designated balanced fund unless and until the participant makes a different investment election. The automatic deferral amount will increase each year by 1% of eligible compensation up to a maximum of 10% unless another election is made.

The employer may make matching contributions. The employer's matching contribution was 100% of the participant contributions, up to 2% and 3% of employee compensation withheld during the Plan year, for the years ended December 31, 2024 and 2023, respectively. For 2024 and 2023, the employer made matching contributions totaling \$982,917 and \$628,317, respectively. The employer may also make discretionary profit sharing contributions to the Plan. There were no profit sharing contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

#### 1. Description of Plan (continued)

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the employer's contributions, as well as investment earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, equally among participants, or to specific participants for transactions incurred by them. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the employer's contributions plus actual earnings thereon based on years of service. A participant is 10% vested after one year of service and 100% vested after two years of service. If participants are employed on or after their Normal Retirement Age or if they terminate employment on account of death or disability, they are 100% vested in their employer's contributions.

##### **Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions or pay Plan expenses. Forfeited non-vested accounts totaled \$21,093 and \$47,088 at December 31, 2024 and 2023, respectively. There were \$106,631 and \$44,571 of forfeitures used to reduce employer matching contributions for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures used to pay administrative expenses.

##### **Payment of Benefits**

The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant reaches age 59½. Benefits are payable in lump-sum payments or in installment payments with certain exceptions allowed.

##### **Plan Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to investment advisory services and administration of distributions that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net (depreciation) appreciation of fair value of investments.

#### 2. Summary of Significant Accounting Policies

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### **Contributions**

Employee contributions and the related employer matching contributions are accrued when wages are paid.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities, will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

## **3. Investments**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

The only non-participant directed investments are forfeitures which are included in the stable value fund at December 31, 2024 and 2023. See forfeitures in Note 1.

Certain mutual funds restrict transfers into the fund for a period ranging from 30-90 days after a transfer out of the fund. Other funds allow a certain number of transfers in and out during a specified period of time and then restrict any further transfers into the fund for a specific period of time.

**4. Fair Value Measurements**

GAAP provides a framework for measuring fair value and has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of other than publicly quoted prices that are observable, either directly or indirectly, and Level 3 inputs consist of unobservable inputs and has the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The level is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- Mutual funds: The fair value is based on quoted net asset values (NAV) of the shares held by the Plan at year-end (market approach).
- Stable value fund: As a practical expedient, the NAV of units of the collective investment trust is used to estimate fair value. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund.

The Reliance MetLife Stable Value Fund (the Fund), a collective investment trust, seeks to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed-income investments. The Fund primarily invests in MetLife Group Annuity Contracts, fully benefit-responsive investment contracts, which consists of separately managed investment portfolios that primarily invest in fixed-income securities and cash and cash equivalents. An investment in the Fund is not insured or guaranteed.

Participant and plan directed transactions made in accordance with the provisions of the Plan (including benefit distributions or elections to change investments), may occur daily. Plan directed withdrawals from the Fund are subject to a market value adjustment if the contracts fair value is less than the guaranteed contract value. Any participant directed withdrawals based on advice or direction of the Sponsor and any transfers to a “competing fund”, as defined in the trust document of the Fund, will be deemed a plan directed withdrawal subject to potential market value adjustment. If the Plan wishes to redeem all or substantially all of the units held by the Plan, they must notify the trustee no later than thirty (30) business days prior to such valuation. The trustee has adopted excessive trading policies designed to discourage and detect abusive trading. Accordingly, purchases, exchanges or withdrawals that the trustee determines to be actually or potentially harmful to the Fund will be rejected.

**5. Tax Status**

Effective January 1, 2022, the Plan adopted the Automatic Data Processing Non-Standardized Defined Contribution Pre-Approved Plan which received a favorable opinion letter, from the Internal Revenue Service (IRS) dated October 6, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status, and the non-discrimination requirements were satisfied for both 2024 and 2023.

#### **5. Tax Status (continued)**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **7. Related Party and Party-In-Interest Transactions**

Reliance Trust Company is the trustee of the Plan and ADP, LLC is the recordkeeper of the Plan; therefore, transactions with the trustee and recordkeeper qualify as party-in-interest transactions. Fees paid by the Plan to the trustee and recordkeeper totaled \$16,456 and \$7,882 for the years ended December 31, 2024 and 2023, respectively. The Plan paid investment advisory fees of \$79,752 and \$62,013 for the years ended December 31, 2024 and 2023, respectively. The Sponsor also paid certain administrative expenses of the Plan.

#### **8. Subsequent Events**

The Plan's management has evaluated events occurring subsequent to year-end through September 26, 2025, the date the financial statements were available to be issued, for financial reporting and disclosure purposes. Plan management concluded that no events occurred that required adjustments to or disclosures in the financial statements.
