Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Noa Brands America, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the



supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Noa Brands America, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted by Noa Brands America, Inc. (the Company) effective February 1, 1996, and is a defined contribution plan covering eligible employees of the Company and Falcon Manufacturing, LLC, an adopting employer. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The trustee of the Plan is Reliance Trust Company (Reliance) and the recordkeeper of the Plan is ADP Retirement Services (ADP). Reliance holds all assets of the Plan in accordance with the Service Agreement with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

An employee becomes eligible for the Plan after completion of 90 days of service and attainment of age 21, as defined by the Plan Document. Eligible employees may enter the Plan upon meeting the age and service requirements. Leased employees and residents of Puerto Rico are excluded from Plan participation.

Contributions

The plan allows eligible participants to contribute, on a pre-tax, after-tax, and Roth after-tax basis, up to 90% of their qualifying annual compensation as elected in their salary deferral agreements. The Plan includes an auto-enrollment provision whereby all newly eligible and rehired employees are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation unless they affirmatively elect a different percentage or elect not to participate. The Plan also includes an auto-escalation feature whereby participants, who were automatically enrolled into the Plan, will have their initial pre-tax deferral rate increased 1% per year until their pre-tax deferral rate equals 6%. The auto-escalation shall be effective March 31st of each Plan year. Participant contributions are subject to certain IRC limitations. Salary deferral agreements shall be made, terminated or changed according to procedures and limitations set up by the plan administrator and the Plan Document. The Plan also allows catch-up contributions for participants aged 50 and over subject to certain IRC limitations.

The Plan provides a Safe Harbor matching contribution. For the year ended December 31, 2024, the Company matched 100% of the first 3% of the eligible compensation and 50% of the next 2% of the eligible compensation. The Company matches participant catch-up contributions.

Discretionary profit-sharing contributions may also be made in an amount to be determined by the Company to employees with at least 1 year of service, as defined. This contribution is based on an integrated formula. Participants must be employed on December 31 and have 1,000 hours of service during the Plan year to be eligible. No discretionary profit-sharing contributions were made for the 2024 plan year.

Rollover contributions transferred from other qualified retirement plans are accepted as permitted by the Plan Document.

Participants' Accounts

Participants' accounts are credited with participant deferral (pre-tax, after-tax, and Roth) contributions, rollover contributions, employer contributions and an allocation of plan earnings or losses. Participant accounts are charged with certain administrative expenses that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participants may direct the investment of their account balances into various investment options in registered investment companies offered by the Plan. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are 100% vested in their deferral and rollover contributions, Safe Harbor matching and profit-sharing employer contributions and the allocated earnings thereon.

Forfeitures

At December 31, 2024 and 2023, there were \$2,078 and \$1,992, respectively, of forfeited non-vested accounts. Forfeitures may arise from excess contributions and may be used to pay Plan expenses or reduce employer contributions. During 2024, no forfeitures were used to reduce employer contributions or to pay Plan expenses.

Payment of Benefits

Upon termination of service, death, attainment of normal retirement age (65), or disability, as defined, a participant may elect to receive his/her benefit payment in the form of a lump-sum amount equal to the vested portion of the participant's account, receive his/her benefit in the form of installment payments, remain in the Plan if his/her vested account balance has a minimum of \$7,000, or may roll over the amount to another qualified retirement plan or individual retirement account. If no other election is made by the participant account balances less than \$1,000 are paid in a lump-sum to the participant and balances between \$1,001 and \$7,000 are rolled over to an Individual Retirement Account (IRA) for the benefit of the participant. Hardship withdrawals and certain other in-service withdrawals are also allowed by the Plan if certain criteria are met.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note is secured by the participant's account and bears an interest rate based upon prevailing commercial lending rates and is fixed for the term of the note. The note may be for a term of up to five years, unless used for a principal

residence, which may be for a term of up to ten years, and is subject to certain other restrictions, as defined by the Plan Document, and applicable restrictions under the IRC. Participants may have two outstanding notes at a time. Principal and interest are paid ratably through payroll deductions. Interest rates for the notes outstanding as of December 31, 2024 range from 4.25% to 9.50%.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. Participants would be fully vested upon termination, to the extent they are not already fully vested.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies and a collective investment trust are stated at fair value as further discussed in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies using information provided by the investment advisors and trustee.

Interest income is recorded as earned on the accrual basis. Dividend income (and capital gains) is recorded on the ex-dividend date. Purchases and sales are recorded on a trade-date basis. The net appreciation (depreciation) in the fair value of investments represents the realized and unrealized gains and losses on the investments and reinvested capital gains on the investments.

Contributions

Participant contributions and related employer contributions are recognized in the plan year during which the Company makes the respective payroll deduction from the participant's compensation and in the year in which the contributions relate to the participant's compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest was de minimus. Interest income is recorded as paid. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses which are incurred in connection with the Plan. These costs amounted to \$3,896 for the year ended December 31, 2024. Investment related expenses (in the form of a fee expense ratio charged to each investment option) are included in net appreciation (depreciation) in fair value of investments.

3. Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest earned on notes receivable from participants as shown on the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Investment amounts included in the notes to financial statements as of December 31, 2024 and 2023 and in the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobserved inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - At this level, inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - At this level, inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - At this level, inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Investment Trust (SVT) - The MetLife Reliance Stable Value Trust is a stable value fund that is composed primarily of fully benefit-responsive investment contracts. The SVT is valued at the net asset value of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. This is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain plan investments are shares of a collective investment trust managed by Reliance. The Plan paid fees to ADP during the year ended December 31, 2024. Reliance and ADP may receive certain other indirect fees from mutual fund companies. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. Income Tax Status

On July 1, 2022, the Plan was restated to a non-standardized pre-approved profit sharing plan sponsored by ADP, LLC. On October 6, 2020, the IRS advised the sponsor of the non-standardized pre-approved profit sharing plan document that the form of the plan document, as then designed, was acceptable under Section 401 of the IRC and therefore exempt from federal income taxes under the provisions of Section 501(a) of the IRC. The Company believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC, thus no provision for income taxes has been provided for in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Concentrations, Risks, and Uncertainties

The Plan invests through its registered investment companies and collective investment trust in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Additionally, the value, liquidity and related income of the investment securities are sensitive to changes in economic conditions, and may be adversely affected by shifts in the market perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in value in the near term could materially affect the amounts reported in the accompanying statements of net assets available for plan benefits and participant accounts.

At December 31, 2024 and 2023, there was one and two investments, respectively, which individually represented more than 10% of investments held. Refer to the supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

8. Delinquent Participant Contributions

During 2024 and 2023, certain participant contributions were not remitted to the Plan in a timely manner. The Company identified the late remittances and remitted lost earnings for all late remittances during 2024. See the supplemental Schedule of Delinquent Participant Contributions for the year ended December 31, 2024.
