To the Trustees and Participants
Union Beverage 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Union Beverage 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Union Beverage 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related

information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Note 1 - Plan description:

The following description of the Union Beverage 401k Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all eligible employees of Union Beverage Packers, LLC (the "Company") who are at least age 21 and have completed 3 months of service at the Company. An employee is credited for each month during which he or she performs one hour of service, whether or not consecutive months. Participation begins on the first day of the month following the completion of the eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan amendments:

In October 2023, the Plan was amended to remove its automatic enrollment provision. This change took effect on January 1, 2024.

SECURE Act 2.0:

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. The provisions affect 2023 and 2024 plan years as well as future years. Since the provisions include both required and optional elements, the Plan administrator will review and determine the provisions to elect. The provisions adopted by this Plan have been reflected in the appropriate accounting policy disclosure.

Participant accounts:

Each participant's account is credited or charged with the participant's contributions, the Company's contributions and allocations of the Plan's earnings or losses. Allocations are based on participant earnings or account balances, as defined. All accounts are participant-directed. The benefit to which a participant is entitled upon termination of employment is equal to the vested benefit in the participant's account.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by their vested account balances and bear interest at prime plus 2%. The term of the loan may not exceed five years, except for loans made for the purchase of a primary residence. Loans are repaid by salary deductions. Effective August 1, 2022, the maximum number of Plan loans that a participant can have outstanding at any one time is two. No allowance for uncollectible receivables has been recorded as of December 31, 2024 and 2023.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Plan description (continued):

Employee contributions:

Participants may make voluntary pre-tax contributions and after-tax Roth contributions up to the lesser of 90% of eligible compensation or the dollar limits permitted by the Internal Revenue Code. Participants may stop making contributions at any time and may increase or decrease the percentage of compensation as of each payroll. Compensation for Plan purposes is defined as all amounts paid to the employee and subject to income tax and is limited to the maximum compensation dollar limit set by the Internal Revenue Service, which was \$345,000 in 2024 and \$330,000 in 2023. The Plan also allows for participant catch-up contributions as applicable.

A participant may make a rollover contribution to the Plan at any time excluding any voluntary nondeductible amounts (after tax contributions). Rollover contributions are assets transferred from other qualified savings plans in which employees participated prior to their employment with the Company.

Employer contributions:

The Company may make a discretionary matching contribution to eligible participants as determined by the Company. During 2024 and 2023, the matching contribution was equal to 50% of the elective deferrals, up to 4% of eligible earnings to be determined each payroll period.

The Company may also make non-elective contributions which are at the discretion of the Company. These contributions are allocated based on the relationship of each participant's compensation to the total compensation of all participants. To participate in the non-elective contribution, the participant must be employed on the last day of the year. Participants terminated prior to December 31 due to death, disability, or attainment of age 65, the Plan's normal retirement age, will be eligible to receive any non-elective contribution that the company may make for the year in which their employment was terminated. No non-elective contributions were made for the years ended December 31, 2024 and 2023.

Hardship distributions:

Participants may request a distribution based on financial hardship after taking any non-hardship in-service withdrawals that are available. Prior to April 29, 2022, a participant had to take the maximum available loan under the Plan, unless repaying the loan would increase the amount of the hardship (certain rules apply). The Plan was amended to allow hardship distributions without being required to obtain all nontaxable loans available first.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Plan description (concluded):

Vesting:

Participants are 100% vested in their voluntary contributions plus actual earnings and losses thereon at all times. Vesting in the Company's contributions plus actual earnings and losses vest proportionally over a period of six years. The vesting percentage increases 20% per year after the first two years of service. Normal retirement is at age 65 with 100% vesting. If a participant becomes disabled under the Plan while employed by the Company, the participant becomes 100% vested.

Payment of benefits:

Participants are entitled to distributions of their vested benefits upon retirement, death, disability, termination of employment or termination of the Plan. Upon retirement, distributions may be taken in whole or in part at the election of the participant. Upon separation from service other than for retirement, the entire vested account balance is distributed to the participant when requested by the participant. If the participant is under age 59 ½ at the time of distribution, the participant may be liable for an additional 10% tax on the distribution. SECURE 2.0 increased the age to start taking required minimum distributions from age 72 to 73 beginning in 2023. Previously, the original SECURE Act increased the age from 70½ to 72. Effective January 1, 2022, a participant may request a distribution of up to \$5,000 per child as a Qualified Birth or Adoption Distribution (QBAD), provided certain conditions are met. In the event of death, participants become 100% vested.

Forfeitures:

If a participant terminates employment before being fully vested, a portion of the employer contribution will be forfeited. Forfeitures are used to reduce future employer matching contributions and can be used to pay administrative fees. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$155 and \$148, respectively. During 2024 and 2023, \$24,634 and \$20,255 of unallocated non-vested employer contributions were used to offset employer matching contributions and \$14,889 and \$10,619 were used to offset administrative fees, respectively.

Note 2 - Summary of significant accounting policies:

Basis of accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Note 2 - Summary of significant accounting policies (concluded):

Investment valuation and income recognition:

The participants direct how their account balance will be invested. The participants select from Company chosen investments including a menu of registered investment companies and a common/collective trust. Individual accounts are maintained for each participant. The accounts are valued on a daily basis at quoted market prices. Investments are stated at fair value. Fair value is the unit valuation of each fund at year-end as determined on the open market and includes interest and dividend income and appreciation (depreciation) in the Plan's assets.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded when earned. The cost of investments sold is determined on the basis of identified cost. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Payment of benefits:

Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no amounts due to participants who elected to withdraw from the Plan.

Note 3 - Tax status:

The Plan is a prototype defined contribution plan, sponsored by ADP Retirement Insurance and Annuity Company ("ADP"), the third-party administrator. ADP received a favorable IRS opinion letter, dated October 6, 2020, which stated that the Plan document is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the plan administrator and management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.

Note 4 - Investment contracts under the collective trust:

The common/collective trust fund includes fully benefit-responsive investment contracts. The fund is stated at fair value in accordance with ASU 2015-12 using the net asset value per share practical expedient.

ADP Inc. along with Invesco Trust Company, the trustee, and the Company entered into a participation agreement to participate in the Invesco Stable Asset Fund - ADPZ (the "Fund"). The trust invests 100% of its assets in Class C units of Invesco Stable Value Trust. The Trust offers four classes of Units: ADP85, ADP30, ADP59 and ADPZ. Each units' primary investment objective is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The Fund invests primarily in synthetic guaranteed investment contracts ("SGICs") which are portfolios of securities (debt securities or units of collective trusts) with wrap contracts associated with the portfolios. At December 31, 2024 and 2023, the investments of the underlying fund were 97.62% and 97.75% synthetic guaranteed investment contracts and 2.38% and 2.25% short-term investment funds, respectively. The Fund may also invest in Traditional Guaranteed Investment Contracts ("TGICs") which are backed by the general account of the issuer and short-term investments which are measured as level one in the fair value hierarchy. There were no amounts in TGICs at December 31, 2024 and 2023.

The contributions are maintained in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Certain events limit the ability of the trust to transact at contract value. Employer initiated events, if material, may affect the underlying economics of investment contracts. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer-initiated events could limit the Trust's ability to transact at contract value with plan unit holders. For example, retirement benefit payments which occur because an employer has offered a subsidized early retirement program will not transact at contract value unless the scope of the program is not material or the investment contract includes a "contract value corridor". The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTES TO FINANCIAL STATEMENTS

Note 4 - Investment contracts under the collective trust (concluded):

In addition to the limitations noted above, issuers of investment contracts have certain rights to terminate a contract and settle at an amount which differs from contract value. Examples of events that would permit a wrapper contract issuer to terminate a wrapper contract upon short notice include the Plan's loss of its qualified status, material breaches of responsibilities that are not cured, or material and adverse changes to the provisions of the Plan. If one of these events was to occur, the wrapper contract issuer could terminate the wrapper contract at the market value of the underlying investments (or in the case of a TGIC, at the hypothetical market value based upon a contractual formula). TGICs generally do not permit issuers to terminate the agreement prior to the scheduled maturity date.

Note 5 - Fair value measurements:

The Plan adopted the guidance on fair value measurements. This guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820-10 are as follows:

Basis of Fair Value Measurement:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The valuation methodology used for mutual funds is as follows: mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded. There have been no changes in the methodology used during December 31, 2024 and 2023.

Note 6 - Related party transactions:

Certain Plan investments are in a common/collective trust managed by the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Note 7 - Plan termination:

Although management has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 8 - Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Management believes that the Trustee maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

Note 8 - Risks and uncertainties (concluded):

The Plan permits loans to participants. These loans are classified on the statements of net assets available for benefits as notes receivable from participants. Concentrations of credit risk with respect to notes receivable from participants are limited due to the fact that participant loans are secured by their vested account balances and that loans are repaid from salary deductions.

Note 9 - Administrative expenses:

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses that are paid by the Company are excluded from these financial statements.

Investment related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses.

Note 10 - Certification by the Trustee:

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividend income, and interest income – notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

Note 11 - Subsequent events:
