We have performed audits of the accompanying financial statements of Emprise Corporation 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). ## Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Emprise Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

#### General

The Plan is defined contribution plan established on August 1, 2015, to provide retirement and other profit-sharing benefits to employees of Emprise Corporation (the “Company” or “Employer”).

The Plan was established for the exclusive benefit of eligible participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and related rules and regulations.

#### Eligibility

All employees of the Company are eligible to participate in the Plan as defined in the plan document. There is no minimum age or hours requirement to participate in the Plan.

#### Contributions

Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan and subject to Internal Revenue Service (“IRS”) limits. The Plan also allows for participants who are 50 years old or older to make catch-up contributions subject to IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer may make discretionary non-elective contributions to the Plan, as defined by the Plan, in an amount that the Company determines each plan year.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer’s contributions, as well as allocations of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations of Employer contributions, investment income and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are vested immediately in their deferral and rollover contributions and safe harbor matching contributions, including the earnings on those amounts. Vesting in the discretionary Company matching and profit-sharing contributions portion of their accounts is based on years of continuous service. Participants become fully vested in employer contributions upon the completion of five years of service. Participants are also fully vested upon reaching normal retirement age, death or total disability.

## **NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

Upon retirement, disability, death, or termination of employment, a participant or their designated beneficiary shall become entitled to the total value of their vested account. Distributions are paid in a lump sum, based upon election of the participant or as defined in the Plan. The Plan administrator may distribute lump-sum payments without participant consent for participants with a vested account balance less than \$5,000 upon termination.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½. Withdrawals from a participant's pre-tax deferral accounts may also be made in the event of a financial hardship or under other certain circumstances, in accordance with the provisions specified in the Plan.

### Forfeited Accounts

At December 31, 2024 and 2023, there were \$32 and \$31, respectively, of forfeited non-vested accounts. Forfeitures of discretionary matching contributions and excess matching contributions due to ineligible participants may be used to reduce the Company's future matching contributions. Forfeitures of discretionary profit-sharing contributions may be allocated to the remaining participants at the end of the Plan year in proportion to their compensation. During 2024, no forfeitures were utilized.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and Reliance Trust Company ("Reliance"), the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events for the year ended December 31, 2024 through September 26, 2025, the date on which financial statements were available to be issued.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

### *Level 1 Fair Value Measurement:*

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end fund that is registered with the Securities and Exchange Commission. This fund is required to publish their daily NAV and to transact at that price, which approximates \$1. The money market fund held by the Plan is deemed to be actively traded.

At December 31, 2024, mutual funds of \$13,014,636 and a money market fund of \$393,936 are considered Level 1 within the fair value hierarchy. At December 31, 2023, mutual funds of \$10,683,889 and a money market fund of \$670,505 are considered Level 1 within the fair value hierarchy.

#### **NOTE 4 - CERTIFIED INFORMATION**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required schedule of assets (held at end of year), including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, the trustee of the Plan

#### **NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance. Reliance served as the trustee of the Plan's assets and record-keeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. Reliance and other parties-in-interest perform certain administrative, advisory and recordkeeping services for the Plan. For the year ended December 31, 2024, Reliance and other parties-in-interest were paid \$72,048 for these services.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

#### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

#### **NOTE 7 - TAX STATUS**

The Plan has adopted a non-standardized prototype plan that received a favorable opinion letter from the IRS that it was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**
