Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Metropolitan Cabinet Distributors, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Metropolitan Cabinet Distributors, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with a cash deferral arrangement, established on July 1, 1997 by Metropolitan Cabinet Distributors, Inc. (the "Employer"), covering all employees of the Employer, who are age 21 or older ("Participants") that have worked one year (defined as 1,000 hours) except those covered under a collective bargaining agreement, leased employees and non-resident aliens. Newly eligible Participants may enter the Plan on the first day of each plan year or the first day of the next quarter after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant directed.

Participant Contributions

Participants may defer up to 100% of their eligible annual compensation, as defined by the Plan, subject to dollar limits set by Federal law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("Participant Rollovers").

Employer Contributions

Safe Harbor Matching Contributions

The Employer matches 100% of the first 3% of the Participant's eligible compensation contributed to the Plan plus 50% of deferrals that exceed 3% of eligible compensation but do not exceed 5% of eligible compensation. All active Participants making eligible contributions are eligible to receive Employer matching contributions.

Discretionary Contributions

The Employer may decide to make a discretionary non-elective contribution on behalf of eligible Participants each year. In order to receive a discretionary non-elective contribution, a participant must be employed on the last day of the contribution period unless separated due to death or disability or retirement. For the year ended December 31, 2024, no such discretionary contribution was made.

Note 1 - Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions and actual investment earnings thereon, and reduced by direct loan fees, if applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their deferral and rollover contributions. Vesting in the Employer's contribution is based on years of continuous service. A participant begins vesting in the Employer matching and discretionary profit sharing contributions after one year of service and is fully vested after six years of service. A year of service is defined as 1,000 hours of service within the Plan year. Upon death, disability or attainment of normal retirement age, a participant is fully vested in all of their accounts.

Forfeitures

A participant who leaves the Employer forfeits any non-vested balance upon the earlier of five consecutive one-year breaks in service or the distribution of the entire vested portion of the participant's account. During the year ended December 31, 2024, \$15 of forfeitures were used to reduce Employer contributions. At December 31, 2024 and 2023, \$25 and \$11 of forfeitures were available to reduce future Employer contributions, respectively.

Payment of Benefits

In-service withdrawals from any of the participant's vested balances are permitted only upon reaching age 59½, Employer contributions have been maintained in a participant's account for at least 24 months or after the participant has at least 60 months of participation. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or installment payments of such amounts, frequency, and duration as the participant or beneficiary may elect. Upon termination, if a participant's vested account is less than \$1,000, and the participant does not elect to receive the distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent. Hardship withdrawals may be taken from all accounts with a minimum amount of \$500.

Notes Receivable from Participants

Subject to approval by the Plan administrator, Participants may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years (or up to ten years for the purchase of a primary residence).

Notes Receivable from Participants (Continued)

The loans are secured by the balance in a participant's account and interest is charged at a rate commensurate with local prevailing rates as determined by the Employer. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

Individual participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. All other operating expenses incurred in the administration of the Plan are paid by the Employer.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. See Note 4 for discussions of fair value measurements.

Benefits Paid

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could vary from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Subsequent Events

The Plan has evaluated subsequent events through September 15, 2025, the date that the financial statements were available to be issued.

Note 3 - Investments Certified by Trustee and Custodian

Plan investments are held by the Plan's trustee and custodian, Reliance Trust Company ("Reliance"). Reliance certified the fair value of investments as of December 31, 2024 and 2023, and investment transactions for the year ended December 31, 2024. Investment transactions include interest and dividend income and net appreciation in fair value of investments. Information included in the supplemental Schedule of Assets (Held at End of Year), including participant loans (notes receivable from participants), has also been derived from information certified by Reliance.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual Funds, Exchange Traded Funds, and Cash Funds held in Self-Directed Brokerage Accounts

The fair values of the mutual funds, exchange traded funds, and cash funds within the self-directed brokerage accounts are based on the daily closing price as reported by the funds or quoted market prices when available. Exchange traded derivatives are priced based on inputs using quoted prices in active markets using observable inputs. Observable inputs reflect the assumptions market participants would use in pricing the asset or liability based on market data obtained from outside sources independent of the reporting entity.

Corporate Bonds held in Self-Directed Brokerage Accounts

Corporate debt securities are categorized as Level II Valued based on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flow approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

Note 5 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 7 - Tax Status

The Internal Revenue Service has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC") and informed the trustee of such in a letter dated October 6, 2020. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Related Party and Party-in-Interest Transactions

ADP, LLC ("ADP") is the recordkeeper as defined by the Plan. The Plan paid certain expenses related to the Plan's operations and investment activity to ADP and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to ADP and other related parties totaled \$41,68 for the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions, as defined by ERISA.
