Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Traditions Spirits Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

Note 1. Description of the Plan

The following description of Traditions Spirits Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Traditions Spirits Inc. (the Plan Sponsor or employer) for the following entities: Traditions Spirits Inc, RWC Spirits LLC, NGC Spirits LLC, RW Hotel LLC, WWC Spirits LLC and MSC Spirits, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Participation: All employees, except interns, nonresident aliens and employees covered by a collective bargaining agreement, are eligible to participate in the Plan immediately following attainment of age 18 and completion of three months of service. Temporary and seasonal employees are eligible to participate in the Plan upon completing 1,000 hours of service during the plan year.

Contributions: Participants can make voluntary pretax and Roth contributions up to 100% of their eligible compensation, as defined by the Plan, up to the maximum permitted by law. Participants may also make qualifying rollover contributions from benefit plans of previous employers. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan Sponsor makes matching contributions equal to 100% of the participant's salary deferral up to 4% of the participant's compensation. The Plan Sponsor may also make a discretionary profit sharing contribution. To qualify for the discretionary profit sharing contribution, the participant must be employed on the last day of the plan year. The Plan Sponsor did not make a discretionary profit sharing contribution for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions, the Plan Sponsor matching contributions, if any, and an allocation of (a) the Plan Sponsor's discretionary profit sharing contribution, if any, and (b) investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specified transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and profit sharing contributions, and earnings thereon. Vesting in Plan Sponsor matching contributions is based on years of service. Participants must have 1,000 hours of service during the plan year to be credited with a year of service. Participants become 33% vested for each year of service and are fully vested after three years of credited service.

Notes receivable from participants: Participants may borrow amounts from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. Loan terms may not exceed five years. The loans are secured by the balance in the participant's account and bear interest at prime plus 2%. Loan repayments of principal and interest are made through regular biweekly payroll deductions. The rate of interest on existing loans at December 31, 2024, ranged from 4.25% to 10.50% on loans maturing through November 2029.

Note 1. Description of the Plan (Continued)

Benefit payments: A participant's benefits are based on the amount in the participant's account and the vesting policy described above. A participant may request a distribution of their vested account balance upon termination of employment or while still employed by the Plan Sponsor if certain conditions are met. Distributions of benefits upon termination are paid in lump-sum payments if the participant's account balance is \$1,000 or less. If the participant's account balance is over \$1,000, they must provide written consent before any distributions can be made. Full or partial withdrawals are allowed in lump-sum payments. Voluntary withdrawals of a participant's pretax or Roth account balance while still employed by the Plan Sponsor are allowed before reaching age 59½ for reasons of financial hardship, as defined.

Forfeitures: Forfeited nonvested accounts are used to pay Plan expenses or fund future employer contributions. As of December 31, 2024 and 2023, the Plan had forfeited nonvested accounts of approximately \$12,500 and \$14,900, respectively. During 2024, the Plan used forfeitures of approximately \$4,100 to fund employer contributions.

Investment options: Participants are allowed to invest in a variety of investment options, as more fully described in the Plan's literature. The funds vary in type of investments, rates of return and investment risk. Participants may elect to have all or part of their balances and future contributions transferred from one investment option to another or in any combination. Participants may change their investment options daily.

Note 2. Significant Accounting and Plan Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Note 2. Significant Accounting and Plan Policies (Continued)

Contributions: Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which participant compensation is earned.

Excess contributions refundable: Amounts refundable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan did not distribute the 2024 excess contributions to the applicable participants until after March 15, 2025, and therefore, these excess contributions are subject to the 10% employer excise tax.

Benefit payments: Benefit payments to participants are recorded when paid.

Administrative expenses: The Plan Sponsor pays certain, but not all, administrative costs of the Plan. The expenses paid directly by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are included as an offset to net appreciation (depreciation) in fair value of investments.

Risks and uncertainties: The Plan provides for investments in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: Plan management, in preparing the financial statements and notes thereto, has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

Collective trust fund: The collective trust fund is valued at the net asset value (NAV) of the units in the collective trust held by the Plan at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The methods described above may produce fair values that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all amounts credited to the participants' accounts would become 100% vested as provided by the Plan.

Note 6. Tax Status

The Plan adopted a preapproved profit sharing plan sponsored by ADP, LLC that received a favorable opinion letter from the IRS on October 6, 2020, which stated that the preapproved Plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (the Code). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Delinquent Participant Contributions

During 2023 and 2022, the Plan Sponsor inadvertently failed to deposit \$47,365 and \$228,704, respectively, of participant contributions within the required time frame as stated by the United States Department of Labor regulations. The Plan Sponsor corrected the 2022 failure in 2024. The Plan Sponsor intends to deposit lost earnings to correct the 2023 failure in 2025. The Plan Sponsor will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes will be made from the Plan Sponsor's assets and not from assets of the Plan.

Note 8. Related-Party and Party-in-Interest Transactions

Reliance Trust Company, the custodian, holds the Plan's assets and executes transactions. Therefore, these transactions qualify as party-in-interest transactions.
