We have conducted an Employee Retirement Income Security Act of 1974 (ERISA) Section 103(a)(3)(C) audit of the financial statements of West Point Optical, LLC Retirement Savings Plan (the Plan) as of and for the year ended December 31, 2024 and have issued our report thereon dated September 22, 2025. Professional standards require that we advise you of the following information related to our audit.

Our Responsibility in Relation to the Financial Statement Audit

As communicated in our audit engagement letter for the audit of the financial statements mentioned above, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). For an ERISA Section 103(a)(3)(C) audit, the audit will not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are also responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

Planned Scope and Timing of the Audit

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

Compliance with All Ethics Requirements Regarding Independence

The engagement team, others in our firm, as appropriate, and our firm have complied with all relevant ethical requirements regarding independence.



In the normal course of our professional association with West Point Optical, LLC Retirement Savings Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

Qualitative Aspects of the Plan's Significant Accounting Practices

Significant Accounting Policies

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments. The most sensitive accounting estimate affecting the financial statements is:

Management's estimate of the fair value of investments is described in Note 4 to the financial statements. We evaluated the key factors and assumptions used to develop the fair value of investments and determined that it is reasonable in relation to the basic financial statements taken as a whole.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most significant disclosures affecting the financial statements are:

Fair Value Measurements disclosure note, which describes the valuation methodologies used to estimate the fair value of investments.

Prohibited Transactions disclosure note, which describes untimely remittances of participant contributions to the Plan.

Self Correction Program disclosure note, which describes an operational error.



Significant Unusual Transactions

We encountered no significant unusual transactions during the performance of the audit.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. There are no uncorrected misstatements.

In addition, professional standards require us to communicate to you all material, corrected misstatements that were brought to the attention of management as a result of our audit procedures. See financial statement footnote "Reconciliation to Form 5500", if any, for material, corrected misstatements.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditor's report. No such disagreements arose during the course of the audit.

Representations Requested from Management

We have requested certain written representations from management, which are dated September 24, 2025.

Management's Consultations with Other Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Internal Control Matters

Except as discussed in the Our Responsibility in Relation to the Financial Statement Audit paragraph, in planning and performing our audit of the financial statements of the Plan in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose



of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal controls and considered their nature as follows:

- A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.
- A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.
- A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis.

We identified the following deficiencies in the Plan's internal control, which are also considered to be reportable findings:

Control Deficiency - Forfeiture Balances

Matters Identified: During our audit, we found that there are no procedural controls to ensure forfeited participant accounts are used in the year the forfeitures are generated pursuant to Plan provisions. The Internal Revenue Code (IRC) requires that these forfeited accounts be used pursuant to Plan provisions. We noted forfeitures used during the audit year are less than the forfeitures generated during the year audit year, and that there is a balance of forfeitures at audit year end.

Recommendation: We recommend the Plan use or reallocate these forfeited accounts as soon as possible and plan management put in place a procedural control to monitor that all forfeitures created are used pursuant to Plan provisions. We also recommend Plan management consider consultation with ERISA counsel to determine if an official correction is necessary to ensure the Plan remains in compliance with ERISA and IRC regulations.

Control Deficiency - Employee Demographic Data

Matters Identified: During our audit, we noted there are insufficient controls in place to ensure that employee data matches between the recordkeeping system and payroll system. We noted certain employee data did not match between service providers, specifically dates of hire and termination, and therefore, alternative procedures were used to ensure the discrepancies did not affect Plan operations. It is important that employee data in the recordkeeping system be accurate since this is the data used for Plan operations and to ensure the plan's compliance with laws and regulations.

Recommendation: We recommend Plan management put policies and procedures into place to ensure employee data captured in the recordkeeping system is reviewed for accuracy and relevance for proper Plan operations.



Control Deficiency - Timely Remittance of Contributions

Matters Identified: During our audit, we noted there are insufficient controls in place to ensure the employer segregates all employee contributions and loan repayments from its general assets as soon as administratively feasible, as required by the Department of Labor (DOL). We noted employee contributions and loan repayments for the July 12, 2024 pay date took longer to remit to the Plan compared to remaining paycheck dates during the audit year. We discussed with Plan management and they agreed.

Correction Complete: In November 2024, lost earnings were deposited to affected participant accounts related to late remittances during the audit year.

Recommendation: We recommend Plan management consult with the Plan's service provider to implement policies and procedures to ensure consistent and timely remittance of employee contributions and loan repayments.

Control Deficiency - Employee Personnel Files

Matters Identified: During our audit, we noted there are insufficient controls in place related to maintaining current and complete employee personnel files. We noted certain employee personnel files contain data that is either old or incomplete and therefore, alternative audit procedures were used to obtain audit evidence for sample testing. Current and complete personnel files are important if there were ever any disagreement or allegations by employees that he or she was treated in a discriminatory manner as it relates to Plan operations.

Recommendation: We recommend Plan management implement policies and procedures to maintain current and complete employee personnel files, specifically to support key demographic data needed for proper Plan operations.

Control Deficiency - Auto Enrollment of Newly Eligible Employees

Matters Identified: During our audit, we noted Plan management did not have proper controls in place to ensure all newly eligible employees were auto enrolled into the Plan, unless the employee specifically opted out. Alternative procedures were needed to corroborate that some sampled eligible employees who are not participating have opted out. Written documentation of opt out from auto enrollment is important if there were ever any disagreement or allegations by employees that he or she was not auto enrolled in the Plan upon meeting eligibility requirements, a violation of plan provisions and ERISA.

Correction Required: Plan management needs to calculate and deposit corrective contributions to the affected participants, including Qualified Nonelective Contributions (QNEC) for employee missed deferral opportunity and related lost earnings. We will request proof of correction when performing next year's audit.

Recommendation: We recommend that Plan management put policies and procedures in place to maintain adequate documentation that supports all newly eligible employees are either timely auto enrolled into the plan or the employee has specifically opted out of participation.



Control Deficiency – Employee Deferrals Not Calculated Accurately

Matters Identified: No control was in place to ensure the proper elected deferrals were taken for certain participants. We noted 10 participants who had incremental amounts of before-tax deferrals taken in excess of their respective elections on paydates that occurred in January through June 2024, prior to the plan sponsor's change in payroll service providers.

Correction Required: Plan management needs to calculate and refund the excess deferrals along with any earnings thereon.

Recommendation: We recommend management review payroll each pay date to ensure deferrals are being calculated and withheld in accordance with participants' elections and the Plan's definition of compensation.

Control Deficiency - Mandatory Distributions

Matters Identified: During our audit, we found that there is no procedural control in place to ensure that mandatory distributions are processed following severance of employment for participants with an account balance of \$5,000 or less, pursuant to Plan provisions. We noted participant accounts exist at audit year end that belong to terminated employees and do not exceed \$5,000.

Recommendation: We recommend Plan management consult with its service provider to develop a procedural control to periodically (at least annually) review the accounts of terminated employees and process mandatory distributions pursuant to Plan provisions. If mandatory distributions cannot be made due to missing participants, plan fiduciary must be able to demonstrate compliance with DOL's missing participants guidance (<https://www.dol.gov/agencies/ebsa/employers-and-advisers/plan-administration-and-compliance/retirement/missing-participants-guidance>) regarding efforts made in locating missing participants or the selection of a distribution option for the benefit of missing participants.

Other Matters

The ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, were subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards (GAAS).

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. We obtained and read a substantially complete draft of the Form 5500 prior to the dating of our auditor's report. Material inconsistencies with the information, or manner of its presentation, appearing in the financial statements are included in the financial statement footnote "Reconciliation to Form 5500", if any. Our procedures are not sufficient, nor are they intended, to determine that the Form 5500 is completely and accurately prepared.
