## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Choice Health at Home 401k Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all employees of Choice Health at Home 401k Plan and participating Affiliates, collectively (“the Company”), who have completed three months of service. Employees of the Company are eligible to participate in the Plan on the first day of the month following the completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (“ERISA”). In 2023, Company purchased Lumicare Hospice whose employees became eligible to participate in the Plan during 2024. Transfers into the Plan from these participants totaled \$801,159 as shown in the accompanying financial statements. The Plan administrator is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The Plan was amended and restated, effective January 1, 2024, to allow all participants to be 100% vested in employer nonelective and employer match contributions. The employer also elected to match 100% of participant elective deferrals up to 2% of the participant’s compensation. Effective June 1, 2024, the Plan’s name was changed from Nathan Jackson DBA Choice Rehab 401(k) P/S Plan to Choice Health at Home 401k Plan.

**CONTRIBUTIONS**

Participants may contribute any combination of pretax elective deferrals and Roth elective deferrals from 1% to 50% of eligible wages, not to exceed the limit of Internal Revenue Code (“IRC”) Section 401(k). Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

For the year ended December 31, 2024, the Company contributed matching contributions of 100% of the first 2% of eligible compensation contributed by participants, which qualifies these contributions under the current safe harbor matching provisions. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contributions and the Company matching contributions. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**VESTING**

Participants are immediately fully vested in their voluntary contributions, rollover contributions, employer contributions, and actual earnings thereon.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Loans bear interest at Wall Street Journal prime plus 2%. Principal and interest are paid ratably through payroll deductions. Participants may only have two active loans outstanding at one time.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, normal retirement age, and other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installments. Hardship distributions are permitted from elective deferrals, excluding earnings. In-service distributions are permitted from vested accounts. Participants can elect to receive their distributions either in cash or as a direct rollover to another tax-qualified plan. The participant may elect to defer distribution until April 1 of the calendar year following the calendar year in which the participant reaches 73 years of age.

**FORFEITED ACCOUNTS**

Forfeitures may be used to pay administrative fees or reduce employer contributions. For the years ended December 31, 2024 and 2023, forfeited non-vested amounts totaled \$8,934 and \$10,488, respectively. During 2024, \$2,019 of forfeitures were used to reduce employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant's note receivable become uncollectible, the amount is deemed as a distribution and written off.

**EXCESS CONTRIBUTIONS**

Estimated excess contributions of \$13,737 at December 31, 2023, represent payments due to certain active participants to return to them excess deferral contributions, as required to satisfy the relevant nondiscrimination provisions of the Plan. This amount is recorded as liabilities, with corresponding reductions to participant contributions. Corrective amounts were distributed to the associated participants subsequent to 2023. The Plan had no excess contributions payable as of December 31, 2024.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lower priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. ADP Retirement Services and Reliance Trust are each considered a party-in-interest. Certain Plan investments are managed by Reliance Trust. Reliance Trust is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 7 - TAX STATUS**

The Plan has adopted a prototype non-standardized profit sharing plan which received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has concluded that there are no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
