## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF THE PLAN

The following description of the Delon Hampton & Associates, Chartered 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions for more complete information.

#### General -

The Plan is a defined contribution plan covering employees of the Delon Hampton & Associates, Chartered (the Company) who have completed one year of service and are at least twenty-one years of age by the end of a twelve-month period. The Plan qualifies under the Internal Revenue Code as a 401(k) Plan. The Plan was most recently restated effective January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In December 2022, Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Most of the provisions will become effective in 2024 and forward; therefore, there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

#### Contributions -

Participants may elect to defer a portion of their pre-tax compensation, as defined in the Plan, up to the annual statutory limits as determined by the Internal Revenue Service. In the Plan's before-tax and Roth 401(k) options, employees can choose to defer between 1% and 90%. The overall maximum contribution to the Plan is capped at 90%. The Company makes a safe harbor matching contribution equal to 100% of the employee's salary deferrals up to the first 1% of the eligible compensation, plus 50% of the employee's salary deferrals up to the next 5% of the eligible compensation. The Company may also make profit sharing contributions to each eligible employee's profit sharing account. The Company did not make any profit sharing contributions during the years ended December 31, 2024 and 2023.

#### Vesting -

Participants are immediately vested in their salary deferral contributions, plus actual earnings thereon. Vesting in the Company's safe harbor matching contributions, plus actual earnings thereon, is 100% after two years. Vesting in the Company's profit sharing contributions, plus actual earnings thereon, is 100% after three years.

#### Participant accounts -

Each participant's account is credited with the participant's contribution, the Company's contribution, and Plan earnings according to the participant's instructions. Allocations are based on participant earnings or account balances as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment options -

Contributions to the Plan are invested with Reliance Trust Company, the Trustee, according to participant instructions. The Plan Administrator will provide participants with current copies of the prospectus describing each investment option.

**1. DESCRIPTION OF THE PLAN (Continued)**

Payment of benefits -

Participants are entitled to receive a distribution of their vested account in the Plan upon termination of their employment; retirement; death or disability; or termination of the Plan without the establishment of a successor plan and the employer's sale to an unrelated corporation of the business in which they are employed. Payment can be made to participants while employed through in-service distributions, provided the participant is 59 1/2 years of age.

Plan termination -

The employer intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right to terminate the Plan at any time. Upon such termination, the liability of the employer to make contributions hereunder will terminate and participants will become fully vested in their accrued benefits. If the Plan is terminated, each participant will receive a total distribution in the form of a lump-sum distribution.

Notes receivable from participants -

Participants may borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. The notes receivable from participants are secured by the balance in the participant's account and bear interest at prime, plus one percent, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. For the years ended December 31, 2024 and 2023, interest rates were between 4.25% and 9.50%.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting -

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

Use of estimates -

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Fair value measurement -

The Plan applies the provisions of FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs (assumptions that market participants would use in pricing assets and liabilities, including assumptions about risk) used to measure fair value, and enhances disclosure requirements for fair value measurements.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Investment valuation and income recognition -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Certain Plan assets are invested in common collective trusts. Under the common collective trusts, the investment advisors account for the Plan's share of the total portfolio on a unit basis and are the Custodians of the investments (at net asset value).

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are loans for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date.

Administrative expenses -

Certain expenses of maintaining the Plan are paid directly by the Company and some are paid out of the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net appreciation in fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

Plan benefits -

Payments of Plan benefits are recorded when paid.

**3. INCOME TAX STATUS**

The Plan was established as a qualified plan under Section 401(k) of the Internal Revenue Code (IRC). The prototype plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service (the IRS) indicated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC and was qualified and tax-exempt. On January 1, 2023, the Plan adopted its most recent Plan amendment. Management of the Plan, in consultation with its legal counsel, believes that the Plan continues to meet the requirements of Section 401 of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

**3. INCOME TAX STATUS (Continued)**

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**4. FORFEITURES**

Forfeitures resulting from terminated non-vested participants will be added to any employer discretionary profit sharing contributions. There were no forfeiture balances and no forfeitures were used for the years ended December 31, 2024 and 2023.

**5. INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's Administrator instructed the Plan's independent auditors not to perform, and they did not perform, such auditing procedures with respect to the information certified by Reliance Trust Company. Reliance Trust Company issued Certification Statements, certifying the information presented in the Schedule of Assets (Held at End of Year) and the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**8. FAIR VALUE MEASUREMENT**

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for investments measured at fair value. Transfers between levels are recorded at the end of the reporting period, if applicable. There were no transfers between levels in the fair value hierarchy or changes in the methodologies used during the years ended December 31, 2024 and 2023.

- *Registered Investment Companies (Mutual Funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
- *Common/Collective Trusts* - These accounts are valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets of each of the respective common collective trusts. The underlying assets are valued based on the NAV as provided by the investment account manager.
