Report of Independent Auditors

To the Administrator of Van Eck Associates Employees Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Van Eck Associates Employees Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

(1) Description of Plan

The following description of the Van Eck Associates Employees Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which became effective January 1, 1987 and covers all eligible employees of Van Eck Associates Corporation ("the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Plan Administration

The Plan is administered by the Company. Reliance Trust Company serves as the trustee of the Plan and State Street Bank and Trust Company serves as sub-custodian of Plan assets. ADP Retirement Services serves as recordkeeper of the Plan.

(c) Eligibility

Employees are generally eligible to participate in the Elective Deferral and Employer Discretionary Match upon attaining 21 years of age and on the first day of the month coinciding with or subsequent to the 3 month anniversary of the date of hire. Leased employees, union employees, and nonresident aliens are not eligible to participate in the Plan.

(d) Contributions

Each participant may elect to contribute on a pretax basis up to the statutory maximum allowed by the Internal Revenue Code (IRC), which was \$23,000 for 2024. Participants aged 50 and over were eligible to an additional \$7,500 in 2024 (catch-up contribution). Prior to 2024, eligible employees were subject to automatic deferral provisions of 3% of that participant's compensation for each payroll period. The automatic deferral increased 1% a year beginning with year 3 of eligibility until reaching a 6% deferral upon year 5 of eligibility. Effective January 1, 2024, eligible employees are subject to automatic deferral provisions of 6% of that participant's compensation for each payroll period. Participants have the option to opt out of this automatic deferral.

The Plan Sponsor makes safe harbor contributions that matches 100% of each participant's elective contributions up to the first 6% of each participant's elective contributions. See the vesting schedule of these contributions at note 1(f). The Plan Sponsor may also apply participant forfeitures as an additional discretionary match. See note 1(g) for further discussion.

The Plan permits direct rollovers into the Plan from another qualified plan. The Plan also permits Roth elective deferrals made on behalf of participants on an after-tax basis.

Participants direct their elective contributions into various investment options offered by the Plan. The Company's safe harbor and discretionary match contributions are added into the same investments as those chosen by the participant's elections.

(e) Participant Accounts

Each participant's account is (i) credited with participant contributions and employer safe harbor match in the year in which employee contributions are withheld from compensation, (ii) credited with Plan earnings and (iii) charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan participants have the option of investing their contributions and existing account balances in various investment options available in the Plan including mutual funds, a money market fund, or a self-directed brokerage account.

(f) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the employer safe harbor matching contributions plus actual earnings thereon based on the following schedule:

Less than 2	0%
2 or more	100%

Participants are required to be credited with 1,000 hours to constitute a year of service.

(g) Forfeitures

A forfeiture will occur as of the earlier of (1) the last day of the Plan year in which the former participant incurs five consecutive 1-year breaks in service or (2) the distribution of the entire vested portion of the participant's account. Forfeited balances of terminated participants' nonvested employer matching contributions may be used to pay administrative expenses or may be added to any employer matching contribution and allocated as an additional matching contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$77,988 and \$18,252, respectively. For the year ended December 31, 2024, \$0 of forfeited nonvested accounts were used to pay administrative expenses and \$18,252 of forfeited non-vested accounts were added as additional matching contributions. These contributions are allocated to all participants eligible to share in the allocations in the same proportion that each participant's compensation for the Plan year bears to the compensation of all participants for such year. Forfeitures allocated to participant accounts are deemed discretionary matching contributions and vest based on the following schedule:

(h) Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may transfer it to another qualified plan or individual retirement account.

Terminated participants or a beneficiary with vested benefits of \$5,000 or less will automatically receive the value of the vested interest in his or her account as a lump-sum distribution.

(i) Hardship Withdrawals

Under certain conditions, participants, while still employed by the Company, are permitted to withdraw a portion of their elective contributions account balance. These conditions include: uninsured medical expenses incurred by the participant, his or her spouse or any of his or her dependents; costs directly related to the purchase of a principal residence of the participant; the payment of tuition, related educational fees, and room and board expenses for up to the next 12 months of post-secondary education for the participant, his or her spouse, children or dependents; payments necessary to prevent the eviction of the participant from, or foreclosure on the mortgage on, his or her principal residence; payments for burial or funeral expenses for the participant's deceased parent, spouse, children or dependents; and expenses for the repair of damage to the participant's principal residence that would qualify for the casualty deduction under the Internal Revenue Code (the Code). A participant's right to make elective deferrals to the Plan will be suspended for six months after the receipt of a hardship withdrawal.

(j) Administrative Expenses

The administrative expenses of the Plan are paid by either the Plan or the Company, as provided by the Plan document. For the year ended December 31, 2024, participant loan origination, self-directed brokerage account fees, and distribution fees were paid by the Plan participants initiating such transactions. All other expenses of administering the Plan were paid by the Company.

(k) Participant Loans

Participants may borrow from their participant account a maximum equal to the lesser of \$50,000 reduced by the highest outstanding Plan loan balance in the preceding 12 months or 50% of their vested account balance. Loan terms range from one to five years and may be up to thirty years when used for the purchase of a primary residence. Loans are secured by the participant's account balance in the Plan and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator at the time of the loan. Principal and interest are paid ratably through payroll deductions. The interest rates on outstanding loans as of December 31, 2024 and 2023 range between 4.25% and 9.5% and 4.25% and 9.25%, respectively. Maturity dates on outstanding loans range from February 2025 to August 2050.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and reductions to net assets during the reporting periods. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of money market funds and mutual funds are valued at the net asset value and investments held in self-directed brokerage accounts, which are comprised of exchange traded funds (ETFs) and common stock, are valued at the quoted prices of shares held by the Plan at year end. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as those held at year end. Realized gains and losses from security transactions are recorded on the average cost method.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Participant Loan Receivables

Loan receivables from participants are valued at unpaid principal plus any accrued but unpaid interest. Interest income from participant loans is recorded on an accrual basis.

(f) Employer Contribution Receivable

The employer safe harbor match is recalculated at the end of each plan year. Any “true-up” to the employer safe harbor match deemed necessary is included as an Employer contribution receivable on the Statements of Net Assets Available for Benefits.

(3) Information Certified by the Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting under ERISA. Accordingly, Reliance Trust Company, the Trustee of the Plan, has certified as being complete and accurate the investments and participant loans on the statements of net assets available for benefits as of December 31, 2024 and 2023, and the investment income, net appreciation in fair value of investments, interest and dividends, and interest income from participant loans reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the investment and participant loan information included in the supplemental schedule to the financial statements as of December 31, 2024.

(4) Fair Value Measurements

U.S. GAAP provides a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the net asset value of shares held by the Plan at year end.

Self-directed Brokerage Account Securities: ETFs and common stock are valued at the quoted prices of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

As of December 31, 2024 and 2023, all assets measured at fair value were classified as level 1 assets.

There were no changes in levels of investments during the years ended December 31, 2024 and 2023 and the Plan did not hold any level 3 investments during the years ended 2024 and 2023.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of a termination or partial termination of the Plan, or in the event of complete discontinuance of contributions, the account balances of affected participants will be fully vested and nonforfeitable.

(6) Related Party Transactions and Party-in-Interest Transactions

The Company earns management fee revenue from certain Plan investments that are shares of mutual funds distributed and managed by the Company. The value of these investments was \$30,138,792 and \$28,132,148 at December 31, 2024 and 2023, or 33.7% and 37.2% of plan net assets, respectively. Transactions involving these investments qualify as exempt party-in-interest transactions.

(7) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, and events such as global pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Tax Status

The ADP underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the written form of the underlying prototype document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code, and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or derecognition of an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that it is not subject to income tax examinations for years prior to 2021.

(9) Subsequent Events

The Plan has evaluated the need for any additional disclosures and/or adjustments resulting from subsequent events through September 30, 2025, the date the financial statements were available to be issued. This evaluation resulted in one subsequent event that necessitated disclosure in the financial statements. On January 1, 2025 ADP Retirement Trust Services, LLC replaced Reliance Trust Company as the trustee of the Plan. There were no other subsequent events that necessitated disclosures and/or adjustments in the financial statements.
