### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Community First Healthcare of Illinois, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024**

**1. Description of Plan**

The following description of Community First Healthcare of Illinois, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan established under Section 401(k) of the Internal Revenue Code, covering substantially all employees of Community First Healthcare of Illinois (collectively the “Company,” “Employer,” “Plan Sponsor,” or “Plan Administrator”), who have completed three consecutive months of service or, otherwise, have been credited with one year of service. Eligible employees enter the Plan on the date the eligibility requirements are met. The Plan Sponsor adopted the Plan effective January 1, 2015. Management of the Company controls and manages the operation and administration of the Plan. Reliance Trust Company (see Note 4) serves as the Trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Contributions*

Each year, participants may contribute up to 90% of their gross compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) deferral limitations. The Plan includes an automatic deferral feature whereby the Employer will automatically withhold 3% of participant’s compensation and contribute that amount to the Plan. The Company may make a discretionary matching contribution equal to a uniform percentage of each employee’s eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Annual compensation is defined as salaries and wages, including overtime, bonuses, commissions, and other compensation paid by the Company.

The Company may make a discretionary contribution for all participants who are employed at the end of the year, which is funded subsequent to year end. Any discretionary contributions are based upon participants’ annual compensation subject to IRS deferral limitations.

There were no Employer discretionary contributions elected for the year ended December 31, 2024.

*Participant accounts*

Each participant’s account is credited with the participant's contributions and an allocation of the Company’s contribution, Plan earnings (losses), and forfeitures of terminated participants’ nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*(Note 1, continued)*

*Investment options*

Participants direct the investment of their contribution into various investment options offered by the Plan including self-directed brokerage accounts. Participants may change their investment options on a daily basis.

*Vesting*

Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in Company matching contributions and profit sharing, if any, and earnings thereon, is based on years of service and is determined as follows:

Years of Service	Vested Percentage

1	20%
2	40%
3	60%

*Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. At December 31, 2024, outstanding loans bore an interest rate of 4.25% to 9.50%. Principal and interest are paid ratably over the term of the loan (generally five years) through payroll deductions.

*Payment of benefits*

The Plan provides for normal retirement at age 65. On termination of service due to death, disability and/or retirement, a participant may receive a lump-sum payment. Upon separation from service, participants or their beneficiaries may elect to have their normal retirement benefits paid as a single lump sum payment. Accrued vested benefits less than \$5,000 may be distributed at any time after such termination.

Under certain circumstances and with the consent of the Plan Administrator, a distribution of vested benefits may be made in the event of hardship.

*Forfeitures*

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures may be used to reduce future company contributions or to pay administrative expenses of the Plan. Forfeited non-vested accounts totaled approximately \$9,450 and \$407 for the years ended December 31, 2024 and 2023, respectively.

*(Note 1, continued)*

### *Party-In-Interest Transactions*

Administrative expenses of the Plan are paid by the Company except for the trustee and recordkeeping fees, which are paid by the Plan. Additionally, various administrative, legal, and accounting services are performed by the Companies' personnel on behalf of the Plan for which no charges are made to the Plan. Investment expenses, however, are charged against the Plan's investment income.

## **2. Summary of Significant Accounting Policies**

### *Basis of accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### *Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

### *Concentration of Credit Risk*

Substantially, all of the Plan's assets were held by Reliance Trust Company as of December 31, 2024 and 2023 (the "Trustee"). The Trustee of the Plan held the Plan's investments and executed all investment transactions.

### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*(Note 2, continued)*

*Payment of benefits*

Benefits are recorded upon distribution.

*Administrative expenses*

The Plan's administrative expenses are deducted from participant accounts. However, forfeitures from nonvested participants' accounts may be used to pay the Plan's administrative expenses in accordance with the Plan document. Certain administrative expenses, including functions performed by officers or employees of the Company and professional fees, are provided by the Company at no charge to the Plan, and the Company's management has no plans to obtain reimbursement of these expenses from the Plan.

*Subsequent event*

In preparing these financial statements, the Plan administrator has evaluated events and transactions for potential recognition or disclosure through September 1, 2025, the date the financial statements were available to be issued.

### **3. Fair Value Measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(Note 3, continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds and Brokerage Fund Option.*

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

*Common Collective Trust ("CCT").*

Accounts that invest exclusively in CCT that invest in underlying insurance contracts are valued at net asset value ("NAV") of the underlying insurance contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become completely vested in their accounts.

## 6. Tax Status

On July 16, 2014, IRS stated that the prototype plan adopted by the Plan, as then designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

## 8. Non-Exempt Party-In-Interest Transactions

During the 2024, 2023, 2022 and 2020 Plan years, there were unintentional delays by the Company in submitting participant contributions and loan repayments in the amounts of \$2,089,670, \$1,691,599, \$849,669 and \$184,741 to the custodian. These delinquent payments constitute prohibited transactions pursuant to the Department of Labor (the “DOL”) regulations.

As of the date the financial statements were available to be issued, late contributions and loan repayments in the total amount of \$4,815,679, which relate to 2024, 2023, 2022 and 2020 late contributions and loan repayments, were not corrected.
