**NOTE A - DESCRIPTION OF PLAN**

The following description of the Beumer 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan, which commenced January 1, 1993. All employees who have attained age 21 are eligible to participate. Employees are able to enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 90% of their gross compensation on a pre-tax basis to a regular 401(k) account or Roth 401(k) account or on an after-tax basis into a non-Roth 401(k) account to the Plan through salary reduction. Participants’ elective deferrals are subject to the limitations of Internal Revenue Code Section 402(g). Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company can make a discretionary match, as defined in the Plan. The Company’s matching contribution will equal 50% of the participant’s elective deferral contribution but may not exceed 5% of participant compensation. Effective April 2024, the Company’s matching contribution was amended to be 100% of the first 1% of participant’s compensation plus 50% of the next 5% of participant’s compensation. The Plan includes an auto-enrollment provision (4% salary deferral with 1% increases annually on the first day of January until reaching a maximum of 8%) whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants’ contributions were \$2,936,830 for the year ended December 31, 2024. The Company contributions were \$864,581 for the year ended December 31, 2024.

**Participant Accounts**

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant’s contribution, an allocation of the Company’s matching contribution and an allocation of Plan earnings (losses), as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately 100% vested in their own contributions to the Plan. If an employee of Beumer Corporation leaves the Company for any reason, they will be vested in matching contributions and nonelective contributions according to the following schedule:

Less than three years of service	0%
Three years or more of service	100%

Regardless of the vesting schedule, a participant will become fully vested upon death, disability, and at normal retirement age.

**Forfeitures**

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan as specified in the Adoption Agreement. The non-vested account balances at December 31, 2024 and 2023 were \$1,617 and \$21, respectively. Forfeitures can be applied to reduce employer contributions or pay plan expenses. Forfeited amount of \$37,794 for 2024 was used to reduce employer match contributions.

**Plan Expenses**

The plan has a separate plan expense account set up to pay expenses of the plan. The account balances at December 31, 2024 and 2023 were \$0 and \$30,919, respectively. This account has been established to capture the revenue-sharing amounts received which are used to pay plan expenses.

**Loans**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in *The Wall Street Journal*. Principal and interest are paid ratably through payroll deductions. Any loan will by its terms require that repayment be over a period not extending beyond 5 years from the date of the loan, unless the loan is for the purchase of a participant's primary residence in which the loan repayment period may not extend beyond 30 years.

**Payment of Benefits**

Participants are eligible to receive a distribution of the vested portion of their individual account balance upon the following:

- The occurrence of any of the distributable events specified in the Adoption Agreement,
- The participant's termination of employment after attaining normal retirement age, or
- Termination of the Plan.

The normal retirement age under this Plan is 65.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of participants' accounts shall be in accordance with the Plan document.

**Plan Amendments**

Effective April 1, 2024, the plan was amended to change the employer matching contribution formula to be 100% of the first 1% of participant's compensation plus 50% of the next 5% of participant's compensation.

Effective August 1, 2024, the plan was amended to update the eligible employee exclusions. For all contribution types, excluded employees will be union employees, nonresident aliens, and leased employees.

Effective November 1, 2024, the plan was amended to update the eligibility requirement to require two months of service, for all contribution types.

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act; however, plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the modified cash method of accounting, which adjusts securities investments to fair value.

The Plan accounts for all transactions on the modified cash basis. Security transactions are recorded on the settlement date, and the determination of gain or loss on securities sold is based on the average cost of the securities. Investment income (interest and dividends) is recorded on the date received. Expenses are recorded on the date of payment.

Modified cash basis accounting represents a departure from accounting principles generally accepted in the United States of America. It is not a prohibited method of accounting for employee benefit plans under the reporting requirements of ERISA. The result of the use of the modified cash basis of accounting is that dividends and interest receivable, security trades made but not settled, contributions receivable from the employer and liabilities at December 31, 2024 and 2023, are not included in the accompanying financial statements. Accordingly, the financial statements are not intended to present financial position and changes in net assets in conformity with generally accepted accounting principles.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Plan investments in mutual funds are stated at fair value. Shares of mutual funds are valued at quoted market prices. The Plan's investments in the common collective trust is stated at net asset value as a practical expedient as reported by the trustee which include a mix of mutual funds and managed accounts. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investments options are valued daily. This daily price is considered the selling price for transfers and withdrawals, and is calculated each day the principle market is open and available to any participant in the Plan.

Purchases and sales of registered investment company shares are recorded at end of day net asset value. Dividends are recorded as of the record date.

**Participant loans receivable**

Participant loans receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are paid.

**Contributions**

Contributions from participants are recorded in the period in which they are received by the Plan. Company matching and discretionary profit-sharing contributions are recorded in the period made.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses, excluding transaction fees, are paid by the Company.

**Party in Interest Transactions**

Certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as party in interest transactions allowable under ERISA guidelines.

**Date of Management's Review**

Management has evaluated subsequent events through September 18, 2025, the date which the financial statements were available to be issued.

**NOTE C - RELIANCE ON TRUSTEE'S REPORT**

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by the trustee of the Plan, Reliance Trust Company, other than comparing such information to that contained in the financial statements and supplemental schedules. **NOTE D - TAX STATUS**

The Plan is a prototype plan sponsored by ADP, LLC. The prototype plan has received an opinion letter dated October 6, 2020 that the prototype plans are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes.

**NOTE D - TAX STATUS (Continued)**

In accordance with the modified cash basis of accounting, plan management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE E - LATE REMITTANCES**

When participant payroll deferrals are not remitted within the appropriate time period by the Company, these transactions constitute prohibited transactions as defined by ERISA.

During the year ended December 31, 2024, employee contributions aggregating \$391 were not remitted timely by the Company. Lost earnings will be calculated, and the Company plans to remit the amount to the plan.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan provides for investments in a selection of mutual funds and a common collective trust. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits--modified cash basis.

**NOTE G - FAIR VALUE MEASUREMENTS**

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

*Level 1* inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.
