Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of HCP Financial and Management Services 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.



NOTE A – DESCRIPTION OF PLAN

The following description of the HCP Financial and Management Services 401(k) Plan (the “Plan”) provides only general information. Participants and readers should refer to the Plan document and Summary Plan Description (SPD) for a more detailed description of the Plan’s provisions. The Plan is subject to the *Employee Retirement Income Social Security Act of 1974 (“ERISA”)*.

General

The Plan is a defined contribution plan with a 401(k)-provision established for full time, non-union employees of Healthcare Plus Corporation, HCP Financial, LLC, Healthcare Plus Caregivers Corporation, Healthcare Plus Transport Corporation, Healthcare Plus Staffing, LLC, Chicagoland Homeowners Association, LLC, Medical Gear, LLC, Healthcare Plus Homemakers, LLC and Comfort Home, LLC (collectively the “Employer”). Non-union employees become eligible to participate semi-annually in the Plan upon completion of one year of service and attainment of age 21.

The Plan elected to implement certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which changed the Plan to, among others, delay the commencement date for required minimum distributions. Also, the Plan elected to implement certain provisions of the Coronavirus Aid, Relief, and Economic Security (“CARES Act”) of 2020. The CARES Act included several relief provisions available to tax-qualified retirement plans and their participants only for a limited duration of time. These provisions include, among other things, special COVID-19 related distributions of up to \$100,000, increasing the maximum amount of Plan loans to participants to \$100,000, deferring payments on certain Plan loans through December 31, 2020, and suspending required minimum distributions for the year ended December 31, 2020. The Plan adopted provisions of SECURE Act and CARES Act in 2020.

Contributions

Participants may elect to contribute a percentage of their pretax eligible earnings, as defined in the Plan, and/or a percentage of their post-tax net earnings (Roth Elective Deferrals) subject to maximum amounts established by the Internal Revenue Code (the “Code”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also includes a provision for catch up contributions when an employee is eligible.

The Employer is required to make a safe-harbor matching contribution based on a formula, as defined in the Plan. For the year ended December 31, 2024 and 2023, the employer’s matching contribution was equal to 100% of the first 3% participant’s elective salary deferral plus 50% of the next 2% of the participant’s elective salary deferral. Additional amounts may be contributed at the option of the Employer’s board of directors as non-elective contributions. There was no employer Non-Elective Contributions for the years ended December 31, 2024 and 2023, respectively.

Additionally, the Plan may accept rollover or Roth rollover contributions. Participants will always be 100% vested in their rollover accounts, although those funds will be affected by any investment gains or losses.

Participants’ Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer contributions and (b) earnings in a participant’s account, and charged with an allocation of transaction fees, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.

NOTE A – DESCRIPTION OF PLAN – (continued)

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon as well as the Employer's safe-harbor matching and rollover contributions and also if required, qualified employer non-elective contributions and qualified matching contributions.

Vesting in the Employer's discretionary matching or non-elective contributions portion of the accounts plus actual earnings is based on years of continuous service and fully vested after five years of credited service. The graduated vesting schedule is as follows:

<u>Years of Service</u>	<u>Vested %</u>
Less than 1 year	0%
1 to 2 years	20%
2 to 3 years	40%
3 to 4 years	60%
4 to 5 years	80%
5 or more years	100%

Investment Options

Participants may direct the investment of their account balances and future contributions and Employer contributions into various investment options offered by the Plan. Participants are allowed to change their investment options daily.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Account balances less than \$1,000 are subject to payment regardless of whether the employee consented to receive it upon termination.

In 2020, the Plan elected to implement the CARES Act provisions that allowed participants or beneficiaries to waive the required minimum distribution for the year ended December 31, 2020. In addition, effective January 1, 2020, pursuant to the SECURE Act, the required beginning age under the Plan for required minimum distribution is 72.

Notes Receivable from Participants

Participants may borrow (subject to certain restrictions) from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loan terms range from one to five years unless it is for the purchase of a primary residence, for which there is no term limit. The loans are secured by the vested balance in the participant's accounts and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Each participant's account is charged with administrative fees on any loans the participant has taken.

Forfeitures

Forfeitures of non-vested discretionary contributions, when not used to reduce employer matching contributions, will be used to pay administrative costs of the Plan or reallocated amongst the remaining participants. \$20,576 and \$9,528 in forfeitures were used to reduce Employer contributions in December 31, 2024 and 2023, respectively.

Hardship Withdrawals

Hardship withdrawals may be made to satisfy certain immediate financial needs, according to specific types of costs and set conditions designated in the Plan. Hardship withdrawals can only be made from accounts which are 100% vested.

In 2020, the Plan elected to implement the CARES Act provisions that allow special COVID-19 related distributions of up to \$100,000 for the year ended December 31, 2020. The COVID-19 related distribution may be repaid during the three-year period beginning on the day the distribution was received.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with U.S. generally accepted accounting principles (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of their financial statements change as new events occur, as more experience is acquired, as additional information is obtained and as the operating environment changes.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement. See Note D regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and have a term of up to 60 months. The interest rate is based on the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 2% at the end of the prior month when taking the loan principal and interest are paid ratable through bi-weekly payroll deductions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Plan Sponsor or charged against forfeitures. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. The Plan imposes certain charges against individual participant's accounts when individual participants incur the charges. Fees related to the administration of notes receivable from participants or are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments. During years ended December 31, 2024 and 2023 the Plan's fees were \$64,131 and \$56,249, respectively. No forfeiture dollars were used to pay these Plan expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Reclassifications

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation with no effect on previously reported net increase in net assets available for benefits.

NOTE C – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as accurate and complete by a qualified institution need not be subjected to independent audit.

The Plan administrator has obtained a certification from Reliance Trust Company, as trustee of the Plan, that the following information included in the Plan’s financial statements and supplemental schedule is complete and accurate:

- Investments as of December 31, 2024 and 2023;
- Plan transactions related to investment income and securities transactions for the years ended December 31, 2024 and 2023;
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, at the request of the Plan administrator, the Plan’s independent certified public accountants performed no procedures on investment information and related activity, other than to agree the information to the trust statements certified by the Plan’s trustee and provided to them by the Plan administrator.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Stable Value Collective Trust Fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient will not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The Plan is permitted to redeem investment units at NAV on the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract with ADP. ADP maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Since this contract meets the fully benefit-responsive contract criteria, the contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate was 1.77% and 1.99% as of December 31, 2024 and 2023, respectively.

Certain events may limit the ability of the Plan to transact at contract value with the participant. Such events include, but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE F –PARTIES-IN-INTEREST

Substantially all fees are paid by the Employer on behalf of the Plan. Certain employees of the Employer provide administrative services to the Plan. These employees are compensated by the Employer for such services. The plan trustee, Reliance Trust Company is a party in interest as it manages one or more mutual funds.

NOTE G – TAX STATUS

The Plan is a prototype plan. Effective July 8, 2014, the Company adopted the ADP, Inc. Prototype Non-Standardized Profit-Sharing Plan, which is a non-standardized prototype plan. The Plan has received a favorable opinion letter from the Internal Revenue Service (IRS), who stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan has not individually sought its own determination letter.

NOTE G – TAX STATUS (continued)

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. For federal purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior 2021.

NOTE H – SUBSEQUENT EVENTS

The management of the Plan has evaluated events subsequent to the statement of net assets available for benefits date of December 31, 2024, through September 25, 2025, the date the financial statements were available to be issued. It has been concluded that there are no other effects that provide additional evidence about conditions that existed at the statement of net assets available for benefits date that require recognition in the financial or related note disclosures in accordance with FASB ASC 855, *Subsequent Events*.
