## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of CES Cleaning Contractors, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CES Cleaning Contractors, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF PLAN

The following description of the CES Cleaning Contractors, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. A more complete description of the Plan's provisions can be found in the plan agreement.

General – The Plan was adopted on January 1, 2016 by CES Cleaning Contractors, LLC.

The Plan is a defined contribution plan covering all eligible employees of the Company who have three months of service and have attained the age of twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Company does not have employer contributions or safer harbor matching requirements under the plan. The Company must contribute the amount by which participants have reduced their compensation for the plan year, subject to a statutory dollar limitation of \$23,500 and \$23,000 for 2024 and 2023, respectively. An additional salary deferral may be made for the calendar year by any participant that is age 50 or over during the calendar year.

Funding – Employee salary deferrals are funded by the Company concurrently with the processing of payroll each period.

Participant Accounts – Each participant's account is credited with an allocation of the plan earnings and forfeitures of terminated participants' non-vested accounts and with actual employee deferral contributions. Contributions and forfeitures are allocated based on the ratio of each participant's compensation for the Plan year to the compensation of all participants for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting – Participants are 100% vested in their employee deferral contributions.

Investing Options – Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment funds Reliance Trust Company offers. Participants may change their investment options daily through a toll-free number with ADP or via the internet on the ADP website.

Participant Notes Receivable – Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their non-forfeitable account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the non-forfeitable balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the advisory committee. The interest rates on the current loans outstanding range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

If a participant fails to make a payment on their loan, the loan is considered to be delinquent. The participant is given 90 days from the loan becoming delinquent to bring the loan back to a current status. If the loan is not brought current, the unpaid loan balance is considered to be a deemed distribution. As of December 31, 2024 and 2023, there were no delinquent loans outstanding.

Payment of Benefits – Upon termination of service including death, disability or retirement, a participant will be paid no earlier than 90 days following the participant's separation from service. Normal retirement age is defined as 65. The benefit obligations payable to participants were \$163,205 and \$94,334 for December 31, 2024 and 2023, respectively.

Forfeitures – There are no monies to be forfeited by participants as of December 31, 2024 and 2023 since the plan does not currently have any employer matching or safe harbor contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the CES Cleaning Contractors 401(k) Profit Sharing Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements is as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized when received. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Notes receivable from participants are considered to be delinquent after one payment is late. The participant is notified by letter that the note receivable is held in default if the note is not brought current after three missed payments. The default is a deemed distribution.

Allowance for Doubtful Accounts

Allowance for doubtful accounts is assumed to be zero based on historical collections.

Investment Valuation and Income Recognition

Mutual funds are stated at their quoted market price on a daily basis.

Participant notes receivable are valued at cost, which approximates fair value. The net aggregate change in net assets available for plan benefits are presented as net appreciation or depreciation in the fair value of investments.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

During the year, the Plan sponsor paid for accounting and certain administrative expenses. Other administrative expenses paid by the Plan are reflected in the statement of changes in net assets available for plan benefits.

NOTE 3 FAIR VALUE MEASUREMENTS

Generally accepted accounting principles provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at the year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest include fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization or relatives of such persons. As of December 31 2024 and 2023, the Plan holds notes receivable from participants and paid certain expenses related to plan operations and investment activities to various service providers. Transactions with these entities qualify as exempt party-in-interest transactions.

NOTE 5 TAX STATUS

The IRS has determined and informed the plan sponsor by a letter, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The tax years 2021 to current remain subject to examination by taxing authorities.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants are 100 percent vested in their accounts.

NOTE 7 RISKS AND UNCERTAINTIES

Plan participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The maximum amount of loss due to credit risk in the event of a complete institutional failure at December 31, 2024 is \$390,889.

NOTE 8 SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 22, 2025, the date through which the financial statements were available to be issued.
