## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the Spreadtrum Communications USA, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements Spreadtrum Communications USA, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Spreadtrum Communications USA, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1 – Description of Plan**

The following description of the Spreadtrum Communications USA, Inc. 401(k) Plan (the 'Plan') provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan and was established on January 1, 2004 for the benefit of all eligible employees of the Company. Employees can enroll into the Plan on the first day of the subsequent month after the month they are hired. Generally, the Plan covers all employees of the Company who are 21 or older except for employees who are:

- union employees; or
- non-resident aliens; or
- leased employees, or
- Spreadtrum Shanghai employees

The Company and the Plan trustees are responsible for administering the Plan.

b. Participant contributions

Participants may contribute up to \$23,000 for the year ended December 31, 2024. Participants may also contribute up to 100% of their eligible compensation (subject to statutory limits). Participants who are age 50 and over may make an additional catch-up contribution of \$7,500.

The Plan also permits Roth 401 (k) contributions up to 90% into the Plan. Participants may also make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. All contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

c. Company's contributions

Each plan year, the Company may make a discretionary matching contribution equal to a uniform percentage of participant's salary deferrals up to \$7,000. On an annual basis, the Company will determine the amount of the discretionary percentage. In addition, the Company may make qualified non-elective profit-sharing contributions at the discretion of the Company. For the year ended December 31, 2024, the Company made contributions of \$662,039.

d. Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan to the extent that not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately and fully vested in salary deferral, rollover contributions, employer's matching contributions, and gains or losses thereon allocated to their accounts. Participants vest in the employer's profit sharing contributions according to the following schedule:

f. Forfeited accounts

Forfeitures, if any, are applied to reduce administrative expenses of the Plan or may be used to reduce future employer contribution. For the year ended December 31, 2024, employer contributions were reduced by \$1 from forfeited nonvested accounts.

g. Investment options

Participants can direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and collective trust funds as investment options for the existing participants. In addition, the Plan offers self-directed-brokerage accounts that allow participants access to other investments outside of the Plan to trade securities, such as mutual funds, exchange traded funds, and stocks. Participants may change their investment options and allocations on a quarterly basis.

h. Notes receivable from participants

Participants may borrow from their accounts. Each participant may have no more than one loan outstanding at any one time. Loan fees and interest due are paid by the participants. Minimum loan amount is \$1,000, the maximum loan amount cannot exceed the lesser of (a) 50% of the vested account balance of the participants; or (b) \$50,000 (reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is executed, over the outstanding balance of loans from the Plan on the date the loan is executed).

The maximum repayment period is generally not more than 5 years for a general-purpose loan. If the loan is obtained for the purpose of purchasing a primary residence, the loan will be repaid within a period not to exceed 30 years. The loan will bear interest at the prime rate plus 1%. Principal and interest is paid ratably through each pay period. All loans must be secured by not more than 50% of the participant's vested account balance.

i. Payment of benefits

Upon separation from employment due to termination of employment, death, disability, or retirement, the participant may receive their entire vested portion in a lump sum. A participant generally has two options concerning the account balance when a distribution is made:

- The participant may elect to roll-over the vested account balance to another qualified retirement plan or to an individual retirement account; or
- The participant may elect to have the vested account balance paid directly to him and income taxes will be withheld accordingly.

If the value of the vested account is less than \$5,000 when the participant terminates his/her employment with the Company, the participant will receive a distribution of the entire vested portion of the account balance and the non-vested portion will be forfeited.

The Plan allows for hardship or in-service withdrawals but is subject to the approval of the Plan administrator.

**Note 2 – Summary of Significant Accounting Policies**

a. Basis of presentation

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

b. Use of estimates

The preparation of the financial statements in conformity with U.S. generally accepted principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could materially differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

d. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions based upon the basis of the terms of the plan document.

e. Risks and uncertainties

The Plan provides various funds that hold investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

f. Participant distributions

Benefits paid to participants are recorded when paid.

g. Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

h. Date of management's review

The Plan has evaluated subsequent events through September 20, 2025, the date at which the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual fund:** Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trusts ("CCTs"):** Valued at the respective net asset values ("NAV") as reported by such trusts/funds, which are reported at fair value. The value of each unit is determined by subtracting total liabilities from the total value of the assets, including accrued income, and dividing the amount remaining by the number of units outstanding on the valuation date. There are no restrictions as to the redemption of these investments, nor does the Plan have any contractual obligations to further invest in any of these CCTs.

**Self-directed brokerage accounts:** Accounts primarily consist of common stocks that are valued at the closing price reported on the active market on which the individual securities are traded.

**Note 7 – Plan Termination**

At the date of the report, the Company has no intention to terminate the Plan but it reserves the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.

**Note 8 – Income Tax Status**

The IRS has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code. Although the Plan was amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
